I am a resident of Concord and In November I participated in an action protecting our unhoused neighbors in Manchester who were residing on public property from an illegitimate and unethical eviction. After five days, the cops forcibly removed the encampment; many people lost all of their possessions and were left with nowhere to go. The cops were violent towards residents of the encampment and protestors, including myself. I witnessed officers beating a minor in the street, kneeling on their chest so they couldn't breathe. I saw them gleefully shredding tents (the only shelter that many unhoused people have, particularly in these freezing months).

Treating people like criminals for not having access to safe and affordable housing is reprehensible, especially when there are plenty of empty buildings in the state that could be used to provide that for these people. Shelters are not enough, and there are countless reasons why some unhoused people do not feel safe or welcome inside them. Criminalizing and brutalizing them, rather than providing accessible resources is unacceptable.

- 1 Committee Established. There is established a committee to study the response of law enforcement and the criminal justice system to homelessness in New Hampshire.

 - I. The members of the committee shall be as follows:
 - (a) Three members of the house of representatives, appointed by the speaker of the house of representatives.
 - (b) One member of the senate, appointed by the president of the senate.
- 8 II. Members of the committee shall receive mileage at the legislative rate when attending to the duties of the committee.
 - 3 Duties. The committee shall study how law enforcement and the criminal justice system respond to homelessness in New Hampshire..
 - 4 Chairperson; Quorum. The members of the study committee shall elect a chairperson from among the members. The first meeting of the committee shall be called by the first-named house member. The first meeting of the committee shall be held within 45 days of the effective date of this section. Three members of the committee shall constitute a quorum.
 - 5 Report. The committee shall report its findings and any recommendations for proposed legislation to the speaker of the house of representatives, the president of the senate, the house clerk, the senate clerk, the governor, and the state library on or before November 1, 2021.
