McLeon: anyone can use, an insurance company may or may not accept these payments as deductable on their policy.

Greg Moore, AFP:

increased access to extended services, ie: labs, x-rays. Currently the law requires them to have a facility license and accept Medicare and Medicaid. No DPC hospitals would be established with this business model.

Rep Marsh: Why is it not a viable business model for hospital. Would future legislative changes make that posible.

Moore: Currently a licensed facility would have to take insurance. Would welcome future legislation to remedy. Rep Kofalt: Address possible cost savings

Moore: A small army of staff to handle insurance and 3rd party payers would be reduced from overhead. currently no medical provider is allowed to offer a rate lower than the Medicaid price.

HB 290 – Relative to Policies Required for Health Facilities and Special Health Care Service Licenses

Testimony

Good morning, Mr. Chairman, and members of the committee. My name is Paula Minnehan, Senior VP, State Government Relations with the New Hampshire Hospital Association (NHHA), representing all 26 of the state's community hospitals as well as all specialty hospitals.

The NHHA is opposed to HB 290. We have concerns that this bill could impede access to services if a healthcare facility is not required to have a charity care policy in place. We also have questions about the intent of the legislation and what the sponsor is attempting to address. The statute being amended by this bill is specific to health facilities licensed under RSA 151:2, I (a) or (d) and every person holding a special health care service license under RSA 151:2-e. These include hospitals and facilities such as ambulatory surgical centers, hospice facilities, urgent care centers, and/or birthing center. In addition, a special health care license (RSA 151:2-e) refers to Cardiac Catherization Laboratory Services, Open Heart Surgery/Coronary Artery Bypass Graft Surgery and Megavoltage Radiation Therapy.

The bill, as we read it, would allow for these types of facilities, if they exclusively provide services to persons who make direct payment for services, to not have a charity care policy. All hospitals that fall under this statute, provide care to all patients, regardless of their ability to pay. We do not believe it is in the best interest of the patients seeking care in these facilities to not be assured that the facility maintains a charity care policy. I am also not aware of a licensed health care facility that only accepts payment directly from a patient. That would mean that the facility would not accept any form of insurance including Medicare, Medicaid or third-party group health insurance.

NHHA does not believe this bill is necessary and we ask that you find this bill inexpedient to legislate. Thank you for the opportunity to provide our comments. I am happy to answer any questions the committee may have.

In the Year of Our Lord Two Thousand Twenty One

AN ACT relative to policies required for health facilities and special health care service licenses.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 Health Care Facilities and Special Health Care Service Licenses. Amend RSA 151:2-f, I to

- I. Adopt and enforce a written policy to assure that the facility provides its services to all persons who require the services the facility provides regardless of the source of payment for the services provided to any person, unless the facility exclusively provides services to persons who make direct payment for services. For purposes of this paragraph, a direct payment is one that is paid directly by the patient and is not reimbursed or otherwise paid by a third party.
 - 2 Effective Date. This act shall take effect January 1, 2022.
