This bill's requirements would make rabies vaccination far more expensive than it is now and has the potential to reduce rabies vaccination compliance due to cost. It would cost veterinarians to set up to do this, requiring everything from a digital camera, a color or picture printer, inks, space and time to do the pictures etc. These costs would all be passed on to the consumer.

In addition, low income and seniors and many others who make use of rabies clinics to get their pets vaccinated would be impacted due to increased costs and the need to support color printing rather than a simple rabies certificate.

Then there is the fact this would be ineffective to identify any specific animal as so many dogs, cats, and ferrets look alike due to breed and coloration and so many more change over time.

In many coated breeds grooming and age can make a huge difference in looks. In many breeds and even mixes there are multiple individuals that look much the same (that being the whole point of purebreds that they be very similar). If any of you have ever watched a dog show breed competition ring you might have wondered how the judge told the dogs apart.

Here is an image of the same dog several months apart – about the age for first rabies vaccine and about the age for second vaccine. Not many would know this was the same dog.

Here is an image of the same two cats some months apart. The orange one stayed mostly the same. The light colored one is also the dark colored one in the second picture. He happens to carry the Siamese gene, though he was a barn cat of unknown background, which caused him to darken as he aged. How many would guess this is the same cat?

The color pictures requested in HB322 would be a costly and impractical addition to the rabies certificates. Please vote to ITL this bill.

Dear Committee Members,

We represent Banfield Pet Hospitals and Veterinary Clinics of America (VCA), with about a dozen clinics throughout New Hampshire, as well as Zoetis and others in the animal health profession. We thank the committee for the opportunity to comment on HB387 and HB322.

Regarding HB387, while we appreciate the focus on controlling rabies, we feel the requirement that every owner have a rabies antibody test on their dog 30 days post initial vaccination is an unnecessary cost for owners.

Rabies vaccinations have proven to be effective for decades. No state in the country requires antibody tests to be performed post vaccination. They are expensive for a lot of owners, and again, just unnecessary. In general, we encourage pet ownership and do not want to see undue burdens that could result in current owners abandoning their pets or prevent prospective owners from adopting new pets. As such, we are opposed to HB387.

We have less of a concern about HB322, but it would increase the costs on clinics and photos are not a reliable way to identify animals. From a personal perspective, I have two black Labradors. No one other than me could tell them apart in a photo and even I would need a good photo. The inclusion of a photo is going to have little benefit and the costs on the clinic include color printers, toner, a camera or smartphone (or asking staff to use personal smartphones), along with the additional time to take photos, upload them, and incorporate them into vaccination certificates. To use a common adage, the juice is not worth the squeeze.

Microchipping is the best way to identify our pets and help them get back to their families. While we don't want to recommend additional costs on the pet community, we do encourage microchipping and would note that a lot of states are considering requiring microchipping, in general, or at least for animals adopted out of rescues and shelters. Pet owners would be better off spending money on microchipping than antibody tests and then we would have a reliable way to identify our pets, which may end up helping them be reunited with their family, to which I can personally attest to, as well.

Good morning, Environment and Agriculture Committee -

I have a Board of Veterinary Medicine meeting today and will not be able to attend your hearings, but the department wants to share some thoughts about HB 585, allowing the prepayment of dog licensing fees for the duration of a rabies vaccination and reducing fines related thereto, and HB 322, requiring a color photo of a dog, cat, or ferret on a rabies vaccination certificate.

- <u>HB 322</u> The department has nothing to do with rabies certificate management, so this would not have any direct effect on us. The department applauds the concept of expanding the use of electronic records to document animal health, where possible, but there appear to be a few substantial questions about how this proposal would be implemented...
 - Only town clerks would know, but presumably most rabies certificates (tens to hundreds of thousands) are currently in hard copy (in fact, LSR language still says "in triplicate"). Would a printed color photo needs to be attached to each copy?
 - Would there be legal standards for the photograph for example, head only; frontal photo; full body; both sides; all of the above? Would the photo be taken and submitted to the Town Clerk by the veterinarian or the owner? Currently, statute requires the veterinarian to submit the rabies vaccination certificate.
- **HB 585**. The department has identified some potential unintended and catastrophic consequences for the state's Animal Population Control Program (spay-neuter program) established in statute, RSA 437-A.
 - The bill explicitly retains funding for the New Hampshire Veterinary Diagnostic Laboratory at the current level per licensed year. This is important and appreciated.
 - RSA 466:4 is the section of current statute that requires funding of the state Animal Population Control Program (APCP). The bill does not mention the APCP nor does it modify the sections of statute where APCP is referenced.
 - The bill appears to keep APCP funding at \$2 per license rather than \$2 per licensed year. This
 would result in a large reduction in the APCP budget. In the worst case, it would result in funding
 the APCP only every third year when all licenses renewed. The APCP could be at risk of folding
 from lack of consistent, predictable funding.
 - APCP has an average annual budget of approximately \$400,000, funded by license fees; there
 has been one occasional private donor in the past several years.
 - If the APCP funding and operation were to suffer, it should be assumed that this would result in public health and safety concerns, as well as increased local animal control costs. Specifically, the International City/County Management Association (ICMA) conducted research to document the cost savings to and impacts on local government attributable to the APCP. The savings estimated by that research have surely increased since research was completed, because the cost of services has increased while the cost of dog licensing has remained level. The ICMA research showed that for each \$1 spent by NH APCP, locals save \$3.23 in attendant

- expenses (animal control, impounding, bites, etc.); http://www.spayusa.org/main_directory/03-programs and clinics/statewide publicly funded/study three state programs.pdf; pg 29-30.
- APCP receives in excess of 5000 requests for applications from pet owners annually; approximately 3000 APCP surgeries are performed annually by participating veterinarians.
 Assume research is accurate in identifying that low income owners, such as those that use APCP, will not spay/neuter their pet without such program assistance.

Mr Chairman and Members of the House Environment and Agriculture Committee,

I am writing you today in opposition to HB 322 – requiring a color photo of a dog, cat or ferret on a rabies vaccination certificate.

This bill's requirements would make rabies vaccination far more expensive than it is now and has the potential to reduce rabies vaccination compliance due to cost. It would cost veterinarians to set up to do this, requiring everything from a digital camera, a color or picture printer, inks, space and time to do the pictures etc. These costs would all be passed on to the consumer.

In addition, low income and seniors and many others who make use of rabies clinics to get their pets vaccinated would be impacted due to increased costs and the need to support color printing rather than a simple rabies certificate.

Then there is the fact this would be ineffective to identify any specific animal as so many dogs, cats, and ferrets look alike due to breed and coloration and so many more change over time.

In many coated breeds grooming and age can make a huge difference in looks. In many breeds and even mixes there are multiple individuals that look much the same (that being the whole point of purebreds that they be very similar). If any of you have ever watched a dog show breed competition ring you might have wondered how the judge told the dogs apart.

Here is an image of the same dog several months apart – about the age for first rabies vaccine and about the age for second vaccine. Not many would know this was the same dog.



Here is an image of the same two cats some months apart. The orange one stayed mostly the same. The light colored one is also the dark colored one in the second picture. He happens to carry the Siamese gene, though he was a barn cat of unknown background, which caused him to darken as he aged. How many would guess this is the same cat?



The color pictures requested in HB322 would be a costly and impractical addition to the rabies certificates. Please vote to ITL this bill.

ANALYSIS

This bill requires a color photo of a dog, cat, or ferret to be attached to its rabies vaccination certificate.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty One

AN ACT requiring a color photo of a dog, cat, or ferret on a rabies vaccination certificate.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 Rabies Vaccination Certificate; Color Photo Added. Amend RSA 436:102 to read as follows:

436:102 Duties of Veterinarian. It shall be the duty of each veterinarian, at the time of vaccinating any dog, cat, or ferret, to complete a certificate of rabies vaccination in triplicate which includes the following information: owner's name and address, description of dog, cat, or ferret (breed, sex, markings, age, name), a color photograph of the dog, cat, or ferret, date of vaccination, rabies vaccination tag number, type of rabies vaccine administered, manufacturer's serial number of vaccine, and the expiration date of the vaccination. Distribution of copies of the certificate shall be: the original to the owner, one copy retained by the issuing veterinarian and, within 40 days of the vaccination, one copy to the town or city clerk where the dog, cat, or ferret is kept. The veterinarian and the owner shall retain their copies for the interval between vaccinations specified in RSA 436:100. A metal or durable plastic tag, serially numbered, shall be securely attached to the collar or harness of the dog. Whenever the dog is out-of-doors, off the owner's premises, and not under the control of the owner or handler while working the dog, the collar or harness with the vaccination tag shall be worn. For the purposes of this section, "working the dog"

or participating in any lawful competitive event, including, but not limited to, conformation shows or

obedience trials, field trials, agility events, hunts, sled races, or training activities pertinent to

means a dog doing a defined functional canine activity with its owner or handler such as hunting,

field work, drafting, and guarding, working, or herding livestock, as defined in RSA 21:34-a, II(a)(4),

functional canine activities. Cats and ferrets shall not be required to wear the collar or harness with

the tag.
