AN ACT relative to sports book locations.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Sports Book Retail Operations. Amend RSA 287-I:5 to read as follows:

2 287-I:5 Sports Book Retail Operations. The commission and its agents are further authorized to 3 operate physical sports book retail locations within the state for the purposes of accepting tier I, *tier* 4 *II*, and tier III sports wagers from authorized bettors and paying prizes relating to those wagers. 5 The sports book retail locations may be co-located with other commercial businesses or general 6 commercial retail locations. [No more than 10 sports book retail locations may be in operation at 7 any given time.]

8 2 Effective Date. This act shall take effect 60 days after its passage.
