AN ACT relative to the local option for sports betting.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 1 Sports Betting; Local Option. Amend RSA 287-I:6, I(c) to read as follows: 2 (c) The wording of the question shall be substantially as follows: "Shall [we] the 3 city/town of [fill in town/city name] allow the operation of sports book retail locations within [the 4 town or city] [fill in city/town]?" 5
 - 2 Effective Date. This act shall take effect July 1, 2021.
