You asked:

When were political committees first required to provide the name and address of a contributors of more than \$25 contribution?

What was the disposition of 2019 legislation that increased this threshold to \$100?

SUMMARY

From at least the recodification of the NH election laws in 1979 until 1982, political committees with *expenditures* equal or exceeding \$500 were required to submit an itemized statement of *all receipts*. The statement was required to include the full name and post office address of each contributor and the amount and date of the contribution. For receipts over \$100, the statement was required to include the occupation and principal place of business of the contributor.

In 1982, RSA 664:6, I was amended to apply to political committees with either *receipts* or expenditures over \$500 and to permit receipts of \$25 or less to be unitemized. The itemized reporting requirements have applied to receipts over \$25 since that time. Numerous additional changes have been made to the language of this section, but the dollar amounts have not changed since 1982 (Ch. 27, Laws of 1982).

HB 391 (2021) would increase the threshold for providing detailed information about each contributor from \$25 to \$100. HB 152 (2019) proposed the identical revision to the campaign finance law. The 2019 bill was killed in the House.

Support

• This is a straightforward bill to increase the threshold for itemizing contributions.

 People want to support candidates financially but contribute less than \$25 to avoid being identified; some business are targeted negatively because of their contributions.

Opposition

• Greater transparency in campaign finance laws is needed, not less transparency.

• This change would dramatically influence the amount of dark money flowing into political campaigns; changing the threshold from \$25 to \$100 for identifying a contributor would magnify the problem of multiple LLCs being registered at one address contributing to candidates without identification.

Committee Report: Majority: Inexpedient to Legislate, vote 12-7, Regular Calendar

Minority:

Rep. Paul Bergeron for the Majority of Election Law. This bill would increase the threshold requirement for reporting itemized receipts on political contribution statements from \$25 to \$100. Currently, RSA 664:6 requires that political committee and candidate campaign contribution reports include the full name, postal address, amount of contribution, and date of contribution for donors of more than \$25. Contributions of \$25 or less are aggregated as "unitemized receipts." This bill would permit political committees and candidates to aggregate contributions of \$100 or less as "unitemized receipts." The majority of the committee believes that NH citizens have the right to know who is funding their elections. Full disclosure allows voters to make better informed choices and strengthen the public's trust in the integrity of our elections. Increasing the

amount of contributions that could be "unitemized" would diminish the level of campaign financing transparency that currently exists in state law.

Rep. Timothy Lang for the Minority of Election Law. This bill is a modernization bill that would update the required reporting of information about campaign contributors from those who give \$25 to those who give \$100. The last time this portion of the statute was addressed was 35 years ago in 1984, when the \$25 amount was set. The committee agreed that at \$99 no one was buying influence but just participating in the pre-election campaign process. The reason for this bill is the divisive nature of politics at this point in time. Citizens want to participate in our elections, however some fear that being listed on a campaign finance report will create animosity between friends or neighbors, and they are just not willing to be listed, thus silencing those NH citizens' voices. These citizens are not buying influence, but merely trying to support candidates of the same political leanings or a friend or neighbor running for office. The goal of election campaign finance laws is to shine a spotlight on who is paying for a given election race, so the public knows who a candidate may be beholden to based on those donations. This legislation supports the recently passed NH Constitutional amendment where a strong majority of NH citizens voted to formalize the right from undue intrusion into the privacy of our citizens. No one is beholden to anyone for \$99. This is common sense modernization legislation.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 Reporting by Political Committee. Amend RSA 664:6, I to read as follows:

I. Any political committee whose receipts or expenditures exceed \$500 shall file with the secretary of state an itemized statement in the form prescribed by the secretary of state, signed by its chairman and treasurer showing each of its receipts exceeding [\$25] \$100 with the full name and postal address of the contributor in alphabetical order and the amount of the contribution, the date it was received, and the aggregate total for each election for each contributor of over \$100. Statements shall be filed not later than the first Wednesday in June and December after the state general election and before the filing deadline established in RSA 655:14, after which statements shall be filed no later than the Wednesday 12 weeks immediately preceding a primary election, before 5 o'clock in the afternoon, and shall cover the period from the day of the committee registration up to and including the Monday before the statement is due. All receipts of [\$25] \$100 or under shall appear on the statements as unitemized receipts. Any listing that exceeds an individual's aggregate total of \$100 for each election shall be accompanied by the contributor's occupation including official job title, the name of the contributor's employer, and the city or town of the contributor's principal place of business, if any. The statement shall also show each committee expenditure exceeding [\$25] \$100 with the full name and postal address of the payee or promise of payment, the date paid or obligated, and the election for which the expenditure was made, with the specific nature and amount of each expenditure since the date of the registration.

2 Effective Date. This act shall take effect 60 days after its passage.
