Honorable Committee Members:

I am writing on behalf of the NH Water Pollution Control Association (NHWPCA) and our 300+ members who represent all of the wastewater treatment plants throughout the State.

Based on our careful reading of this bill, we are in support of HB 397. The bill will reinstate the exemption in permitting fees associated with the Shoreland Protection Act for municipal, county, state, federal or nonprofit organizations that was not renewed in the previous session. New Hampshire municipalities, public water and wastewater utilities and ratepayers, and ultimately all tax payers will benefit from this bill.

The Wastewater Treatment Plants, the Water Treatment Plants, and portions of their collection and distribution systems are located within the protection zone that is regulated under the Shoreland Protection Act. The government entities must comply with and obtain a permit under the Shoreland Protection Act when they try to make improvements. This bill does not ease any permit requirements, it just makes the entities exempt from the permitting fees.

The NHWPCA and its members are committed stewards of the environment. We will continue to comply with the permit requirements as outlined in the permit. We respectfully request that *this bill be passed* to ease the financial burden that the permit fees can impose on these governmental entities.

Dear Chairman Renzullo and Members of the Committee:

Thank you for the opportunity to comment on HB 397. This bill proposes to exempt municipal, county, state, or federal entities as well as legally recognized non-profit organizations from the application filing fees required when applying for permits required under the Shoreland Water Quality Protection Act, RSA 483-B. The New Hampshire Department of Environmental Services (NHDES) does not support this bill.

The Shoreland Program at NHDES handles over 600 applications, 600 Permit by Notifications, and 80 compliance investigations per year. Processing these applications and associated field work requires significant staff time and effort with the goal to balance development with the protection of water quality in our lakes, rivers, and tidal waters. Applications from government entities and non-profit organizations require no less effort than those for private development. They still consume significant program resources and, therefore, should not be exempt from supporting this fee-for-service program.

Our mission is to serve the roughly 2,500 regulated public water supply systems in New Hampshire that provide clean, safe and affordable drinking water to approximately 550,000 residents. Many of these systems are owned and operated by governmental entities, such as municipalities, districts and precincts. We support HB397 as proposed for the following reasons:

- Excessive fees can be a financial burden on the applicant, with funds better spent on project implementation.
- A permit application fee exemption was in place from 2008 through 2018. The proposed bill restores that established and effective part of the shoreland permitting program.

We recognize that there are costs to the NH Department of Environmental Services related to permit application review and approval and are in favor of exploring alternate means to support their important and critical work.
