### HB407 ITL

Rep. Nick White for the Majority of Science, Technology and Energy This bill is substantially equivalent to HB1262, which was rejected last session to allow for needed revisions. ### HB 289

Rep. Michael Harrington for Science, Technology and Energy

This bill expands the definition of an Energy Facility to include energy storage facilities. This allows the Site Evaluation Committee (SEC) with its additional expertise and resources to 1) Have primary jurisdiction on siting of energy storage facilities with a peak storage capacity of 30 megawatt-hours or greater; and 2) Allow municipalities to petition the SEC to take jurisdiction over smaller-sized storage facilities.

### HB309

Rep. Michael Harrington for Science, Technology and Energy

This bill would change the capacity factor assigned to class II (solar) facilities from 20% to a capacity factor rating equal to the annual PV Energy Forecast issued by the Distributed Generation Working Group under ISO New England. The capacity factor determined by ISO-NE provides a more accurate number based on actual field measurements.

### HB351 OTP

Rep. Doug Thomas for the Majority of Science, Technology and Energy.

This bill returns the authority for increases in the systems benefit charge (SBC) to the legislature, either by passage of legislation or by approval of the fiscal committee of the General Court. The SBC is one of several state-mandated surcharges added to electricity bills to pay for energy efficiency programs. An example of what can happen without legislative approval is the current 3-year Energy Efficiency Plan under review by the Public Utilities Commission (PUC). The majority does not dispute the value of energy efficiency but feels approval to raise the yearly surcharge from \$62M to nearly \$280M over a three-year span is the duty of the legislative body, which has a fiduciary responsibility to taxpayers, particularly during the current pandemic crisis. The majority believes the legislative body is well-equipped to review and approve any such requests from state agencies where the merits can be discussed and recommended.

### HB 396

Rep. Lee Oxenham for the Minority of Science, Technology, and Energy This bill puts an end to what the Minority considers to be an unconstitutional practice known as "REC sweeping," that authorizes the monopoly electric utilities to seize - without any compensation - the private property of NH businesses and residents. "REC sweeping" allows the monopoly electric utilities to effectively take title to the renewable energy in which others invest and use it to meet their obligations under the Renewable Portfolio Standard (RPS). In the case of a business, this deprives the original investors of their right to market their businesses as powered by renewable energy, or even to claim they use the renewable energy they produce. Any firm doing so is vulnerable to Federal Trade Commission (FTC) enforcement action. The utilities' uncompensated seizure of unregistered renewable energy attributes, i.e. their use of other people's property to meet their RPS obligations, constitutes an unconstitutional "taking." An uncompensated taking of private property without the owner's consent is theft and constitutes a violation of the Takings clauses in both the US and NH Constitutions. No other state permits this. To add insult to injury, this practice has helped "wreck" NH's REC market, diminishing the utilities need to make Alternative Compliance Payments - the only source of funding for the Renewable Energy Fund.

### HB407

Rep. Kat McGhee for the Minority of Science, Technology, and Energy

This bill includes all the requested improvements that caused the prior version of the bill to be retained last session. Specifically, definitions were added to ensure a clear understanding of how limited electric energy producers would participate in electric markets, expressly prohibiting the ability of those who are net metering from qualifying as Limited Electric Energy Producers. HB407 also clarifies that those who participate in the FERC wholesale electric energy market are prohibited from seeking status as a LEEP qualified seller in the state of New Hampshire. The bill adds 'qualified storage facilities' to the required statutes where they are currently lacking necessary references to acknowledge the role of qualified electric storage facilities as load reducers. These changes to the retained bill satisfy every objection to the former bill language and should be given a vote. This bill supports local, renewable energy markets and the aids our recovering economy.

Dear Chairman Vose and Honorable Members of the Committee,

The New Hampshire Timberland Owners Association (NHTOA) appreciates the opportunity to provide testimony in support of the proposed modernization of the Limited Electrical Energy Producer Act (LEEPA). Specifically, the policy objectives sought through House Bills 407, 294, and 167 – updating and streamlining the ability for LEEPA direct power sales.

Because the NHTOA represents New Hampshire wood processors (i.e. sawmills, mulch grinding/blending facilities, etc.) which are large electricity consumers and in some cases have on-site electricity production (i.e. wood boilers, solar, small hydroelectric) we have an interest in LEEPA. The NHTOA is advocating for streamlining the ability to transact direct retail power sales between electricity consumers and small electricity producers as this will provide these wood producers more competitive options for electricity purchases, and in the case of on-site generation provide more options for the sale of excess electricity production.

Although we recognize the proposed policy changes in these three bills may require rulemaking and further clarification the objectives of greater consumer choice and competitive options sought by House Bills 407, 294, and 167 are worthwhile and should be pursued. In particular, House Bill 407 has already begun this process by trying to address some of the objections raised during the 2020 debate on Representative Costable's House Bill 1262.

Again, thank you for allowing us to comment on these proposals and we welcome the opportunity to work with the Committee further on this subject.

To Chairman Michael Vose and the Honorable Members of the New Hampshire House Science, Technology & Energy Committee,

As voters and community leaders, we write to respectfully request that you vote "No" on House Bill 315, relative to aggregation of electric customers (HB 315).

In 2019, Governor Sununu demonstrated his leadership on energy issues when he signed into law an update to RSA 53-E, Relative to Aggregation of Electric Customers by Municipalities and Counties. This "Community Power Law" democratizes energy by enabling cities, towns, and counites to procure and provide electricity and related services on behalf of their residents and businesses. Over the past year, many towns and cities across the state have begun working to leverage Community Power for the benefit of their citizens. Now, before we have even had the chance to launch our initial programs, Community Power comes under threat.

House Bill 315, introduced at the request of Eversource, would gut RSA 53-E and undercut the innovative potential of businesses to offer customers new products and services through Community Power. This bill would strength monopoly control over competitive markets, burden communities with arduous regulations, and altogether sabotage the potential for municipalities to make their own energy supply decisions through Community Power. HB 315 entirely undermines the intent of Governor Sununu's innovative update to RSA 53-E, which was supported by a bipartisan legislature.

The purpose of RSA 53-E is to:

- "provide small customers with similar opportunities to those available to larger customers in obtaining lower electric costs, reliable service, and secure energy suppliers..."
- "to provide such customers access to competitive markets for supplies of electricity and related services..."
- "to encourage voluntary, cost effective and innovative solutions to local needs with careful consideration of local conditions and opportunities."

HB 315 undermines the purpose of RSA 53-E by:

- 1. Eliminating Community Power authority to provide electric power supply and related customer service, load management and energy conservation;
- 2. Restricting energy services available to Community Power to only monopolistic and regulated ones;
- 3. Removing Community Power access to data necessary for program implementation;
- 4. Subjecting Community Power to regulation by the Public Utilities Commission.

Community Power aims to harness competitive markets and economies of scale to help lower energy costs and give communities greater choice. We are excited about the potential benefits that Community Power can bring to our cities and towns. But those benefits will be never be realized if HB 315 is to become law.

Community Power represents a "New Hampshire Way" forward on energy issues, one that chooses markets over mandates; local control over monopoly control; and innovation over regulation. Please do not allow this attack on Community Power to take away our local authorities.

## Please, vote "No" on HB 315.

This bill expands the authority of a limited producer of electrical energy to sell its output to retail electricity customers located within the same New Hampshire electric distribution utility franchise area as the limited producer, and includes qualifying electrical energy storage.

### HB 407 - AS INTRODUCED

### STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty One

AN ACT relative to the purchase of output of limited electrical energy producers in intrastate commerce and including qualifying storage system.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Definition; Limited Electrical Energy Producers; Limited Producer. Amend RSA 362-A:1-a, III 2 to read as follows:

3 III. "Limited producer" or "limited electrical energy producer" means a qualifying small power producer, a qualifying storage system, or a qualifying cogenerator, with a [total] maximum 4  $\mathbf{5}$ rated generating or discharge capacity of [not more] less than 5 megawatts, that does not 6 participate in net energy metering, that is not registered as a generator, asset, or network 7 resource with ISO New England, and does not otherwise participate in any FERC 8 jurisdictional wholesale electricity markets. Such non-participation in FERC 9 jurisdictional intrastate wholesale markets may be achieved by retirement from such 10 markets.

New Paragraph; Definition; Qualifying Storage System. Amend RSA 362-A:1-a by inserting
 after paragraph IX the following new paragraph:

IX-a. "Qualifying storage system" means an electric energy storage system as defined in
 RSA 72:84.

15 3 Limited Electrical Energy Producers Act; Purchase of Output in Intrastate Commerce. RSA
 362-A:2-a is repealed and reenacted to read as follows:

17

362-A:2-a Purchase of Output of Limited Producers in Intrastate Commerce.

I. A limited producer of electrical energy may sell its produced electrical energy to one or more purchasers other than the franchise electric utility. Such purchasers may be any retail electricity customers located within the same New Hampshire electric distribution utility franchise area as where the limited producer is located or any electricity suppliers serving retail load within such area.

II. Intrastate sales of electricity across the distribution grid shall be facilitated and accounted for by competitive electricity suppliers registered with the commission under RSA 374-F:7 or by municipal or county aggregations under RSA 53-E that are load-serving entities.

III. To participate in such intrastate sales of electricity over the distribution grid a limited producer must be equipped with a revenue grade interval meter that can accurately measure hourly exports to the distribution grid and report such meter data for daily load settlement purposes.

IV. The commission shall establish procedures to enable limited producers to sell electricity at wholesale within intrastate commerce and at retail, either directly or indirectly through

electricity suppliers. The commission may establish such requirements and conditions concerning
 intrastate sales of electricity pursuant to this section that it deems necessary to avoid substantial
 risk or uncompensated costs to the electric utility in whose franchise area the sales takes place.

The limited producer, or the purchasers of their output, as determined by the 4 V.  $\mathbf{5}$ commission, shall receive credit for actual avoided transmission charges if the intrastate wholesale or retail sale of such electricity reduces the retail load measured at the wholesale meter point 6 7between the distribution system under state jurisdiction and transmission facilities under federal 8 jurisdiction such that transmission charges allocated to the distribution utility are reduced from 9 what they otherwise would be absent the electricity exported to the distribution grid by the limited 10 producer during hours of coincident peak on which transmission costs are allocated. Such credit 11 shall be based on measurement of exports to the distribution grid at the retail meter point without 12additional credit for avoided line and transformation losses between the wholesale and retail meter 13points to provide some sharing of the benefit of reduced transmission charges with other ratepayers 14who do not participate in such intrastate electricity sales by limited producers.

VI. Purchasers of power from limited producers shall pay for the delivery of such power through tariffs, charges, and rates that are generally applicable to the customer's rate class, except for default energy service charges if not applicable and transmission charges as they may be adjusted pursuant to paragraph V.

19 4 New Section; Electric Renewable Portfolio Standard; Exclusion to Amount of Electricity
 20 Supplied. Amend RSA 362-F by inserting after section 3 the following new section:

21 362-F:3-a Exclusions to the Amount of Electricity Supplied. If a provider of electricity has 22 revenue grade meter data on the quantity of exports to the grid from a qualifying storage system as 23 defined in RSA 362-A:1-a to the extent that it is charged from the grid, such amounts may be 24 deducted from the calculation of electricity supplied by the provider to its end-use customers for the 25 applicable year for purposes of compliance with RSA 362-F:3 as determined and provided for by the 26 commission.

5 Utility Property Tax; Exclusion From Definition of Utility Property. Amend RSA 83-F:1, V(d) to read as follows:

29 (d) The electrical generation, production, *storage*, and supply equipment of an "eligible

30 customer-generator" as defined in RSA 362-A:1-a, II-b, and of a "limited producer" as defined in

31 RSA 362-A:1-a, III if selling under RSA 362-A:2-a, for facilities with a rated electricity

32 production capacity of up to and including one megawatt;

33 6 Effective Date. This act shall take effect 60 days after its passage.
