\*Representative Al Baldasaro – Rockingham 5, Londonderry. This bill is for other people and college students voting. I personally don't have a problem with college students voting. My problem is with non-residence voting. If they are voting and reside in NH, they should get in-state tuition. My mentality is to make sure students who want to become residents, and get in-state tuition. The second part of this bill is voter ID. Long ago state made a mistake putting into law, college ID's at polls. College ID's should not be allowed. See further testimony.

**Question: Rep Mooney – Rep Baldasaro,** do you know h ow many other states have similar laws, allow students to vote?

**Answer:** Too many. I know when I sat on Election Law, we had very few who allowed college students to vote.

**Question: Rep Prudhomme-O'Brien** – Does this mean people can come into state, would be allowed to vote right away?

**Answer:** In my opinion, if you are a student at college staying her 60 days, required to get a driver's license, this tightens up law. If students want to vote, need to be paying in-state tuition.

**Deborah Nelson: I'm resident in the town of Hanover, significant college town**. I think that it is unfortunate when we have students paying taxes, rent, contribute to the businesses, serve on hotline suicide, active in community, they should be denied ability to vote. As a former 27 year civichistory teacher. They are not seeking a break in tuition. I think it is critical everyone have access to voting. Thank you for this time, but again resident and voter of Hanover, and complete supporter of access to voting.

**Question: Rep Berry** – Besides the part about a college ID, if a student is contributing as you say they are, why should they be denied like that of all other residents?

**Answer;** I am not speaking to that. My experience with students at Dartmouth is not an issue whether in-state tuition. This is about access to voting, doing our civic duty. Student voting is patriotic.

**Rep Michael Moffett: I represent Loudon and Canterbury.** I think HB 429 is an important measure. If they are bona fide outer staters, they should not vote in NH. I encourage the committee to pass this bill and further discussion on right path.

**Question: Rep Tirosian** – What other states allow college students for tuition, are considered out of state?

Answer: Great question. I did not research this, but should be able to obtain this.

\*Tom Cronin: I am on staff, Director of Government Relations, at the University System of NH I'm opposed to HB-429. See Testimony. This bill would have an impact on the cost to families of higher education. Simply stated 1) the student or his/her family has to physically reside here, and reside 12 consecutive months remain in NH for other than being a student. We would have a \$170 million dollar annual loss to the system. In response to the system, we would have to raise tuition, and in state differential is funded by NH taxpayers.

**Question: Rep Prudhomme-O'Brien** – Out of state children of professors of NH professors, do they receive in state-or out state tuition?

Answer: If they are not residents, but out state, but pay discount on out of state.

Question: Why does the university treating them differently?

Answer: Essentially the legislature created in-state and out of state eligibility.

**Question: Rep Muirhead** – My calculations, 32 states have resident requirements of less than 30 days. How many for in-state tuition?

Answer: I do not know.

\*Emily Winfrey: I reside in Michigan, but a resident of UNH. See Testimony. Question: Rep Prudhomme-O'Brien Do you believe it is easier to vote in NH versus absentee in MI?

**Answer:** It probably would be just as east to get absentee in MI, but I want to reside in NH, therefore, I vote here.

**\*Representative Horrigan: Testimony given.** My son went to school in Maine. This is a ridiculous bill, a bad bill.

\*Hannah Donley: Student at Dartmouth, oppose to 362. When I cast my vote on November 3<sup>rd</sup>, I was proud. If 362 passes, students would not be able to vote. NH is becoming our home where we live, work, care for communities. Please oppose this bill. See further testimony.

**\*Miles Brown**: I'm a college student at UNH. I oppose 362. Governor and SOS Gardner said we had most secure election. You are failing to serve college students by not giving us to have our voices heard.

Testimony of Tom Cronin, Director of Government Relations University System of New Hampshire (USNH)

The University System opposes HB 429 because it will increase the cost of public higher education for New Hampshire students and families.

State law grants the USNH Board of Trustees the authority to set policies and determine eligibility for in-state tuition rates. At its most basic, the current requirement states that to be eligible for in-state tuition a student must 1) physically reside in the state for at least 12 consecutive months, and 2) must reside in New Hampshire for some purpose other than obtaining an education.

This legislation would create a loophole that would allow non-resident students to register to vote and immediately obtain the in-state tuition rate, which represents a nearly 50% reduction in tuition price. Based on a fiscal note prepared for a similar bill in 2019 (SB 268), USNH estimates this would result in a \$170 million annual loss in revenue to the system.

In response, the system would be forced to raise tuition and reduce institutional financial aid offerings, both of which would have the result of increasing the cost of attendance for New Hampshire students. Further, as the in-state tuition differential is funded using state appropriations, this legislation would also result in traditionally outof-state students receiving a tuition subsidy funded by New Hampshire taxpayers.

For these reasons, USNH respectfully requests the House Election Law Committee recommend HB 429 inexpedient to legislate.

Dear Chairman Griffin and Members of the Committee:

Fair Elections Center<sup>1</sup> writes to voice its strong opposition to HB 362, HB 429, HB 531, HB 535, and HB 554, which are currently scheduled for a hearing before the Committee on Monday, March 8, 2021. Since 2012, Fair Elections Center has operated its Campus Vote Project to help students understand and exercise their right to vote. These bills would make it harder for students to participate in democracy, and respectfully request that this letter be entered into the record as written testimony.

These bills would make the following changes:

- **HB 362** explicitly removes college addresses as acceptable for domicile, directly preventing voters from establishing domicile through evidence of residence at an institution of learning.
- **HB 429** would eliminate student ID issued by a New Hampshire university or college as acceptable voter ID, even when it is issued by an institution funded by the state. At the same time, HB 429 would still allow voters to use student IDs issued by a public or private high school, though far fewer eligible New Hampshire voters are high school students.
- HB 531 and HB 535, among other things, would remove voters' ability to sign an affidavit to register and cast a regular ballot if they lack the requisite documentary proofs of qualifications. These provisions would remove a critical failsafe for

student voters, who are less likely to possess the types of documentation that can be used as proof of these qualifications. They would also disenfranchise many other voters who lack such often-expensive documentation. HB 531 also allows voter challengers to target students without allowing challenged voters to affirm their qualifications via affidavit in response to the challenge and vote.

• HB 554 changes the definitions of domicile in New Hampshire in ways that clearly target students. It states that "a person who maintains a domicile address in another state and is eligible to retain that domicile for voting purposes is not eligible to gain domicile in New Hampshire." This bill would sow unnecessary confusion as to whether someone is eligible to vote in New Hampshire, where the person may still be eligible to vote in another state or no longer maintains a lease, deed, or physical presence in their place of domicile, even if the person intends to return. These requirements take aim at students, as many may remain eligible to vote absentee in the states where their families reside. Others have had to return to their families' homes in other states after COVID-19 forced campuses to close, even though they intend to return to New Hampshire.

For half a century, courts have repeatedly invalidated state efforts to exclude student voters from the electorate. In *Newburger v. Peterson*,<sup>2</sup> a federal court struck down New Hampshire's "indefinite intention test" for determining voter residency, on the grounds that it violated students' right to equal protection. Last year, a state court found that SB 3 violated the New Hampshire Constitution. Passed in 2017, SB 3 targeted out-of-state college students by requiring voters to supply documentary evidence of a "verifiable action" that establishes domicile in New Hampshire. Many of these "verifiable actions" are those students often have no reason to undertake such as renting or purchasing a home or enrolling a child in school. House Bills 362, 429, 531, 535 and 554 would continue this shameful tradition.

The Supreme Court of the United States has already recognized that treating college students differently from other community members based solely on student status violates the Twenty-Sixth Amendment.<sup>3</sup> It has also invalidated voting residency requirements that punish people for exercising their constitutional right to interstate travel,<sup>4</sup> because Americans "who elect to become permanent residents" of a new state have "the right to be treated like other citizens of that [s]tate."<sup>5</sup> Even if litigation against these bills were ultimately successful, their enactment would nonetheless do incredible damage to Granite Staters in the interim by preventing thousands of eligible voters from registering and wasting taxpayer money on avoidable litigation.

These bills would not only harm student voters, but other New Hampshire voters as well. COVID-19 has eviscerated the nation's economy, costing millions of workers their livelihoods. As a result, more than 30 million Americans will face homelessness when eviction moratoriums end.<sup>6</sup> HB 554 would cause Granite Staters in this untenable situation to lose their domicile when they lose their lease, deed to their home, or physical presence at an address, even if they intend to remain in the same town or city. Under HB 531, it is unclear how they would be able to vote if they lack documentary proof of domicile because they live in temporary housing where they have no intent or ability to remain long-term; live in an informal housing situation without a lease or other documentation, such as a family member or friend's home; or live in a vehicle.<sup>7</sup> The last thing these residents should have to worry about is losing their right to vote.
