Current restrictions brought to bear during the pandemic are, indeed, an inconvenience (which we all bear to some degree) but are not a method of discrimination in the classic use of the term. It is to these inconveniences which are borne more by some than others that efforts need be direct. Enacted, this bill would allow a “Typhoid Mary” to have unfettered access to restaurants, hotels, malls, football stadiums, etc. Although the bill’s intent is to allay the inconvenience experienced and which might be accomplished in the short term, it would expose not only the inconvenienced but also the general public to grave harm. My name is Hridaya Sivalingam. I am a Hindu and a resident of Ashland NH. I hold a doctorate in counselor education and supervision and am licensed as a Clinical Mental Health Counselor here in NH. I have served for several years on an Internal Review Board (IRB) who's role is was assess research protocol and assure participants were not harmed. I also work full time as a faculty member with a primary focus on Ethical practice. I practice Auryveda, homeopathy and natural and herbal medicine.

There are many reasons that I am in support of non-discrimination for medical choices but for today I would like to focus on 2 points;

- first the importance of approaching medical choice with cultural humility and responsiveness and second
- the need for true informed consent as it relates to medical choice.
- I will close with some reflections on the impact of the current environment on my family and I.

First I'd like to speak to the importance of **cultural humility and responsiveness** as it relates to supporting individuals in making their own medical choices. I stand with my peers who consistently advocate for the importance of self-reflection, awareness of our own viewpoints, and humble recognition that our ways of viewing the world are not shared by all and that is incumbent upon us to be responsive to those with cultural differences even when their voices may be few and even when we may not understand the perspectives they represent.

- In the past year it has become obvious that there is a dominant health ideology that has sought to eliminate all alternative ways of thinking and seeing life, death, health and well-being. Instead of responding to a novel situation with humility and openness to cultural, religious and indigenous approaches to health we have instead entered a realm of centralized, authoritarian health dictates which seek to shame, silence and marginalize all of those who disagree. Instead of responding to a novel situation by honoring the creative potential of our neighbors as fellow souls to come together to express and share their inherent health wisdom- the public health authorities have shut down channels of communication and minority perspectives who have dared to share hope, optimism, and encouragement. **It is not in our true nature to coerce our neighbors; to ignore their inherent health wisdom, nor should we insist that they make specific health choices to engage in society. I ask for your true nature to show up here and take a solid step against the coercion, a humble and responsive step to honor your neighbors with different religious or cultural health traditions.**

Second, I'd like to speak to the importance of **informed consent** as it relates to supporting individuals inherent right to make their own medical choices. From my study of ethics, I can clearly attest to the fact that greatest atrocities we have committed against fellow souls have come

from a failure to provide thorough information and *true* choice. There is a clear connection between our gross negligence and the extent to which coercive elements are factors. The current health mandates that everyone wear medical devices and line up for testing and a vaccine in order to preserve their access to school, work, basic services and healthcare is blatantly coercive. The positive incentives to get vaccinated are similarly harmful and create untenable situations that prohibit true choice. I assert that if the current approach of masking, social distancing and coerced vaccination was presented as even an undergraduate level research experiment it would fail to pass an Internal Review Board assessment for safety because it fails to consider what harm may come from its approach, it does not allow people to freely engage or disengage from its protocols, it pays no attention to the massive collateral harm caused and it offers no path of redress to those who may be harmed by its methods. It is unethical human experimentation.

- On a personal level my own journey through pregnancy with my first son, I was mentored in the importance of informed consent and medical choice. I was fortunate enough to connect with a gifted doula who educated me about how I could and should advocate for true informed consent during the process. She taught me about how Western medical systems worked to separate women from a sense of agency about their own bodies and created fear around childbirth. Hierarchical approaches assert that credentialed authorities are necessary for a woman to successfully birth a child, and that anyone attempting to do so without support is rash and endangering herself and her unborn child. Cultural wisdom traditions and generational midwifery are pushed aside in favor of medicalized authoritarianism and natural birthing discouraged in favor of drugs and surgery. Breast feeding was dismissed as for the degenerate, while pharmaceutically created formula was touted as the only choice for the wise and affluent woman. I learned through my journey of a natural pregnancy and birth process that it is my inherent right to ask questions, to be given **full and complete information AND the choice** to do with that information that which supports my view of health and my body. So I cringe when someone says – what is the big deal? Just put on the mask, take test, get the vaccine. I say “NO”. I get to assess whether a mask is or is not supportive of my health, I get to decide to engage in testing or not, I get to know the benefits, risks, and alternatives of any medical intervention. I get to reflect on what happens if I delay or do nothing and ultimately use my inherent wisdom and soul’s compass to assimilate that information **to make a choice** for myself and my family in a direction that aligns with our natural religious traditions.
- **It is not in our true nature as souls to coerce our neighbors to put something on or in their bodies to access basic goods and services or to be able to do their heart’s work. Instead we should be honoring each other’s own inherent health wisdom and choice.**

Finally, I would like to close by speaking from the heart as a Hindu and as a mother of two young children. Because of our religion and commitment to natural medicine-

- My kids have not been in school in over a year due to early restrictions and then protocols that are harmful to their development.
- We have not entered a retail establishment since the summer when recommendations became mandates and our fellow citizens started becoming threatening in their response to us.

We see around us leadership that favors further lockdowns, further coercion and that seeks to establish masked distancing as normal, and pharmaceutical compliance as the gold star for access to work and basic services. Remember us and your culpability in the choices you make that impact our ability to thrive. We remain hopeful to soon encounter your inevitable shift back to engaging us with humility and kindness.

House Health, Human Services, and Elderly Affairs Committee Representatives,

I heard several times in today's session fears about mask-less individuals coughing or engaging in harmful behavior toward others publicly. Respectfully, healthy individuals are unable to transmit illness of any sort. I would like to remind the committee that most individuals in the state of NH are free from COVID-19 and thus would be unable to transmit anything. Last week I sent in documentation from the FDA stating that face mask manufacturers are unable to lawfully claim that masks prevent the spread of illness. This is because viruses particles are so small that they can easily pass through masks available to everyday people.

Furthermore, there is basic human conduct that can be expected of each of us to isolate when experiencing potential symptoms. This bill does not challenge that or suggest otherwise. Rather, this bill is necessary because it provides additional protection to individuals who feel unwell masking or who are choosing not to take the new experimental COVID vaccines (they are not as of yet approved).

I tried to testify at the Zoom meeting today on HB506, but due to a problem with my computer microphone input settings, I was unable to be heard. But this e-mail will hopefully serve just as well.

Testimony - HB506 3/8/2021 Health, Human Services and Elderly Affairs Committee

Dear Health, Human Services and Elderly Affairs Committee Members,

I am sending you this testimony **in support of HB506** - relative to equal access to places of public accommodation.

This bill adds additional language to the existing statute regarding equal access, RSA 354:A:16, such that no person shall be denied the benefit of rights to equal access to places of public accommodation because they have declined medical treatment, medical tests, or vaccination, or if they refuse to use a medical device.

To be clear, a public accommodation is a place that offers goods and services to the general public such as a restaurant that is open to the public. Federal and state laws protect designated groups from discrimination in places of public accommodations, based on the premise that everyone is entitled to enjoy the goods and services of the public accommodation on an equal basis. There are two types of entities that are classified as public accommodations: government owned/operated entities and privately-owned/operated businesses and services.

Examples of government-owned/operated entities include:

- Courthouses
- Libraries
- Post offices
- Benefit programs (i.e., welfare services)

Examples of privately owned/operated entities include:

- Restaurants, cafeterias, lunchrooms, lunch counters, soda fountains, or other facility principally engaged in selling food for consumption on the premises.
- Hotels, Inns, Motels
- Theaters, motion picture houses, concert halls, sports arenas, stadiums or other place of exhibition or entertainment
- Transportation services, gas stations
- Stores and commercial businesses

Our state government has a public policy to promote equal rights for all citizens. I believe that our citizens rights have been trampled upon with regard to certain mandates regarding COVID. For example, people have been denied entry to stores and restaurants because of not wearing facemasks. This has been a horrible injustice to people who are unable to wear facemasks for a variety of health reasons. They have been denied the ability to shop for food, and purchase essentials at establishments that they frequent. While they might have other places that they can patronize, the truth is that if every place mandates the use facemasks then there is NO WHERE for people who choose not to wear face masks, for whatever reason, to go. People have even been denied entry to open air areas such as parks and beaches.

This policy is wrong and needs to be addressed in our statutes. No one should be denied access to places of public accommodation because of personal decisions made regarding their own health. We should never be denied the ability to access places and services because we decline vaccination, or make any other personal health care choices. Since health decisions are personal, it is wrong to deny people access to public accommodation because of the individual health care choices they make.

Going forward, I am concerned that citizens on our state will be barred from accessing places of public accommodation based on their vaccine status. I am already hearing about airlines that will refuse to sell seats to people who are not vaccinated. Or that we will be denied access if we do not carry some sort of vaccine identification proving that we've had certain vaccinations. We cannot, and should not, allow this to happen, especially here in NH. "Show me your papers", is a scenario we have already seen in history. People went to jail, were fined, and their lives were turned upside down. I pray we do not repeat that awful time. This bill will prevent that from happening.

I ask that you please to pass this bill through this committee with an OTP recommendation.

Good Evening Members of the Committee,

I would like to submit written testimony in support of HB 506, relative to equal access to places of public accommodation.

I have medical conditions that contraindicate wearing a face covering. The mask requirements at some establishments have cut me off entirely from receiving certain goods and services. More importantly, they have prohibited me from receiving medical care.

- I have not been able to go to my doctor's office to get IVs I was receiving prior to the mask requirements.
- I have not been able to receive dental care for myself or my children because I cannot accompany them.
- Last fall, my son broke his glasses. He had to wait weeks, not being able to see, because I needed to find someone else to bring him for a renewed prescription so I could order him replacement glasses.
- This week I'm dealing with my own vision prescription that needs to be renewed so I can order glasses but the eye doctors I've called don't honor medical mask exemptions.

I haven't been able to go to medical appointments or have lab work done to check in on chronic health conditions. Those are just a few examples of restrictions to medical care. There are many other situations and places that I have been discriminated against for my disability.

I have trigeminal neuralgia, aka "the suicide disease" since some of those suffering would rather take their lives than keep living with it. One of the triggers for me is pressure on my forehead, cheeks, chin, and directly behind my ear. I have to choose between wearing a face covering that will undoubtedly inflict excruciating pain or being prohibited from medical facilities and businesses.

I am just one example of an NH citizen who needs a bill like this to be passed. Everyone says the COVID Pandemic has taught us to come together and to be kind. The truth is I have never felt so alienated and inhuman. I have been yelled at, publicly reprimanded, and threatened because of a disability. I always abide by social distancing and go out of my way to utilize curbside pick-ups and other alternatives to not needlessly put others at possible risk but in situations when that isn't a feasible option I should still be allowed to participate in society. It seems there was a real lack of consideration and concern for how these requirements would affect the ability of certain people to provide and care for themselves and their families.

As a resident of the state of NH, I can't begin to express the need to have you all support HB 506.

Having personal knowledge about using properly engineered masks, with specific protection requirements used at my work sites, one of the most important priorities is that the mask must fit to the face with a perfect air tight seal. Without the sealed fit, the mask filter specifications are compromised and it no longer is providing protection.

I have yet to see a NH resident wearing a mask that is fitted to their face correctly, nor wearing a mask that has the filter specifications to prevent an aerosol viral particle that is 0.1 micron in size from passing through the material and since it is not properly sealed to the face, the aerosol viral particle is able to just bypass the mask and enter or leave from the spaces/gaps between the mask and the person's face. Air will move in the path of least resistance.

I have been in areas where hazardous aerosol particles are suspended in the air. Every male entering the area, had to be clean shaven, and had our masks checked for tightness of seal to face before entering. Even our filters had a functioning time limit. At best, we could work for about 2 hours before we would have to leave the hazardous area and replace out filters.

So I am sure glad that this virus wasn't actually dangerous, because the death counts would have been in the millions. There are people driving in their cars wearing masks that are not protecting them. There are people walking alone, outside, wearing a mask that is not protecting them.

I wear a better professional mask if I am just removing a friend's old carpet, even though the aerosol particles are significantly larger than 0.1 micron. I just choose not to breath in whatever gravity has pulled into the old carpet.

My personal observations indicate that people without masks practice space distancing better than the people wearing masks. In my opinion, the non-protecting masks, give people a false sense of security/protection so that they feel safe being within 2-3 feet of people.

The mask mandate clearly mentioned there are people who are exempt from wearing a mask. So if it is safe enough for these particular people to not wear a mask, why can't all the other people have the choice of wearing or not wearing a mask? There are many times, I have been in a store in which there was only one or two other shoppers. We were easily 20 feet or more from each other. And I time my visits inside, I average 4 min. 37 seconds. The CDC stated you should limit your close contact to no more than 10 min. The cashier was behind a plexiglass barrier and it took me 52 seconds to complete my transaction.

Might you also take into consideration, that many people have made it a priority to achieve a higher standard of health. Increasing our immune system to the point where many haven't been sick in decades.

It is very concerning to see so many people living in fear and anger. During these past 10 months, I can not remember ever hearing the simple friendly greeting "Hi how are you?"

Honorable Members of N.H. House Committee on Health, Human Services and Elderly Affairs:

I have come before you today in support of HB 506, a bill that will clarify existing law by ensuring that bodily autonomy is always protected as a civil right in New Hampshire law. RSA 354-A:16 codifies rights protected in the state Constitution (Part 1, Article 2, 4 and 5) and ensures that no place of public accommodation, which is an organization of any kind that is open to the public, may discriminate on account of several protected classes.

Now, I personally believe that specified protected classes should not be needed in a land where everyone is treated equally under the law, but unfortunately, human nature is such that we must be clear that everyone has the right to buy groceries to feed their families even if they look or act a little different. Currently, the law protects equal access to places of public accommodation for all people regardless of age, sex, gender identity, race, creed, color, marital status, physical or mental disability, national origin, or sexual orientation. Arguably, whether or not I wear a facial covering, face shield, take a Covid-19 test, or show proof of vaccination, I am protected under this law and ought to be able to enter a retail store or place of employment without discrimination. My creed, meaning my belief system or faith, or my physical or mental disability, or all three, could certainly account for my protection under the law for access to such places of public accommodation.

To be clear: I have not worn a mask once during the entire State of Emergency for shopping at a store or going about my daily life, and I won't—ever—for various reasons that I choose to keep to myself. I also will not take any vaccine, I will not undergo a Covid-19 test, and I especially won't inject into my body the current experimental biological agent that is incorrectly being called a "vaccine." These positions are among my natural rights as a free person, and the Constitution protects my right to this bodily autonomy, since there is no equivalent that can be offered in exchange. At the same time, I fully expect to face no discrimination for these choices as I am not impacting anyone else by making them, no matter how many times the Media, health bureaucrats, or the executive branch use repetitive propaganda to say that I am.

So far, I have been able to identify businesses that are willing to accommodate me while displaying the face that God gave me—for better or for worse—and the facial expressions that connect me to other human beings and empower natural social interactions. I have certainly faced my share of harassment from both store managers and customers, but I have always held my ground. If asked to leave, I have been compliant, but that has only happened once or twice. I've been chased down and yelled at numerous times, in front of my children. My daughter was accosted in a bookstore by a man four times her age and twice her height. I have heard, through some of the work I've done for ReopenNH as the group's co-founder and chairman, of many other people who have not been so blessed, and I also pity the people who are forced to wear these muzzles or are strong-armed into injecting an experimental medical treatment into their body to keep their jobs. A woman was tased for not wearing a mask sitting on the bleachers outside during a football game. Others have been beaten or shot dead. This culture is not just inhumane, it is not human. It is for that reason that I believe the law ought to be clarified to add the language protecting access to public accommodation for people who have declined a medical treatment, medical test, vaccination, or who refuse to wear a medical device. In the text, the intent is to reference facial coverings as a medical device, but if it's easier for people to understand the new language, perhaps "facial covering" should be used in the text of this bill instead of "medical device." I leave that up to you to determine, but have included language for a potential amendment in my written testimony.

Now, I have thousands of pages of research that prove my assertions that masks are ineffective—there is no statistical difference for those who wear them and those who don't—and that this so-called vaccine is dangerous and not worth the risk, especially when effective treatments such as Ivermectin are readily available and the disease that has plagued us for the past year has a 99.7 percent survival rate. If you are interested in this research, send me an email and I'll be happy to share it with you. You may not be happy when you see how much research there is to go through. These ideas are besides the point that I ought to be able to buy what I need to survive, even if I choose not to go along with what I believe to be a gross miscalculation by our government at best, which they are now trying to cover up to save face, or at worse, a purposeful attack on our liberty to tighten the power grip of the elite.

What concerns me most and significantly calls out the need for this bill is in the age of the Governor's State of Emergency, we have seen government bureaucracy use businesses as a backdoor regulatory arm, using all manner of unlawful threats and fines to urge compliance to pretend "legislation." It started with big business, which set industry "standards" for everyone else, who then followed suit under the weight of the government-big business partnership. But individual rights have been trampled in the process, and all for no demonstrable reason. On the horizon are threats of more rights violations to come in the name of "public health;" as we've seen in other jurisdictions with health passports, even though no proof whatsoever has been shown that the overreach is needed. This is dystopian fiction come to life, and I want to wake up from this nightmare.

In case you believe that government ought not pass laws that limit the rights of businesses to discriminate, I want to remind you of the basic reason that our nation's founders believed governments ought to be formed: "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. —That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed." Thomas Jefferson's words in the Declaration of Independence show that government's very purpose is to protect individuals' rights from the threats against them by other individuals, businesses, and government agencies.

The language in this bill simply states that I have a right to buy essential goods for my family without having to be vaccinated or tested or wear a mask. I have the right to do that already, but this bill clarifies it and codifies it, and yes, creates a special class of protected people who can seek public accommodation without discrimination. Individual rights always trump the rights of businesses or other larger entities, and it is

government's constitutional role to protect individual rights from others who seek to thwart them. Put another way, the rule of law is paramount because it protects the minority from the majority, and such protection is needed for the rights that are being violated in New Hampshire today. I urge you to pass HB 506 into law.
