STATEMENT OF INTENT

This bill changes the term length in Rockingham County from two years to four years for the offices of sheriff, county attorney, county treasurer, register of deeds, and register of probate. The minority argues that this will make Rockingham County the sole county whose office term lengths differ from other counties in the state and may cause confusion as to the correct term lengths and thus should not be permitted. Should this be the case then the different term length for county commissioners in Carroll, Cheshire, Sullivan, Belknap, Rockingham, Merrimack and Coos counties with 4-2-2 terms for the three commissioners which differ from the remaining counties should not have been permitted either. The minority also argues the two year term is a New Hampshire tradition which permits removal of an undesirable office holder via frequent elections. The majority argues that while the two year term does permit eventual removal of marginal office holders, there are other means which can be used to more effectively achieve this. Further the portions of the two year term required to either become proficient in the position or campaign to retain the position reduces the efficiency and productivity of the office holder. The benefit of this change is the overall improvement of the efficiency and productivity of the office holder through the reduction of the time spent campaigning to retain the office held. Dear Chairman Dolan and Members of the Committee:

Thank you for the opportunity to submit my written testimony in support of HB 560. My name is Cathy Stacey and I currently serve as the Register of Deeds for Rockingham County.

Although my position is elected the functions of my position are administrative in nature. I have long believed candidates for this position should be required to possess knowledge of real property interests, knowledge of the significant statutory requirements, possess strong supervisory skills and understand the budget process. As you know the only requirement is to live within the County.

Elected county positions territories encompass vast numbers of towns/cities requiring significant time spent campaigning. We do not draft nor vote on legislation. We administer our offices. Unfortunately, even with the enormous effort placed on meeting and attempting to educate the public about these positions, if you asked many voters about county positions, they have no idea what we do.

The current election cycle scheme results in the official having little over one year to focus on objectives of the office with the remaining time spent balancing office oversight with the necessity to campaign for re-election. It would be beneficial to the citizens to have more consistency in the administration of the office by extending the term from two to four years. This would enable the elected official more time for long-range planning, research and implementation of new processes to keep the respective offices up to date with current trends.

The challenges in 2020 brought to the forefront an increased importance of focusing on the daily functions of this "essential office" to ensure it remained open for real estate activity. I will share that fifty (50%) percent of my staff took advantage of a voluntary ten-week furlough because of their concerns over COVID-19. During that time my office remained open, accessible and responsive to the public. My responsibility was and is to administer my office, keep staff protected from the virus and continue to ensure no disruption in real estate activity. Rockingham County experienced its most active year since 2008. The Registry of Deeds is BIG BUSINESS! In fiscal 2020 I turned over \$47,322,837.00 to the State and \$4,225,288.00 to the County.

To state campaigning or the election during this past year was challenging is an understatement. Whether it's this year or another election cycle the reality is, it is a distraction and I have an important job to do. A job that requires my full attention. It is a distraction not only for the elected official trying to provide the best services possible to the public but it is a far bigger distraction to staff.

Bi-annually staff are expected to remain focused on the task at hand but the reality is they fear the unknown when it comes to elections. The "what if's" can be debilitating. Staff ask questions about Facebook postings, newspaper reports and become quite upset when opponents come to the office to introduce themselves (a practice I find offensive). Staff are the backbone of our offices. We rely on them to ensure daily requirements of the office are met. The stress placed upon them is significant. I believe extending the term will lessen the unease felt by employees and allow elected officials to focus on setting strategic goals and achieving those goals which best serve the public.

The final point I will share is my personal disappointment with election results that historically show that voter participation towards candidates located at the bottom of the ballot wanes. This is an unfortunate reality. County positions appear to be the most obscure but in many ways some of the most important jobs.

In closing, I ask that you support HB 560 as it pertains to Rockingham County Officials and change our positions to a four-year term.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty One

AN ACT relative to the election of Rockingham county officials.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 Rockingham County Officials; Election for 4-year Term. Amend RSA 653:1, V to read as follows:

 V. One sheriff, one county attorney, one county treasurer, one register of deeds, and one register of probate by the voters in each county, except for Rockingham county. Beginning with the election in November 2022, Rockingham county shall elect one sheriff, one county attorney, one register of deeds, and one register of probate for 4-year terms;
 - 2 Effective Date. This act shall take effect 60 days after its passage.
