STATEMENT OF INTENT

This bill prohibits the use of rubber bullets and tear gas (non-deadly force) by law enforcement. The majority of the Criminal Justice Committee believes it to be inexpedient to legislate at this time. In 2020 we saw, all across our country peaceful protests that morphed into riots. Businesses were destroyed, parts of cities were taken over, hundreds of police officers were injured and many were murdered. Removing a non-lethal tool that police have to restore order in chaotic times is ill advised. Advocates for the bill mentioned that police departments such as Nashua are well trained and they did not know of any misuse of the rubber bullets or tear gas. There was no evidence given to the committee of the abuse of these tools in NH.

1 1 New Paragraph; Rubber Bullets and Tear Gas Prohibited. Amend RSA 627:5 by inserting

3 X. The use of rubber bullets or tear gas by any law enforcement officer is prohibited,

4 2 Effective Date. This act shall take effect upon its passage.
