#### STATEMENT OF INTENT

RSA 318:16-b includes ambiguous language regarding administering the flu vaccine to individuals under age 18. The bill clarifies that a pharmacist may provide a vaccine only to individuals 18 years of age or older. Pharmacists currently provide 12 of 14 vaccines on the Centers for Disease Control and Prevention (CDC) recommended adult immunization schedule. This bill enables a pharmacist to administer the remaining two vaccines, allowing patients greater access to all CDC-recommended adult vaccines. Patient utilization of pharmacists for vaccines has grown significantly in the past few years. This bill enables fully trained, educated, licensed advanced pharmacy technicians to administer a vaccine, allowing safe use of cost-effective healthcare personnel to assist pharmacists.

- 3 1 Pharmacist Administration of Vaccines. RSA 318:16-b is repealed and reenacted to read as 4 follows:
  - 318:16-b Pharmacist Administration of Vaccines. A pharmacist, pharmacy intern, or licensed advanced pharmacy technician, under the supervision of an on-site immunizing pharmacist may administer haemophilus influenza, hepatitis A, hepatitis B, hepatitis A and B, human papillomavirus, influenza, meningococcal, pneumococcal, tetanus and diphtheria, varicella, zoster, MMR (measles, mumps, and rubella), and Tdap (tetanus, diphtheria and pertussis) vaccines, which have been approved by the Food and Drug Administration, to individuals 18 years of age or older as ordered by an immunizing pharmacist. A pharmacist, pharmacy intern, or licensed advanced pharmacy technician under the supervision of an on-site immunizing pharmacist may administer a COVID-19 vaccine, if available, provided that all applicable criteria in this section have been met. The pharmacist, pharmacy intern, or licensed advanced pharmacy technician shall:
  - I. Hold a current license to practice as a pharmacist, be registered as a pharmacy intern under RSA 318:15-b in New Hampshire, or be licensed as a licensed advanced pharmacy technician under RSA 318:15-c.
    - II. Possess at least \$1,000,000 of professional liability insurance coverage.
  - III. In order to administer vaccines, have completed training specific to administration of the respective vaccines that includes programs approved by the Accreditation Council for Pharmacy Education (ACPE) or curriculum-based programs from an ACPE-accredited college of pharmacy or state or local health department programs or programs recognized by the board.
    - IV. Provide to the board evidence of compliance with paragraphs I-III.
  - V. Provide notice to the primary care provider, when designated by the patient, of the administration of any vaccine.
  - VI. Record the vaccination in the state vaccine registry with patient consent or when required by state and federal law and maintain a record of the vaccination as required by state and federal law.

A pharmacist, pharmacy intern, or licensed advanced pharmacy technician, under the supervision of an on-site immunizing pharmacist may administer haemophilus influenza, hepatitis A, hepatitis B, hepatitis A and B, human papillomavirus, influenza, meningococcal, pneumococcal, tetanus and diphtheria, varicella, zoster, MMR (measles, mumps, and rubella), and Tdap (tetanus, diphtheria and pertussis) vaccines, which have been approved by the Food and Drug Administration, to individuals 18 years of age or older as ordered by an immunizing pharmacist. A pharmacist, pharmacy intern, or licensed advanced pharmacy technician under the supervision of an on-site immunizing pharmacist may administer a COVID-19 vaccine, if available, provided that all applicable criteria in this section have been met. The pharmacist, pharmacy intern, or licensed advanced pharmacy technician shall:



#### **TESTIMONY**

#### Rep. Merchant - Introduced bill

This would line up with cdc guidelines. Approximately 30% of vaccines are administered by pharmacies. Convenient, no appointment. Pharmacies need more help because of increasing demand. Need an assistant, trained and licensed, when the pharmacist is on site but is temporarily unavailable.

#### Discussion:

does the pharmacist have the training to deal with a situation that happens in their pharmacy? "yes". Many patients do not have pcp. Discussion followed. If there is an adverse effect, they must report it to the fda but not the registry.

Patients could get multiple doses from different sources i.e. Hospitals, md's office, pharmacies, etc. Because they are unaware that it has already been given or the patient cannot remember. The registry would help to solve this problem.

#### Rep. Cushman

Pharmacist can give a large variety of vaccines, many from different sources. Only 8 approved vaccines, but now 2 more with the covid vaccines.

#### Rep. Pearson

Elderly don't remember what they had. Registry would be the best vehicle.

- L. Condon volunteer director of vaccine administration opposed for 3 reasons:
- 1) providers of vaccines must report adverse effects.
- 2) md must keep track of vaccines...not sure about pharmacists.
- 3) influenza vaccine should not be given to children and infants.

#### HB 572

Thank you, Mister Chairmen, members of the Health, Human Services and Elderly Affairs Committee, colleagues, and public members. My name is Rep. Gary Merchant, Sullivan County, District 4, Claremont, Ward 2.

I come before you today to introduce HB 572 and Amendment 2021-0301h.

**Vaccines** – Today, pharmacists administer approximately 34% of adult vaccines in New Hampshire. Patients do not require an appointment with pharmacists who provide walk-in service, and pharmacies offer convenient locations, especially in rural areas.

Pharmacists today administer the following vaccines: Hepatitis A, Hepatitis B, Influenza, MMR (Measles, mumps, and rubella), Meningococcal, Pneumococcal, Varicella, and Zoster. All except two vaccines appear on the CDC recommended Adult Immunization Schedule – Haemophilus and HPV (Human Papillomavirus).

The bill aligns the list of vaccines a pharmacist may administer with all CDC recommended adult vaccines on the immunization schedule. If the CDC adds a vaccine as COVID to the list, the bill allows the vaccine to be added to the list of vaccines a pharmacist may administer.

**Licensed Advanced Pharmacy Technician** – Today, the states of Utah, Nevada, Idaho, Michigan, Washington, and Rhode Island allow trained pharmacy technicians to administer a vaccine when supervised by a licensed, immunizing pharmacist. Recently, the US Department of Health and Human Services issued guidance under the PREPS Act that allows pharmacy technicians throughout the United States to administer child vaccines and COVID 19 vaccines.

In 2019, the State of New Hampshire created a new pharmacy technician category, a Licensed Advanced Pharmacy Technician or LAPT. Requirements for licensure of an LAPT include:

- Passing a national certification exam.
- Working 2,000 hours as a certified technician.
- Completing a board-approved advanced pharmacy technician program.
- Passing a state exam.

The bill allows an appropriately trained LAPT to administer a vaccine approved by a pharmacist and requires a pharmacist to be physically on-site.

**Amendment 2021-0198h** — The bill as written includes all vaccines approved by the CDC. The amendment clarifies that only vaccines on the CDC Adult Immunization Schedule may be provided by a pharmacist.

Dear Chairman Pearson and Members of the Committee:

New Futures appreciates the opportunity to testify on HB 572, relative to pharmacist administration of vaccines and allowing a licensed advanced pharmacy technician to administer vaccines. New Futures is a nonpartisan, nonprofit organization that advocates, educates and collaborates to improve the health and wellness of all New Hampshire residents. In this role, we work extensively with policy makers, health care providers and families to increase access to quality, affordable health care, including access to important vaccines, throughout the Granite State.

HB 572 not only expands on pharmacy staff allowed to administer vaccines, but it expands on the types of vaccines they are able to provide to the public. This bill would expand that capacity to all CDC approved vaccines for adults and the COVID-19 vaccine for children and adults when it is readily available. While New Futures certainly supports increased access to vaccines for all Granite Staters, to do so while not knowing how affordable that access would be is problematic.

While understanding that this testimony is on HB 572, it would be remiss not to mention the intersection of this bill with HB 604 and HB 221. The intent of HB 604 is to increase access to vaccines while reducing costs to the overall health care system. The pharmacies have resisted being involved in the proposed expansion of the state's vaccine program to include adults. However, they are asking you to expand the scope of their vaccine practice. Additionally, having pediatric COVID-19 vaccines administered through the pharmacies could undermine the successful and well-functioning children's vaccine program that has existed for nearly two decades. Additionally, this bill removes the requirement for the pharmacies to notify a patient's primary care physician about vaccines given, relying solely on the pharmacist entering the information into the state's vaccine registry. HB 572 would need HB 221 to be found inexpedient to legislate for it to function in a way that the patient receives continuity in his or her health care.

Until the overall impact of this legislation is known given its intersection with other house bills currently being considered, New Futures takes no position on this bill at this time. Instead, New Futures simply urges the Committee to fully assess the ramifications of HB 572, especially in conjunction with HB 604 and HB 221 before proceeding forward with this bill. This assessment should include any potential impact on the overall cost to the health care system.

Dear Chairman Pearson and HHSEA Committee Members:

I write to you in <u>opposition to HB572</u> relative to pharmacist administration of vaccines and allowing a licensed advanced pharmacy technician to administer vaccines.

I oppose this bill for three reasons:

#### #One:

- Influenza vaccines administered in pharmacies should be limited to those individuals age 18 and older and not simply be given to the "general public".
   "General public" would include infants as young as six months of age. This trivializes the very real vaccine risks and serious reactions by giving flu shots to infants and children in the corner drug store or grocery store pharmacy. Will pharmacists have the equipment and training to be able to tell the difference between cardiac arrest, anaphylaxis, fainting, and act accordingly to save the lives of babies and children who react at the time of vaccination?
   Most pharmacies and grocery stores don't have lifesaving defibrillators like they do in doctors' offices to save the lives of infants and children who have an immediate life-threatening reaction to vaccines.
- This bill undermines the need for a medical home for a child. Pharmacists don't have the necessary medical history of an infant or child or the time to prescreen for contraindications based on a child's personal and family history and unique health needs prior to vaccination. Children today may get as many as 70 doses of vaccines for 16 different diseases. Many vaccines now come in cocktail shots containing up to 5 different vaccines in one shot. It is difficult for parents to remember if the flu shot was one of them. This is why they need a medical home to keep a patient history and schedule vaccines including the flu shot when appropriate.
- Pharmacists don't have enough training about all the vaccines, risks, prescreening, contraindications, emergency interventions for reactions, reporting reactions to <u>Vaccine Adverse Events Reporting System</u>, and advising parents about the statute of limitations and <u>instructions for filing a claim</u> with the <u>National Vaccine Injury Compensation Program</u>.
- The Centers for Disease Control <u>Vaccine Information Statements</u> list many reasons why patients shouldn't be vaccinated, and it is highly unlikely a busy pharmacist has the time to ask about all the reasons not to vaccinate. These are some of the reasons to not vaccinate that are recorded in

federally required vaccine information statements that a pharmacist with only 8.4 hours of training on vaccines is unlikely to catch:

- Will they screen for things like allergic reactions to ingredients in the vaccine and is a pharmacist going to cover all the ingredients in a flu shot?
- Are they going to perform an exam at the pharmacy and take the child's temperature to make sure they don't have a fever or some other illness?
- Are they going to know if the child has a weakened immune system due to disease (such as cancer or HIV/AIDS), medical treatments (such as radiation, immunotherapy, steroids, or chemotherapy), if they have a history of seizures, if they have a parent, brother, or sister with a history of seizures, or if they have a parent, brother, or sister with a history of immune system problems?
- Will they screen if the child has a condition that makes them bruise or bleed easily?
- Will they know if a child has recently had a transfusion or if they have ever had Guillain Barre Syndrome post vaccination?
- Will they know if a child has had a serious or a life-threatening reaction to any other vaccine that might indicate a high risk with a flu shot?
- Vaccines, just like all pharmaceutical products, can cause injury and death in some people. The United States Government has paid out more than <u>\$4 billion dollars</u> to vaccine victims through the <u>National Vaccine Injury Compensation Program</u>. Influenza vaccines have many more VAERS reports and vaccine injury claims than any other vaccine.
- \* Influenza vaccination rates for New Hampshire children are at the high rate of 70% as reported by Beth Daly of DHHS to the Vaccine Association audit committee on August 20, 2020. Clearly there is no problem with access to flu shots for children without allowing pharmacists and pharmacy technicians to be giving influenza vaccination to children in a busy pharmacy.

#### #Two

The vaccines given in a pharmacy should be limited to vaccines for which actual <u>FDA</u> <u>license</u> has been given and for those individuals for whom the CDC has recommended vaccines according to the details in the CDC's ever-changing, recommended adult vaccine schedule. <a href="https://www.cdc.gov/vaccines/schedules/hcp/imz/adult.html">https://www.cdc.gov/vaccines/schedules/hcp/imz/adult.html</a>

A pharmacy is not the place to be giving experimental vaccines like the COVID shots for which there is only FDA Emergency Use Authorization given and not FDA license.

#### **#Three**

\* It cannot be required that the pharmacist, pharmacy intern, or licensed advanced pharmacy technician <a href="mailto:shall">shall</a> "record the vaccination in the state vaccine registry..." Per RSA 141-C:20-f, the immunization registry is a voluntary program.

\* Inclusion in the vaccination registry requires the consent of the pharmacy vaccine customer. Those individuals who receive vaccines in a pharmacy retain the right to decide whether or not to be included in the registry. It cannot be a mandate imposed on the pharmacist or other staff absent the customer's consent.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 Pharmacist Administration of Vaccines. Amend RSA 318:16-b to read as follows:

318:16-b Pharmacist Administration of Vaccines. A pharmacist [eff], pharmacy intern, or licensed advanced pharmacy technician, under the [direct] supervision of an on-site immunizing pharmacist may administer influenza vaccines to the general public and a pharmacist [eff], pharmacy intern, or licensed advanced pharmacy technician may administer [pneumococcal and varicella zoster] vaccines, as approved by an immunizing pharmacist and which have been approved by the Centers for Disease Control (CDC), to individuals 18 years of age or older, provided all of the criteria in this section have been met. A pharmacist [eff], pharmacy intern, or licensed advanced pharmacy technician under the [direct] supervision of an on-site immunizing pharmacist may administer a COVID-19 vaccine, if available, provided that all applicable criteria in this section have been met. [The pharmacist or pharmacy intern administering a COVID-19 vaccine shall notify the patient's primary care physician.] The pharmacist [and], pharmacy intern, or licensed advanced pharmacy technician shall:

- I. Hold a current license to practice as a pharmacist, or be registered as a pharmacy intern under RSA 318:15-b in New Hampshire, or be licensed as a licensed advanced pharmacy technician under RSA 318:15-c.
  - II. Possess at least \$1,000,000 of professional liability insurance coverage.
- III. In order to administer [influenza, pneumococcal, and varicella zoster] vaccines, have completed training specific to [the administering] administration of the respective vaccines that includes programs approved by the Accreditation Council for Pharmacy Education (ACPE) or curriculum-based programs from an ACPE-accredited college of pharmacy or state or local health department programs or programs recognized by the board.
  - IV. Provide to the board evidence of compliance with paragraphs I-III.
- V. Provide notice to the primary care provider, when designated by the patient, of the administration of [the pneumococcal and varicella zoster] vaccines.
- VI. Record the vaccination in the state vaccine registry and maintain a record of administration of [pneumococcal and varicella zoster] vaccinations for each individual as required by state and federal law.
- 2 Repeal. RSA 318:16-d, relative to additional authority for pharmacist administration of vaccines, is repealed.
