Seeing some of the awful COVID haircuts people have given while homebound and avoiding the salon, maybe it should be. As far as we know, not one person has reported the amateurs giving these haircuts to the authorities for doing so without a license. I will admit I personally have given haircuts to my husband over the past year and, despite vigorously defending the licensing and training for barbers, beauticians, cosmetologists & estheticians via our committee work in recent years, I never once stopped to think I was doing anything wrong. I doubt seriously that anyone felt that way in the Granite State. Given the results of my haircuts, I certainly did gain a new appreciation for the training and licensing this profession deserves. Go any further towards offering additional volunteer services to beloved friends and family, and I doubt anyone would consider that to be wrong. One can therefore conclude, with all due respect, that this is a bill seeking a solution to a problem that does not exist.

The bill would eliminate penalties for barbering etc. if done without pay. This got started last March when barber shops were closed as non-essential. This resulted in people getting haircuts from neighbors and led to ridicule that these people were criminals.

The present law makes no exceptions and Rep. McGuire gave examples of everyday activities that were technically illegal (teenage make up parties). She was aware that these laws are not enforced in these situations, she objected to selective enforcement of laws.

Questions were raised concerning opening the door to more serious violations and about charity events. She also said that drug stores have a variety of products legal for use on oneself but a crime to apply to others.

2. Vinnie Baiocchetti, a traveling master barber, spoke in opposition.

He has no objection to immediate family members but does object to untrained people performing these services on others. He said that it's not financial but a matter of health and sanitation to prevent injury. He described those aspects of training that pertain to sanitation and spread of disease.

Question: has he discovered diseases in his work in prison, medical facilities and with the elderly. He said that the procedure stops if such is discovered; they do not treat disease. **Question** concerning religious tonsure.

There were **further questions** concerning liability and whether consent played a role; the role of warning labels on "box coloring" products.

3. Jeanne Chappell, school owner member of the Board of Barbering, Cosmetology and Esthetics, spoke in opposition representing the Board, not herself individually.

No other professions allow exceptions just because the service is done at no charge, for example no one is prosecuted for unclogging a drain.

The objection is based on public health and safety. She said that consent plays a large role in that someone inviting another into their house is not likely to call the police.

There were questions concerning consent of the requester and liability issues.

ANALYSIS

This bill clarifies that a person may provide barbering, cosmetology, or esthetics services without remuneration and not be in violation of regulation of barbering, cosmetology, and esthetics.

HB 606 - AS INTRODUCED

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty One

AN ACT exempting services provided without renumeration from license requirements for barbering, cosmetology, and esthetics.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Barbering, Cosmetology, Esthetics; License Required; Remuneration. Amend RSA 313-A:9, I 2 to read as follows:

I. It shall be a class A misdemeanor for any natural person, and a felony for any other person, to engage *for remuneration* in any practice regulated by this chapter without the appropriate license.

6 2 Effective Date. This act shall take effect 60 days after its passage.
