## Testimony

### **TESTIMONY IN SUPPORT OF HOUSE BILL 75**

## AN ACT RENAMING AND ADJUSTING THE MEMBERSHIP OF THE NEW HAMPSHIRE COMMISSION ON DEAFNESS AND HEARING LOSS

To be heard in the Health, Human Services and Elderly Affairs committee, February 1, 2021

Thank you, Mr. Vice-Chairman and members of the committee.

For the record, I am Mark Pearson, Chairman of this committee and also Chairman of the New Hampshire Commission on Deafness and Hearing Loss.

Nearly two years ago I formed a sub-committee of the Commission to consider various pieces of legislation. This group made recommendations to the whole Commission. It became my task to turn into LSRs those recommendations receiving a favorable response from the Commission.

Two issues are reflected in hb 75.

1. We heard from numbers of people in the deaf/hard of hearing (d/hh) community that the Commissions name spoke of disabilities, not people, and we might want to change the title accordingly. I charged a few of the subcommittee members with taking an informal poll within d/hh circles to see what others think. A few others were charged with providing us a list of what other states call groups similar to our Commission.

The result was a request to change our name to The New Hampshire Commission for the deaf and hard of hearing.

2. Various Commission members related stories of suboptimal d/hh services in nursing homes. I have considerable experience with nursing homes and other long term residential facilities, first, because in my growing up years I never lacked a close relative who lived in one, and, second, because as a clergyman of 46 years standing, I've always had several parishioners in such facilities. And, to top this off, my assignment in our Rockingham County delegation is to be part of the team overseeing our county nursing home.

I believe most nursing home / long term residential facility administrators are proficient and caring. In talking with several of them it became clear that they were also open to learning more in general and about d/hh residents in particular . This is particularly the case in those facilities where they seldom have more than one, if any, d/hh persons in residence.

We looked at various ways of addressing any concerns that arise and administrators' desire to do even better. We concluded that adding representatives from private nursing facilities, county nursing facilities and assisted living facilities to our Commission would bring them in contact with Commission members who are either d/hh themselves or who advocate for them or both. The leaders of these three groups are in agreement.
