Testimony to House Committee/ State-Federal Rations and Veterans Affairs

In Support of HCR5 regarding Human Rights and Democracy in Hungary, Poland and Hong Kong, by Rep. Peter Somssich, District 27, Portsmouth / Jan. 29, 2021

Thank you, Chairman Baldasaro, and committee members, for giving me this opportunity to introduce HCR5.

This House Joint Resolution expresses the support democracy and human rights in Hungary, Poland and Hong Kong, and encourages support for the democratic government of Taiwan.

The bill is intended to express our disapproval of recent authoritarian actions of the governments of Hungary, Poland and Hong Kong. In addition, we wish to express our support for the democratic country of Taiwan, which is a strong contrast to the authoritarian government in the People's Republic of China run by the Chinese Communist Party.

As a Hungarian American I have sadly observed that the governments of Hungary and Poland have been engaged in increasingly authoritarian actions to limit and even eliminate any democratic opposition voices in their respective countries, and to manipulate their judiciary system to be subservient to the governing party. Many of those actions have been condemned by the European Union, in which they are members, as violations of EU membership requirements. This has resulted in serious consideration by the EU of expulsion.

At the same time that the People's Republic of China has increasingly reduced and restricted the democratic rights of the people in Hong Kong, despite an agreement between that government and the government of the United Kingdom, the government of the Taiwan continues to uphold democratic and constitutional rights of its citizens, despite threats from mainland China,

For all these reasons, this resolution provides moral and symbolic support for the democratic rights of people in Hungary, Poland and Hong Kong. It Likewise signals to our US leaders that our country should strengthen and support our connections to the democratic government of Taiwan.
