She described the provisions of her original bill and said that the bill as amended and submitted to the House was a compromise keeping one section of the original bill. That section required Police Training and Standards to include training in areas of de-escalation, ethics and implicit bias. She described the collaborative efforts of Chief Scippa of PTS and the NH Commission on Law Enforcement Accountability, Community and Transparency (which had been set up pursuant to the Governor's EO #11 and #13) in the drafting of this bill.

We write on behalf of the NH Fish and Game Department and the NH Fish and Game Commission in support of SB 114, as amended by the Senate.

The current text of the bill requires training of all law enforcement officers by the Police Standards and Training Council on the important issues of de-escalation, ethics, implicit bias, and cultural diversity. The Conservation Officers of the NH Fish and Game Department will participate in this training along with all other certified law enforcement officers in the State, and we support this training as a valuable addition to the professional development of our officers.

The bill also requires departments to adopt policies and operational direction for officers on these issues, as well as how to handle incidents that may violate RSA 354-B, which is our state law that prohibits discrimination. This department will, through its command staff, develop and implement such policies and procedures for our officers using existing staff, and within existing appropriations.

We therefore urge the committee to report this bill as "Ought to Pass".

The New Hampshire Department of Natural and Cultural Resources (DNCR) is fully committed to maintaining safe and welcoming public spaces and experiences for all visitors. This goes for all visitors to our state reservations (State Parks and State Forests), our State Library, and we apply this same measure of accessibility when working with arts, cultural and historic entities throughout the state.

While we support the intent of this legislation, we cannot support SB 114 as written.

As an operationally self-funded park system, we are dependent upon our visitors having a positive experience. This is a major check on ensuring that we are welcoming. Our staff educate the public, respond to concerns of park patrons and ensure that our parks and public spaces are safe for all to enjoy. We welcome visitors to experience all that we have to offer. The DNCR staff is available to provide first aid when needed and assistance during special events. The thousand plus seasonal employees hired during the year to operate the park system are not certified law enforcement officers and we do not have law enforcement staff on site. Instead, we rely on local police departments to assist when needed. We do have several Forest Rangers who go through NH's Police Academy training. These trained Rangers will receive the additional training all law enforcement in New Hampshire is now required as a result of the New Hampshire Commission on Law Enforcement Accountability, Community, and Transparency (LEACT).

As for establishing a publically accessible database documenting violators, we believe that since we lean on local police services when needed, it is the law professionals who keep record of such violations. We do not have staff trained and able to maintain such a database.

Thank you for having this important conversation. We remain committed to our mission: to protect, preserve, promote and manage the State's natural and cultural resources, supporting New Hampshire's high quality of life and strengthening the experiences of our residents and guests.

My name is Catherine Corkery and I am the chapter director of the NH Chapter of the Sierra Club. I represent over 20,000 members and supporters in the Granite State and appreciate your time and effort to govern in these difficult times. The Chapter is in support of the passage of SB114, as amended by the NH Senate, whose title is currently relative to the enjoyment of publicly-accessible and publicly-funded recreation areas.

Sierra Club's motto is the "Explore, enjoy and protect the Earth." The original bill had two simple parts. One part allowed the state agencies with jurisdiction over public lands and parks to develop a clear, consistent protocol to record and address civil violations of the NH Civil Rights Act. The second part of the bill codified the executive order of Governor Sununu to enrich the curriculum at the police academy to include non-violent skills training as recommended by the Law Enforcement Accountability, Community and Transparency Commission, or (LEACT).

While SB114 was amended by the NH Senate to include only the non-violent skills training modules for the police academy, NH Sierra Club still recommends the passage of SB114.

After the death of George Floyd by the Minneapolis police officers, Governor Sununu called on the LEACT commission to address community relations of the New Hampshire police agencies. The commission and the community input were remarkable. The

- 2. Again, it will codify the Governor Sununu's executive order that requires the Police Training and Standards Council to include the new non-violent training sessions recommended by the LEACT commission.
- 3. The non-violent training, including ethics, racial bias, and de-escalation skills, are critical to maintain peaceful and safe community relations for the policing forces in New Hampshire.

My name is Catherine Corkery and I am the chapter director of the NH Chapter of the Sierra Club. I represent over 20,000 members and supporters in the Granite State and appreciate your time and effort to govern in these difficult times. The Chapter is in support of the passage of SB114, as amended by the NH Senate, whose title is currently relative to the enjoyment of publicly-accessible and publicly-funded recreation areas.

Sierra Club's motto is the "Explore, enjoy and protect the Earth." The original bill had two simple parts. One part allowed the state agencies with jurisdiction over public lands and parks to develop a clear, consistent protocol to record and address civil violations of the NH Civil Rights Act. The second part of the bill codified the executive order of Governor Sununu to enrich the curriculum at the police academy to include non-violent skills training as recommended by the Law Enforcement Accountability, Community and Transparency Commission, or (LEACT).

While SB114 was amended by the NH Senate to include only the non-violent skills training modules for the police academy, NH Sierra Club still recommends the passage of SB114.

After the death of George Floyd by the Minneapolis police officers, Governor Sununu called on the LEACT commission to address community relations of the New Hampshire police agencies. The commission and the community input were remarkable. The resulting final report and action items are good-faith efforts to improve practices and trainings of law enforcement. The chapter applauds the efforts of the commission and everyone who contributed to the report.

The Department of Fish and Game was contacted for a fiscal note worksheet on January 14, 2021, January 15, 2021, January 20, 2021 and January 22, 2021, which they still have not provided as of January 26, 2021.

METHODOLOGY:

This bill requires personnel with police powers of the Departments of Natural and Cultural Resources (DNCR) and Fish and Game to enforce the use and enjoyment of all publicly-accessible and publicly-funded areas of the state by individuals without fear or threat of verbal or physical violence. The DNCR shall establish and maintain a publicly-accessible database documenting violations of this provision charged by DNCR or the attorney general, including the final disposition of such cases. The database shall not contain any personally identifiable information. The bill also requires the officers of the departments to have ethics and diversity training.

The DNCR assumes the Police Standards and Training Council is developing training as required by this bill for the certified officers within the Department as part of their law enforcement certification and such training will be free of charge. The Division of Forests and Lands, Forest Protection Bureau currently maintains investigation information and such information is available pursuant to RSA 91-A (Right to Know Law) but is not available on a publicly-accessible web-based platform. The database also does not track investigations conducted by other agencies. If such a web-based portal was required, it would necessitate a request for proposals with an unknown development cost and ongoing maintenance cost.

It is assumed this bill will be effective July 1, 2021.
