Carol,

I just spoke with Senator Sherman. The following is from him.

In 2019 HB 243, a bill to change the membership of the Pease development authority board of directors, initially increased the number of members on the board. Along with that it increased the quorum. The bill was passed with an amendment that resulted in it not changing the number of members but changing how they were appointed. However, OLS neglected to have the amendment remove the quorum change.

This was not caught until just before the Governor was to sign it. Given that the effective date was not till April 30, 2021 he agreed to sign it with the understanding that the quorum change would be fixed. That fix was included in a Senate omnibus bill in 2020 that was vetoed due to other things in the bill.

SB 21 is intended to finally fix that problem. If the House passes it in early April the intent is to get it to the Governor for his signature before April 30, 2021. My committee report below is based on all this.

ANALYSIS

This bill provides that the change to the quorum for the Pease development authority board of directors made pursuant to HB 243 (2019, 256) shall not take effect on April 30, 2021. The quorum required under current law shall remain unchanged.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty One

AN ACT relative to the Pease development authority board of directors.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 1 Repeal. 2019, 256:2, increasing the quorum required for the Pease development authority 2 board of directors under RSA 12-G:4, III, is repealed.
- 3 2 Effective Date. This act shall take effect upon its passage.
