Senator Bob Giuda: Prime sponsor of the bill. Simple bill. The Island is located between both towns. Endorsed by the Boards of Selectman of both towns. The bill will be voted on by both legislative town bodies.

Rep. Piemonte: Are there any inhabitants on the Island? ANS: Not that I am aware of. Why is it being transferred? ANS: The community wants it.

Rep. Mangipudi: Any maintenance required? ANS: Question can be answered by other.

Rep. Timothy Lang - No inhabitants, large Island, has a gazebo. Access is only from the town of Tilton. Erosion and the Island needs work on it. Northfield agreed to the transfer of the Island. Voters will decide the issue.

Rep. Maggiore: Map has been forwarded to members.

Rep. Greg Hill - The correct procedure is to go through the legislature to change ownership. The only connection to the Island is through Tilton.

Rep. Maggiore: Is this the first time it has been attempted? ANS: Yes, the changing of boundries require a legislative action and has not been done before.

Rep. Mangipudi: It is between two counties? ANS: That is correct.

Rep. Tripp: My question has been answered.

Rep. Treleaven: Is an admission fee changed? ANS: That is correct, there is a change for weddings.

Stephanie Giovannucci - Cost to rent the Island, you get the money back if there is no damage to the Island. The Island and half the bridge belongs to Northfield. The deed said the Island belongs to both Tilton and Northfield. Attorney said the best way is to change the ownership of the Island.

Rep. Mangipudi: What if there is damage, who gets the money? ANS: Tilton gets the deposit. If the damage is above \$50.00, Tilton goes after the money.
