#### She introduced this bill at the request of PillPack (based in Manchester).

PP wanted a waiver from the Board of Pharmacy to continue the practice after the EO expired. The BofP, however, said that it did not have the clear legislative authority to grant this waiver. Thus, this bill was introduced for that purpose. She said there would be testimony stating that the work-from-home program has shown positive trends in employment, employee satisfaction and productivity, and patient safety. She added that passing this bill now would allow ample time for developing administrative rules. She summarized by saying this bill would be good for consumers, employees and business. She said that a clarifying senate amendment had been incorporated.

# Chris Rochon, representing PillPack, starting by describing the company and the type of pharmacy that PillPack was.

He gave examples of non-dispensing activities as data entry and prescription transfers. He said that supervision of these technicians and interns was required and that technology made remote supervision safe and effective. He said that 11 states had adopted this practice even before the pandemic and 34 states were using the practice after the start of the pandemic.

The National Association of Boards of Pharmacy has developed language for the remote work program which this bill reflects. He echoed the advantages of remote work as had been mentioned by Sen. Carson. He added that this bill would enable PP to continue to grow in NH. I write in support of SB 57, scheduled to be heard by ED&A tomorrow morning. I worked closely with stakeholders in drafting and redrafting amendments to the bill.

SB 57 has been introduced to allow the Pharmacy Board rule making authority to draft rules allowing a pharmacy technician to work remotely and be remotely supervised by a pharmacist, which is currently allowed under emergency orders issued by the Governor. In my opinion, the board has authority to create such rules, however, members of the Pharmacy Board believe the law does not provide clear rule making authority, thus a bill has been introduced to create appropriate legislation.

Board rules and the current emergency orders require tasks performed by a registered or certified pharmacy technician be reviewed and approved by a pharmacist. The bill, as written, does not specifically include this requirement for remote work or supervision, thus the committee may wish to amendment the bill to clearly state this requirement. An option would be for the board to provide clarity in rules.

### NH House Executive Departments and Administration Committee Public Hearing on Senate Bill 57 April 15, 2021

#### Statement of Christopher Rochon on behalf of PillPack

Madam Chair and members of the committee:

My name is Chris Rochon and I represent PillPack. PillPack is a full-service pharmacy that offers patients a safe and innovative way to obtain prescriptions using convenient packaging, modern technology, and personalized service. PillPack was founded right here in New Hampshire, by a second generation pharmacist. Today, PillPack is licensed nationwide and is an independently operated subsidiary of Amazon. Our Manchester facility employs more than 500 full-time New Hampshire workers and processes more than 100,000 prescriptions each month for patients across the country.

We are here to provide support for SB 57. This bill would allow pharmacy technicians and interns to continue to perform non-dispensing tasks—such as data entry and prescription transfers—remotely, after the COVID-19 state of emergency ends.

We would like to thank the stakeholders who worked with us to improve this bill, including the New Hampshire Pharmacist Association, and Representative Merchant. The bill before you today includes the Senate amendment, crafted to address stakeholder concerns – ensuring that all quality and patient safety standards continue to be met, and making the language fit better into existing statute. The amendment also changes the effective date to "upon passage," to ensure these practices can continue without interruption when the state of emergency ends.

We would also like to thank Governor Sununu and the Board of Pharmacy for their leadership on this issue last March, when they approved this practice during an emergency meeting and through Emergency Order #13. These emergency actions allowed PillPack to continue to process and deliver critical medications to patients in their homes, while maximizing the number of PillPack employees who could work safely from their own homes.

Let me be clear: pharmacy technicians and interns are—and should be—supervised by licensed pharmacists. Technology makes remote supervision possible, safe, and effective. This is why, even prior to the COVID-19 pandemic, 11 states had allowed pharmacy technicians to perform certain tasks from home under remote pharmacist supervision. This practice has expanded significantly during the pandemic with 34 states, including New Hampshire, currently allowing some form of remote work for pharmacy technicians. As far as we are aware, the expansion of

remote supervision has been safely implemented across the country, as well as in New Hampshire. The National Association of Boards of Pharmacy developed remote work model language for pharmacy technicians, which SB 57 reflects.

Since implementing the remote work program, we have seen positive trends in employee job satisfaction, productivity, and prescription accuracy. All technicians and interns continue to be supervised by licensed pharmacists and have access to their supervisors by email, phone, and secure instant message chat (including video screen share) for support and guidance as needed, consistent with PillPack's existing operations. We have seen a sustained increase in job satisfaction, and our quality data has remained very strong throughout the remote work period. We are continuously monitoring these important metrics to ensure that we are meeting or exceeding our strict patient safety standards.

Our remote work program has also allowed PillPack to hire additional technicians from different parts of the state, many of whom were specifically seeking remote work. PillPack is continuing to grow and we plan to increase our workforce in New Hampshire. SB 57 will provideus, and other pharmacies, the certainty that our remote work program can continue after the state of emergency concludes. This will allow us to continue to grow and hire in New Hampshire, where we process and fulfill orders for customers across the country.

We previously sought a waiver from the New Hampshire Board of Pharmacy to make remote work permanent. That request was denied by the Board, not on substance, but because the Board did not believe it had sufficiently clear statutory authority to grant the waiver. In its denial, the Board recommended that PillPack and other interested parties pursue legislation that would provide the necessary statutory authority.

As a result, we are testifying before you today to ask for your support to allow pharmacy technicians and interns to continue to perform non-dispensing tasks remotely. Codifying this practice would create much-needed business certainty for pharmacies in the state and for our patients across the country. Thank you again for considering this important piece of legislation during these unprecedented times, and I urge you to vote SB 57 "Ought to Pass."

#### STATE OF NEW HAMPSHIRE

#### In the Year of Our Lord Two Thousand Twenty One

AN ACT relative to allowing pharmacy technicians and interns to remotely perform nondispensing tasks.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 New Paragraphs; Definitions. Amend RSA 318:1 by inserting after paragraph XXXIII the 2 following new paragraphs:

3 XXXIV. "Remote processing" means accessing the pharmacy database to perform non-4 dispensing activities other than at a licensed pharmacy. The pharmacy shall establish controls to 5 protect the confidentiality and integrity of patient information, as required by HIPAA, and prevent 6 any patient information from being downloaded, duplicated, or removed from the electronic 7 database.

8 XXXV. "Non-dispensing activities" are activities permitted under that individual's scope of 9 practice that do not require the physical possession of prescription drugs. Non-dispensing activities 10 include, but are not limited to, prescription transfers, drug utilization reviews, product verification 11 tasks, claims adjudications, refill authorizations, entering patient and prescription information into 12 a pharmacy's electronic database, any other task permitted under that individual's scope of practice 13 that does not require the physical possession of prescription drugs, or other activities established by 14 rules of the board adopted pursuant to RSA 541-A.

New Section; Licensed Pharmacists, Certified New Hampshire Pharmacy Technicians,
 Registered New Hampshire Pharmacy Interns; Remote Processing. Amend RSA 318 by inserting
 after section 15-c the following new section:

18 318:15-d Remote Processing.

I. New Hampshire licensed pharmacists, certified New Hampshire pharmacy technicians, or registered New Hampshire pharmacy interns may engage in remote processing, provided that all work requiring pharmacist supervision is supervised by a licensed pharmacist through electronic or other remote means.

II. Notwithstanding the above, the board may allow registered technicians to perform
 remote processing activities after completion of a board-approved training program on remote
 processing.

26 3 Effective Date. This act shall take effect upon its passage.
