STATEMENT OF INTENT

This bill attempts to deal with the state's housing shortage by creating a New Hampshire Housing and Conservation program, allowing developers to conduct third-party inspections pursuant to planning board approval, and prohibiting municipalities from mandating certain types of heating and energy systems. Democrats on the committee offered an amendment removing the prohibition against heating systems, as it was seen as a concession to the propane industry. The bill, however, was a good and necessary step towards addressing the lack of housing in our state. Instead, Republicans on the committee amended it by stripping it of its core, removing the Housing and Conservation program and leaving the sections on inspections and heating systems intact. We now have a bill that favors developers and the fossil fuel industry while ignoring the Granite State's housing crisis. The minority of the committee recommend Inexpedient To Legislation on the bill as amended, and we continue to hope that the legislature will recognize that something must be done to address New Hampshire's lack of affordable housing.

Rep. Laurel Stavis for the **Minority** of Municipal and County Government. This bill attempts to deal with the state's housing shortage by creating a New Hampshire Housing and Conservation program, allowing developers to conduct third-party inspections pursuant to planning board approval, and prohibiting municipalities from mandating certain types of heating and energy systems. Democrats on the committee offered an amendment removing the prohibition against heating systems, as it was seen as a concession to the propane industry. The bill, however, was a good and necessary step towards addressing the lack of housing in our state. Instead, Republicans on the committee amended it by stripping it of its core, removing the Housing and Conservation program and leaving the sections on inspections and heating systems intact. We now have a bill that favors developers and the fossil fuel industry while ignoring the Granite State's housing crisis. The minority of the committee recommend Inexpedient To Legislation on the bill as amended, and we continue to hope that the legislature will recognize that something must be done to address New Hampshire's lack of affordable housing.

Dear Chairman Dolan:

I am writing to express the strong support of New Hampshire Housing for Part II of SB 86, relating to the re-establishment of the Housing and Conservation Planning Program.

The critical shortage in New Hampshire's housing supply is well-documented, as is its impact on our citizens as they seek to find adequate housing in the communities where they want to live and work. Our statewide rental vacancy rate is a critically low 1.8%, far below the 5% that indicates a balanced market. The cost of renting a 2-bedroom apartment has increased 20% in the past 5 years, and renter incomes continue to fall behind. For homebuyers, the median price to purchase an existing home was about \$323,000 in 2020, a 13% increase from the 2019 median, while the new home median purchase price was \$410,000.

There are several factors that limit market performance in meeting demand for new housing, but one that is clearly within the influence of public policy is local planning and land use regulation. Often well-intentioned local policy decisions – frequently driven by the understandable desire to mitigate the impact of growth on a community – have helped to create our current housing challenge. By requiring low-density single-family housing development, imposing limits on building permits, or creating other impediments to lower housing cost alternatives, local regulations compel private developers to produce fewer housing units at higher cost.

These problems have solutions that are within communities' legal authority, but many communities have limited technical capacity to employ them. The Housing and Conservation Planning Program will provide access to those solutions by providing necessary technical assistance to be delivered through a structured process that begins with an assessment of a community's housing needs and ends with adoption of regulatory policies designed to achieve stated goals and objectives. The program is voluntary for communities and requires both a financial and a policy commitment by a participating community. Importantly, as its name implies, the program combines efforts to improve our approach to housing regulation with an equal emphasis on planning for the protection of our state's vital natural resources.



The Housing and Conservation Planning Program was originally conceived 15 years ago by a visionary collaboration among representatives of development, conservation, business, and municipal government. This effort, the "Growth and Development Roundtable," sought to find common ground on issues of land use. Members of the Roundtable immediately identified pervasive large-lot zoning as a threat both to housing affordability and to conservation. Its solution was the Housing and Conservation Planning Program, enacted in 2007 by the Legislature (SB 217).

Shortly after this program was established, however, the nation was plunged into the Great Recession, and the State faced a dire budget deficit. The Housing and Conservation Planning Program was eliminated as a result. Circumstances are different now, and we strongly encourage you to re-establish this program so that it will once again be ready to serve the needs of our communities.

The cost of these reviews can vary greatly between projects and we believe setting the fees and scope ahead of time allows contractors a clearer indication of what the review process will entail. This change would not interfere with the town's authority, but it would allow for more communication between contractors, owners, and municipalities.

As written, Senate Bill 86, Section 1, does the following:

- Requires a planning board to develop a scope for the project inspection in consultation with the applicant.
- Allows the planning board to ask the applicant in lieu of a third-party inspection to provide a signed document certifying that the project was built in accordance with the plans approved by the planning board.

The AGC of NH supports SB 86, Section 1, and requests that the House Municipal and County Government Committee vote in favor.

IN SUPPORT OF SB 86 PART III BEFORE THE HOUSE MUNICIPAL AND COUNTY GOVERNMENT COMMITTEE

Chairman Dolan and distinguished members of the committee, my name is Leslie Anderson and I am president and CEO of the Propane Gas Association of New England, representing over 40 propane businesses in New Hampshire. I have a master's degree in environmental management, I am an attorney, and I have worked as Bureau Director for the Maine Department of Environmental Protection. As an environmentalist, I am troubled by the electrify everything movement that is gaining momentum across many of our states, and as a citizen I am deeply concerned about the lack of energy diversity and energy security inherent in this electricity only scheme. Propane is an EPA alternative clean energy, and the use of propane accelerates decarbonization. Over 2,700 employees work in New Hampshire in our industry supplying clean reliable energy to over 75,000 residential homes. I am speaking to you today in support of Part III of SB 86. SB 86 is an omnibus legislative proposal and Part III of this proposal deals specifically with consumer choice as it pertains to how a consumer decides to heat their home.

Propane is the unsung energy hero of extreme weather events, and if climate change is going to increase the likelihood of these events as many predict, then we need to make sure that New Hampshire has a healthy vibrant propane industry to step in and provide energy security during these emergencies. For the most recent reminder that propane is the portable energy needed during times of crisis, consider COVID – 19. During the pandemic, propane was the primary energy used to heat outdoor testing sites, including critical biomedical sites such as Lonza in Newington NH, where workers were tested prior to entering the facility to conduct COVID research. Lonza is now currently manufacturing the Moderna coronavirus vaccine. Propane was also used for handwashing stations and hot showers for the homeless, as well as a source of outdoor heating for businesses, restaurants, and testing sites throughout the state.

Using propane furthers the fundamental environmental goal to **Reduce, Reuse, and Recycle** as promoted by EPA. Most people do not realize that propane is a beneficial biproduct of natural gas processing. Approximately five percent of natural gas processing produces propane. Indeed, a global surplus of propane exists and is projected to continue for the next decade. If propane is not captured and beneficially used to offset another energy source, it is simply burned off. Rather than wasting the propane that is left over from the natural gas used to produce over 19% of New Hampshire's electricity each year, our state should be good environmental stewards and reuse this propane that is left over. This would be a true win for the environment and a reduction in carbon emissions.

Our industry is concerned about the environment and is actively working to reduce carbon emissions. **The propane industry is reducing millions of tons of carbon emissions each year.** Across the globe, propane is being used to solve the world's greatest health threat, indoor air pollution caused primarily by burning wood for cooking and heating. Over 3.5 million people die annually from cooking with solid fuels. This leads to deforestation at an alarming rate in many developing countries and causes enormous carbon dioxide emissions. Moving one family from wood to propane saves over one ton of CO2 per year. In addition, moving 50 families to propane from wood saves an acre of rainforest land.

New Hampshire consumers deserve the right to choose their own clean energy source and it is for these reasons that I ask you to support the passage of Part III of SB86, and I thank you for your time.

This would put essential personal in harms way including those that need to be on life support, hospitals and police/fire buildings that rely on power.

I am writing in support of Part III of SB 86. Part III of this legislative proposal allows the citizens of New Hampshire to have their choice when comes to heating their home during throughout the year, including the bitter winter temperatures that we sometimes experience in our State.

As other states around the country pass legislation to mandate that their residents use electric heat pumps to heat their homes, they are not taking all the variables into account before making these tough decisions and these policies do not belong in New Hampshire. Electric heat pumps work solely off the power grid. It is important to remember that electricity must be generated for it to be consumed. We always need to look at energy plans/policy from the cradle to the grave. How was the energy generated, how was the energy consumed, and how efficient was this process? The EPA's Energy Star program gives propane a source site ratio of 1.01, compared to 2.52 for the electricity for the New England ISO grid. This means that it takes 2.5 units of electricity to produce and deliver 1 unit of energy to a home, compared to 1.01 units for propane.

While we do believe that electric heat pumps have a place in the energy portfolio of New Hampshire, we do not believe it should be a mandate from legislation. A combination of different energy sources will be the best, and it should remain a decision that is made by the consumer.

In January 2019, Harmony Homes by The Bay, and elderly housing facility in Durham, NH learned firsthand of the problems with electric heat pumps being used for a sole heat source here in New Hampshire. This facility contains around 50 individual assisted living rooms. When the building was constructed, the engineer had specified that individual electric heat pumps be installed in every room to take care of the heating and cooling needs of that room. When January hit, and the temperatures fell, the electric heat pumps could no longer support the heating needs of the elderly residents and they could not get the building above 65-degree Fahrenheit. Electric heat pumps will run at lower temperatures, but they will blow cool air at best and the elderly like hot air, not cool air. The elderly residents at this facility were not comfortable, and the owner was forced to spend an additional \$72,000 to put individual propane fired Rinnai heaters in each room to accommodate the needs of its residents of which he later recovered in a lawsuit. The electric heat pumps will work for the shoulder seasons but should not be mandated and the only option for heating homes and businesses within our State.

Mandating that New Hampshire residents only use electric heat pumps will affect the livelihood of 40 different propane companies that are directly involved in their communities within our State. Most of these businesses are small, family-owned businesses, with over 100 locations throughout the State to service their customers. Within these small businesses they sustain over 2,700 green jobs and the local infrastructure to provide critical energy diversity and reduce the demand on our fragile electrical grid.

It is for these reasons that I ask you to support the passage of Part III of SB86 and give our residents the option to choose the energy choice that best fits their needs.

My name is Donald Chagnon. I am the Northern New England Managing Partner for Townsend Energy. Townsend Energy has been a family-owned business since 1931 and employs over 100 dedicated individuals with well-paying jobs, excellent benefits and a community involvement that spreads throughout our territory.

I would like to thank the members of this committee for the opportunity to testify in regards to SB-86 and in particular my support of part III of this Senate Bill.

Being born and raised in this state, I know that Freedom of Choice is not just the American way, it is the New Hampshire way through and through.

There are over 40 propane companies in the State of NH employing over 2,700 of your constituents with well-paying careers. We provide a reliable energy source to over 250,000 homes and businesses in this state with a clean, low-carbon energy source that is an approved alternative fuel under the U.S. Environmental Protection Agency's Clean Air Act. Using propane accelerates decarbonization and reduces the demand on our fragile electric grid.

We have all witnessed the failures of our electric grids across the country, including NH and most recently with the rolling blackouts in Texas and California, and the devastation that can cause. Those that had propane-powered generators were able to maintain heat, hot water and cooking while many others experienced frozen pipes and destruction in their homes and businesses. It was not that long ago that some of the people in our own state were without electricity for up to nine days.

We need diversity of choice in this state and throughout the country to prevent this type of situation from occurring. The propane industry is often called on when the electrical grid fails, to supply propane due to the versatility in not only powering generators, but cooking, lights, heat and many other uses.

In addition to the versatility of propane, it is more efficient than electricity. The EPA's Energy Star Program gives propane a source site ratio of 1.01, compared to 2.52 for electricity from the New England ISO grid. This means that it takes 2.5 units of electricity to produce and deliver 1 unit of energy to a home, compared to 1.01 units of propane. For all of the energy that goes into the production of electricity, only about 33 percent of that energy reaches the end user.

There is no doubt that having diverse energy sources in NH is important to the safety and comfort of our citizens, their homes and their businesses. For these reasons and more, I ask that you support Section III of Senate Bill 86.

Testimony of Jason P. Grower Regional Director of Operations, New Hampshire Dead River Company

Before the Municipal and County Government Committee

In Support of Part III of SB86-FN

Chairman Dolan, Vice-Chairman Piemonte, and members of the Committee, my name is Jason Grower. I originally grew up in New York State, but after spending just over 24 years serving our Navy, I call New Hampshire home, and I now live in Goffstown. I am the Regional Director of Operations for Dead River Company, where my responsibilities include delivering energy to thousands of heating oil and propane customers throughout the State of New Hampshire. We also provide service to those customers to ensure that they stay safe and warm when the temperatures drop. In New Hampshire, we employ over 250 people, and throughout New England, over 1200. I routinely visit my employees at our local offices in Plymouth, Bristol, New London, Somersworth, and Manchester, and we also have offices in Haverhill, West Lebanon, and Keene. I am proud of our Company, and I am especially proud that, when you call our Company, you get a real, live person on the line who is ready to take care of you – chances are, that person is one of your neighbors.

I come before you today in support of Part III of Senate Bill 86. First and foremost, we view this legislation as a protection of consumer freedom. That is, the aim of Part III ensures that our customers, and your constituents, will always have the freedom of choice to heat their homes with whichever fuel they choose. If they choose electric heat, they should have that freedom. If they choose oil or propane heat, they should have that freedom as well. Some even choose wood, and we support that too. The answer is an "all of the above solution," and when a government impinges on consumer choice and plays "favorites," we all lose. Town and municipal governments may argue that it restricts their ability to create local regulations, but the bottom line must be this: legislation should always enable consumer choice, not restrict it. Part III of SB86 does exactly that. Six other states agree, and have passed similar laws, with another 15 states pending.

If SB86 does not pass, another effect would be that, companies could essentially be legislated out of existence – widespread, wholesale restriction of home heating fuels would have a detrimental impact to our industry, of course. But what's more, the Granite Staters we employ would be harmed as well. As our Nation recovers from the effects of the COVID pandemic and going forward, we can ill afford to pick which companies should succeed.

Some also believe that certain types of fuels should be banned in favor of other types, because they believe fuels like oil and propane are "dirty" and harmful to our environment. Today's fuels are cleaner than ever, though, and to be clear: we support continually increasing efficiency of home heating systems, and we support cleaner fuels as well. Our industry, and my company, have been working on this for years, and we continue to do so today. Consider the following:

- Propane is a clean fuel listed in the 1990 Clean Air Act. Propane use has been increasing
- In 2018, cleaner heating oil was introduced that effectively eliminates sulfur. Ultra-low sulfur heating oil (ULSHO) greatly reduces emissions. It also results in greater heating efficiency, and it opens even more options to consumers to install the most advanced, ultra-efficient equipment when they are ready to upgrade. I personally made that upgrade last week as well. We are focused on energy efficiency.
- The aforementioned advanced heating equipment has also significantly reduced energy consumption and is continually improving. We actively engage our customers about ways to

be more efficient and use less of the products we sell. Today, the average homeowner uses 700 gallons of heating oil annually. This is less than half of their usage in the 1980's.

• Today, opportunities are occurring right here in our backyard. As we speak, Dead River Company is pioneering a new, renewable liquid fuel called Ethyl Levulinate. This fuel can be produced from either woody biomass or regional waste. It has shown real promise, and our employees are even taking part testing it in their own homes.

In sum, we believe that a broad spectrum of energy choices is most beneficial to consumers. We are often reminded of this during extreme weather or in times of natural disasters, most recently during rolling blackouts in Texas and California. Homes which have multiple sources of heat and energy are resilient, though. I mentioned earlier that I served in the military, and we had a very simple saying that talks to redundancy: One is none, and two is one. I respectfully ask for your consideration and support for Part III of SB86, to ensure consumers can choose for themselves which fuels they want to heat and power their homes.

Dear Chairman Dolan and members of the Committee,

The New Hampshire Building Officials Association (NHBOA) does not support Senate Bill 86 due to potential conflicts that may result with already adopted codes and amendments. Our primary concern is with Part III that proposes to amend NH RSA 155-A-2.

To our knowledge, this proposed amendment has not been presented to the NH Building Code Review Board (BCRB) to verify that it will not create conflicts with either the 2015 editions of the International Building Code, International Residential Code, the International Mechanical Code or any of the amendments to these codes already adopted by the State of NH.

The BCRB was established by the legislature in 2002 per NH RSA 155-A:10 and is charged with reviewing and recommending to the legislature new code proposals and amendments to the adopted codes. The concern of conflicts is raised each time amendments to RSA 155-A are proposed by the legislature and those proposals are not vetted by the BCRB to avoid conflicts.

NHBOA does not oppose amending and keeping our statutes up to date. We do believe strongly the legislature should be utilizing the board established to recognize and prevent any potential conflicts before they amend the RSA relative to the State Building Code.

AmeriGas Propane L.P. is pleased to have the opportunity to offer its comments in support of Part III of **SB 86-FN - An Act adopting omnibus legislation relative to planning and zoning,** to ensure that all citizens of New Hampshire continue to have the right to choose their own energy sources.

AmeriGas is the largest propane retailer in the United States, serving over 1.5 million customers in all fifty states from approximately 1,800 propane distribution locations. AmeriGas has 650 area offices with approximately 6,500 employees nationwide. In New Hampshire over 55,000 consumers have selected AmeriGas to supply them with clean, environmentally friendly propane as one of their energy sources, and this low carbon energy solution is supplied to them by over 100 of their fellow New Hampshire residents.

We all want a cleaner environment. Consumers also want the right to choose what energy source works best for their homes and businesses. Propane is one of those clean energy solutions. The US Energy and Information Administration (EIA) has determined that roughly three times the source energy is required to deliver one unit of electrical power to a consumer in comparison with propane. Propane has a great source-site ratio of 1.01 making it highly efficient in delivering energy to the consumer without the waste.

Access to clean, affordable efficient and renewable energy solutions such as propane ensures equity on the path to zero. Urban and rural low-income households, especially African American and Latino households, spend roughly three times as much of their income on energy costs as non low-income households. In February 2021, EIA reported that electricity was 68% more expensive per million BTUs than propane. Energy should be affordable, so that no one must go without. Despite this belief, the share of income that low-income households were forced to spend on electricity rose by a third in the last decade. Access and choice ensure equity.

Since propane is an off the grid power source it makes our product a valuable partner to electric, reducing the taxing demands during peak usage periods and strengthening the grid. Rolling brown and blackouts have become more common place as demand increases faster than infrastructure improvements are made. This makes energy diversity even more essential for New Hampshire. Propane can reduce the load in peak periods or act as a clean replacement when the

power goes out. With the last year resulting in record outages across the country, propane presented clear solutions while the electrical infrastructure was in crisis. Propane is an EPA certified alternative fuel and a federally certified emergency civil defense energy. When winter storms, natural disasters, or pandemics call for portable energy or back up energy generators, propane steps in to save the day. Whether it is a small outdoor restaurant heating an outdoor space, or a large hospital or school using propane to heat and as back power generation, propane is there to supply reliable clean energy.

We can all agree that we need to work towards a cleaner tomorrow. By maintaining the consumers right to choose their energy source or energy diversification you are protecting both the infrastructure and their wallets. Propane is a sustainable, low-carbon footprint, resilient, cost-effective, and renewable energy option that should be part of our future Green solution.

For these reasons, we respectfully request that the Committee vote Yes on Part III of SB 86-FN.

CEA is a nationwide association made up of both energy consumers and producers working to advance all-of-the-above energy and environmental policies that will lower energy costs for every American. CEA supports actions that thoughtfully advance our nation towards a cleaner, more environmentally responsible energy future. We believe that responsible policies always consider the needs of consumers while leveraging and supporting the development of state-of-the-art technologies to improve our environmental stewardship, aiding in the continued reductions of all emissions.

On behalf of CEA I want to thank you for the opportunity to provide this testimony today in support of part three of Senate Bill 86.

This is very simple and straight-forward legislation that protects the rights of individual consumers to choose the manner in which they heat their home, cook their food, dry their clothes—essentially how they power their lives.

While the objective of SB 86 is simple, its importance and timeliness can't be understated. Unfortunately, dozens of short-sighted local mandates and prohibitions including right next door in Massachusetts, have been proposed and passed across the country that would deny families and businesses the right to choose for themselves how they power their households, business operations, and even what type of appliances a contractor can install in a home it builds. This legislation prevents a municipality from infringing on the right of individuals and businesses to make these choices. It should be up to consumers to decide what types of appliances they want not anyone else.

Similar bipartisan legislation has passed in states like Florida, Kentucky, West Virginia, and Georgia among others to address the aforementioned concerns. Further, we need to have one state uniform energy policy rather than an unworkable patchwork of local prohibitions and rules that would make service and distribution almost impossible to figure out, likely at much greater cost to consumers.



I want to reiterate and be clear – CEA wants to see a clean future with lower emissions. However, misguided attempts to ban natural gas and propane service by forcing mandates onto consumers will lead to astronomical costs and jeopardize energy resources that are helping our nation reduce emissions. A recent <u>report</u> requested by the City Supervisor of San Francisco found that its natural gas ban could cost consumers up to \$5.9 billion or potentially over \$34,000 per household. We do not want to repeat those mistakes here in New Hampshire.

On behalf of CEA I urge you to support this commonsense measure that will help shield our neighbors from intrusive and unrealistic mandates as well as preserve New Hampshire's economic competitiveness.

Dear Chairman Dolan and Honorable Committee Members:

Conservation Law Foundation ("CLF") appreciates the opportunity to comment on SB 86, Part II, establishing the New Hampshire Housing and Conservation Program. CLF is a non-profit environmental advocacy organization working to protect the environment and promote healthy communities in New Hampshire, and across New England. CLF's Northern New England Healthy Neighborhoods Initiative aims to create economic, environmental, community and health benefits for residents, neighborhoods, small towns, and cities through innovative investments in new, energy efficient, and mixed-income housing developments as well as the rehabilitation of older homes.

CLF strongly supports SB 86, Part II, establishing the Housing and Conservation Planning Program. The connections between housing, health, climate, transportation, and economic growth are increasingly recognized as interrelated challenges. According to a January 2021 report of the United States Surgeon General on community health and economic prosperity, among the essential conditions for healthy communities are humane housing, reliable transportation, and a thriving natural world.¹

By re-establishing the Housing and Conservation Planning Program to provide technical assistance grants to municipalities to implement growth and development strategies, the legislature has the opportunity to take a balanced and strategic approach to helping motivated municipalities alleviate these challenges in New Hampshire. Moreover, the four phases that a municipality must comply with to be eligible for such grants will ensure that housing and

conservation policies reflect input from its residents, which is critical to developing effective and equitable policy.

Economic challenges in some New Hampshire communities include several decades of economic decline, combined with stagnant wage growth, that have led to the inability to attract housing investments. Other communities are experiencing job growth but do not have sufficient housing to support their workforce, and as a result the costs of available housing are rising rapidly. For instance, the vacancy rate in the rental market in 2020 was 1.8% of all units, making rental housing difficult to obtain.² Spurred by high demand and low inventory, the median monthly rent of a two-bedroom unit rose by 22% statewide, including up to 26-28% in some southern counties, over the past 5 years.³ The homebuying market tells a similar story: while demand is high, sales were down 6% from 2019 to 2020 due to lack of inventory.⁴ High demand and low inventory has caused the median sales price in August 2020 to be 14% higher than in August 2019.⁵ Despite increasing household income for buyers and renters, the record high cost of homes places homebuying out of reach for many New Hampshire residents.⁶ Similarly, while the development of new multi-family rental units has increased in recent years, many of the units are too expensive for renters earning an average income.⁷

Moreover, residents who do have housing report high rates of housing insecurity. In a September 2020 survey, over 30% of New Hampshire adults reported living in a household where eviction or foreclosure was very or somewhat likely to occur in the next 2 months.⁸ Nearly 6% of New Hampshire adults reported they were behind on their rent or mortgage or had little confidence in their ability to pay next month's rent or mortgage on time.⁹ These trends are not sustainable for the New Hampshire economy. New Hampshire must provide an estimated 20,000 additional housing units to meet demand and, consequently, make housing more affordable.¹⁰

The Housing and Conservation Planning Program offers an important opportunity to remedy the lack of safe, stable, affordable housing that has resulted in economic disadvantage. Indeed the program was well received by municipalities while it was active in 2007-08. Its technical assistance matching grants would support the strategic planning and development of higher-density housing for families of varying income levels, including much needed workforce

housing, and the preservation of open space and environmental resources. The resulting walkable neighborhoods offer potential access to jobs, transportation, and green space as well as increased housing stability and economic opportunity. SB 86 also requires stakeholder engagement in the development and planning stages, thus ensuring that the development policies are equitable and reflect community needs.



Dear Mr. Chairman and Members of the Committee:

Thank you for this opportunity express the Forest Society's support for Part II of Senate Bill 86, legislation to establish the Housing and Conservation Planning Program. As has been noted, the Legislature first established the HCPP in 2008. This voluntary program provided technical assistance matching grants to towns and cities to plan for growth and development that encouraged a balanced housing stock, including higher density and workforce housing opportunities. It also promoted the reuse of existing buildings, including historic properties, while protecting the municipalities' natural resources through more efficient and compact development. Unfortunately, budget constraints at the time forced its repeal in 2011.

One of the prime benefits of the HCPP was to create a vehicle where developers, municipalities and conservationists could work together to find better and more sustainable approaches to land development. SB 86 retains the voluntary nature of the original program. What is notable about it is that the program, if reestablished, will provide a range of tools on how to plan for the full range of housing needs and the protection of important natural and cultural resources to municipalities who choose to participate.

A vibrant town or city has a robust economy, balanced housing opportunity and a healthy environment. We believe the Housing and Conservation Planning Program will help achieve that outcome and will show how the conservation of New Hampshire's natural resources and the provision of needed housing for our citizens can be mutually beneficial when pursued together.
