# **METHODOLOGY:**

This bill increases the penalty for a person who pays to engage in sexual contact with another person under the age of 16 who is a victim of human trafficking.

This bill contains penalties that may have an impact on the New Hampshire judicial and correctional systems. There is no method to determine how many charges would be brought as a result of the changes contained in this bill to determine the fiscal impact on expenditures. 

# Summary of testimony presented in support: Representative Massamilla

- Reviewed the history of the bill.
- This bill raises the penalties for purchasers of sex with a minor to a class A felony if the buyer is over the age of 20.
- The House Criminal Justice Committee amended the bill to say buyers 20 and under would only be charged with a class B felony.

- This bill attempts to eliminate the distinctions between traffickers and buyers by recognizing the equal role buyers play in creating a supply and demand marketplace.
- This creates the same penalty for a buyer as a trafficker.
- In 2017 the National Criminal Justice Reference Service reported that 41 states have statutes that made penalties for the buyers as high or almost as high as the federal penalties.
- The federal penalties range from a minimum of 10 years up to life imprisonment.
- Although NH cannot quantify the rate of child exploitation, human trafficking has been reported in every county.
- The National Human Trafficking Hotline says there have been eight trafficking cases and four indictments. In 2018 there were 29 investigations into human trafficking with 79% involving sex trafficking.
- A Boston psychology study by Melissa Farley et al stated that buyers are most likely to be between 20-75 years old, white males with incomes \$20,000 \$140,000, 44% college degree and 40% married.
- Sex trade is founded on demand.
- Penalties are not simply put in place as deterrents but as mechanisms to hold offenders accountable.
- The Governor has supported this bill in the past.
- Agrees with the concerns on the age carve out.
- · Agrees the word 'trafficking' needs to be included in III-a of the bill.

# **Bob Dunn** (Roman Catholic Diocese of Manchester)

- Human trafficking is a major concern for the church.
- Pope Francis has called human trafficking a crime against humanity.
- The NH Human Trafficking Collaborative Taskforce was created to address the urgent need for a coordinated response to the human trafficking threat in NH.
- The fact that that Taskforce exists speaks to how seriously law enforcement view the problem.
- Thinks everyone who was a supporter of HB180 in the House was happy without the carve out.
- Thinks the carve out was a political issue, as there were folks on the Criminal Justice Committee that wanted to see the carve out.
- Does not think it is ideal for it to be there, but the question is if it is necessary in order to pass both bodies.

# Darlene Pawlik

- Is a juvenile sex trafficking survivor from NH. Shared her personal experience of abuse, being sold on her 14<sup>th</sup> birthday, and often being bought specifically to be abused or raped.
- Supporting this bill as originally written would be great.
- Agreed to the age carve out because young people are stupid.

• Does not like the way the amendment is written, as it is too vague and confusing.

# Summary of testimony presented in opposition: Chief David Goldstein (Association of Chiefs of Police)

- Has worked cases involving trafficking and prostitution.
- The Chiefs are deeply committed to increasing protections for victims of human trafficking.
- Supported initial spirit of the bill to rase the offense to a class A felony.
- Encourages the Committee to reconsider the original language of the bill.
- Crimes of human trafficking are devastating to the victims and their families.
- There is no reason this offense should remain a class B felony at any time.
- The House amendment to the bill created a lesser offense of a class B felony based on the buyer's age.
- This is wholly inappropriate and goes against the federal standards.
- This is not an issue of being in a relationship, it is the intentional purchase and objectification of a human being.
- Senator French asked if there are often cases where buyers are under the age of 20.
  - o Doesn't know if he can answer that objectively. Has certainly seen it, but to put an actual number on it would be very difficult. Referenced the book *How to Lie with Statistics*.
- Senator Kahn asked if they supported the bill in 2020.
  - o Believes they did but would have to go back to look at that.
- Senator Kahn asked if the Chiefs support the original version of this bill.
  - o Yes.

# Joi Smith (NHCADSV) (provided written testimony)

- Served as a CORE member of the NH Human Trafficking Collaborative Taskforce.
- Statistics show there was an increase in the number of victims in 2020.
- Out of the total number of confirmed victims, 53% were victims of sex trafficking and 43% were victims of labor trafficking. Nearly 40% were minors.
- One of the most common form of trafficking in NH is familial trafficking.
- NH must work towards holding suppliers and purchasers accountable.
- Creating an exception does not allow us to acknowledge trafficking as the serve and horrific crime that it is.
- The Coalition supported the bill as originally introduced.
- The original language would bring NH closer in line with the federal law and it would be consistent with other states.
- Has significant concerns with the amendment that was put in by the House with the lesser felony for persons under the age of 20.
- There is no place for this type of carve out and it sends the message that the age of the buyer somehow makes the crime and level of exploitation less severe.

- Sex trafficking is the exploitation of a person through force, fraud or coercion and it is in no way comparable to a relationship, and therefore introducing a "Romeo and Juliet" clause is inappropriate.
- Urges the Committee to remove the House carve out.
- Senator Carson asked why the age carve out is for 20 years old when a person is considered an adult at age 18. Also asked if this says a 13-year-old can legally consent and the buyer would only get a class B felony.
  - That is what the concern is with this amendment.

# **Neutral Information Presented:**

Katherine Cooper (Association of Criminal Defense Lawyers)

- Testified to this problem in the House.
- The way the statute is drafted, III-a does not include an element that a person who is the victim has been trafficked.
- The actual elements of the statute are the same as RSA 645:2 that sets out the same crime of asking or paying for sex with someone under the age of 18.
- The intention of this statute is to include that a person has been trafficked.
- When a statute is analyzed in a jury trial, just because it is housed under a title that includes trafficking does not mean it is an element of the offense.
- Senator Whitley asked if she raised this in the House.
  - o Did and has raised this before in the Senate when the statute was originally passed.

#### Testimony of Joi Smith Program Director, New Hampshire Coalition Against Domestic and Sexual Violence

Good afternoon Madam Chair and Members of the Committee. My name is Joi Smith, and I am the Program Director at the NH Coalition Against Domestic and Sexual Violence, the umbrella organization for 12 community-based crisis centers who each year provide free and confidential services to nearly 15,000 survivors of domestic violence, sexual assault, child abuse and human trafficking. I am also a CORE member of the New Hampshire Human Trafficking Collaborative Task Force, established by NH Senate Bill 194 in 2007. We are a group of law enforcement officers, service providers, attorneys, state agencies and community stakeholders who respond directly to human trafficking cases in the Granite State.

I am here to speak in <u>opposition</u> to recent changes made to HB180, which seeks to increase the penalty for buyers under the law regarding trafficking in persons. Thank you for the opportunity to share this testimony today.

Human Trafficking is a serious matter here in the Granite State. In fact, statistics show that there was an increase in the number of victims seen in 2020. Out of the total number of confirmed victims, 53 percent were victims of sex trafficking and 43 percent were labor trafficking victims. Of those victims, nearly 40 percent were minors. Tragically, one of the most common forms of trafficking that we witness in New Hampshire is familial trafficking, where youth are at risk of exploitation even within their own family units. It's imperative that our state laws take a clear stance against human trafficking. In order to do so we must work towards holding both suppliers and purchasers accountable through addressing the supply and demand sides in the trade of human beings. Creating an exception does not allow us to acknowledge trafficking in persons and children as the severe and horrific crime that it is.

It is with this in mind that the Coalition supported HB180 as originally introduced at the start of the legislative session, which sought to increase the penalty for purchasing a trafficked person from a Class B Felony to a Class A Felony. We feel that this is an appropriate change to our human trafficking statute and acknowledges the severity of these heinous crimes. Moreover, this would bring New Hampshire closer to federal law when it comes to prosecuting crimes of human trafficking, and would be consistent with other state human trafficking laws, which treat this crime as a Class A felony or a minimum 15 year sentence. We strongly urge the committee to support increaseing the penalty from a Class B to a Class A felony.

However, we have significant concerns regarding the amendment to HB180 which was adopted by the House and would create a lesser felony for persons under the age of 20 who partake and purchase in human trafficking. There is no place for this type of carve out from a human trafficking perspective and it sends the message that the age of the buyer somehow makes the crime and level of exploitation less severe. Individuals who are within certain age groups should not be given leniency for the intentional exploitation and purchase of human beings. This amendment is not in alignment with federal policy, and goes against best practice in our statewide efforts to end human trafficking and hold perpetrators accountable.

To introduce a so-called "Romeo and Juliet" clause that is typically applied in statutory rape cases completely undermines the level of abuse and trauma witnessed in human trafficking cases, especially among minors. Sex trafficking is the exploitation of a person through force, fraud or coercion, it is no in way comparable to a relationship. New Hampshire would be taking a giant leap backward in our efforts to address human trafficking should this provision be adopted. It would leave many child victims more vulnerable and fails to acknowledge the type of exploitation that occurs in these cases. We are also unaware of any states that have these types of statutory carve outs.

There is absolutely no need for New Hampshire to be creating a loophole for a person partaking human trafficking to further manipulate and abuse child sex trafficking victims and to lessen the culpability of purchasers in the state. We urge the committee to consider removing section III(b) of HB180 and pass the bill as originally introduced so that any purchaser, regardless of age relative to the victim, is guilty of a Class A felony when engaging in human trafficking in the Granite State.

To recap, I am a survivor of juvenile sex trafficking. I was groomed in my neighborhood for 9-10 months and sold on my 14th birthday to a small business owner from Atkinson, NH. Then, I was sold many, many more times, by a few different pimps over four years.

I know you may think I was sold for sexual encounters, but often, I was sold to be abused, being roughly handled and violently raped. It was traumatizing and demoralizing to be seen, not as a person, but as an implement for the pleasure of the men who paid my pimps. I seldom got any money and if I did it was usually just enough for drugs and alcohol to keep me numb.

The buyers were specifically looking for young girls. When I was 17, I was too old for many buyers. So, I was sold to one man as a "housePet".

When I got pregnant, my buyer said he'd kill me if I didn't abort. So, I faked an abortion and hid. Forced abortion is common among sex trafficking victims. Which is another egregious trauma.

It took over twenty years for me to tell anyone what had happened to me. Many survivors never tell anyone or just a few people or a trusted therapist. So, it's hard to grasp the scope of the problem.

Please vote Ought to Pass On HB 180.

Please tell would-be buyers that NH will not allow her children to be prostituted. That they will be prosecuted with harsh penalties.

The purpose of Section III-a is to address one specific problem associated with trafficking; criminalizing paying a minor for sex to engage in a sexually explicit performance irrespective of whether the minor was trafficked or freely consented. A requirement that the minor was trafficked would effectively make this provision unenforceable.

Under New Hampshire law, the required mental state for a crime applies to all of the material elements of an offense. Patrons paying for sex or to watch a sexually explicit performance typically do not know if the payee was trafficked by any of the means listed in section !(a)(1)-(11) of RSA 633:7. In the vast majority of cases, it would be impossible to prove beyond a reasonable doubt that the payor knew the minor victim was trafficked. Adding a requirement that the minor was trafficked to section !!!-a would render the law effectively toothless.

Instead, allowing a Class B felony for known buyers suggests that the active engagement in sexual exploitation of minors is roughly equivalent to other crimes in this category such as computer fraud, a fourth DWI or petty theft.

There was a question raised in the hearing regarding whether or not the term "trafficking" should be incorporated into RSA 633:7, III-a. Under New Hampshire law, the required mental state for a crime applies to all of the material elements of an offense so a requirement that the minor was trafficked would effectively make this provision unenforceable as in almost every case it would be impossible to prove beyond a reasonable doubt that the buyer knew the minor victim was trafficked. Abusers would take advantage of this loophole.

RSA 645:2, II(a) and RSA 633:7, III(a) serve very specific purposes when it comes to protecting minors against sexual exploitation. While it is correct that RSA 645:2, II(a) also criminalizes paying a minor for sex, it does not address paying a minor to engage in sexually explicit performances. Although these statutes look similar, there are subtle differences and are not identical. RSA 633:7 is broader in some ways, because it includes paying to observe a sexually explicit performance with a person under the age of 18. However, RSA 645:2, II is broader in different ways, because it criminalizes people for allowing places to be used for underage prostitution, or where a person induces another to engage in underage prostitution, or where a person profits from underage prostitution, etc. These statutes are not redundant, nor do they cancel each other out.

Ultimately, we all want children in our state to thrive and grow up in homes and communities free from the threat of human trafficking, a vision which would be promoted by HB180 in its original form. I would be happy to answer any questions that the committee may have regarding this legislation or the work of the Task Force to respond to Human Trafficking in New Hampshire. I am grateful to the committee for your thoughtful consideration and the work you do for our state.
