Summary of Testimony Presented:

Representative Leah Cushman, Hillsborough 2

- Rep. Cushman introduced and testified in support of this bill.
- Rep. Cushman said, individuals have the right to treat their own bodies, and the right to accept or decline treatment without coercion.

- Rep. Cushman said, as amended by the House, there are exceptions to the bill:
 - This bill does not supersede school vaccination requirements.
 - There are some accommodation conditions for state law.
 - Under this bill involuntarily submission of the mentally ill for treatment can still be done.
 - Vaccines for communicable diseases are still required.
- Rep. Cushman said, this bill requires due process for right to use. Patient selfdetermination is valuable. This bill declares that bodily autonomy is important. The government cannot mandate medical decisions.

Representative Tim Lang, Belknap 4

- Rep. Lang testified in support of this bill.
- Rep. Lang said he did not want to see this bill intervene with important procedures, for example, the life-saving work of first responders or required vaccinations for schools. This bill, as amended, is a good compromise.
- Rep. Lang said, this bill protects the inherit right to bodily integrity for the citizens of NH.
- Sen. Avard asked, can schools require parents at graduations to get vaccines to attend?
- Senator Avard referenced the UNH graduation.
 - Rep. Lang, my inclination is no. I serve on the Governor's re-opening task force. They have guidance available to them to safely host a large event.
- Sen. Bradley asked, would you have objection if we made this bill effective upon passage?
 Rep. Lang did not have an objection.
- Sen. Avard asked, what is the penalty if someone violates this bill?
 - Rep. Lang said, I imagine it would be a civil penalty. We did not put one in here. I assume the Attorney General would decide that.
- Sen. Sherman asked, how does this address minors?
 - $\circ~$ Rep. Lang, what does the section say?
- Sen. Sherman referenced Section 1 and said, suppose a child has a curable cancer and the recommendation is that they undergo standard chemo. The family wants to take the child elsewhere for different treatment. The state has a compelling obligation to protect the child. How does this bill protect the minor when there is a conflict with the parents and the medical providers?
 - Rep. Lang said, I would think federal law would override state law and there would be judicial intervention in that case.
- Sen. Sherman asked, would you be amenable to an amendment to protect a minor?
 - Rep. Lang said, I would not object to an amendment that clarifies that so long as it does not get into parental rights.
- Sen. Whitley asked, is this a problem in NH? Are there forced vaccinations?
 - Rep. Lang said, this bill came before the COVID-19 pandemic. If you want to be a foster parent, you and your family all must be vaccinated. Religious exemptions did not count there. You must be vaccinated. I believe that was an infringement on what could be perfectly good foster families.
- Sen. Avard said, would you be amenable to a fine for if someone violates this law?
 Rep. Lang said yes.

- Sen. Bradley said, would you and members of the House be amenable to an amendment that made this for a person of the age of majority (18+ years old)?
 - Rep. Lang said, no, similar to Section 3, I would reference federal guidance in extreme cases. We do not want narrow guidance. I do not want it to infringe on parental rights.
- Sen. Sherman said, if you are a private commercial entity and you do not believe it is safe for people who are not vaccinated come onto your property, would your bill prevent a private entity from preventing an individual from participating on their property?
 - Rep. Lang said, that was provided for and there is a relevant United States Supreme Court case for that. This is about compelling individual rights. Customers have the right to shop and go where they want. I think there is a case to be made that individual business could make a requirement. I would not say that is a good idea.
- Sen. Sherman said, are we telling commercial businesses what to do with this bill?
 Rep. Lang said, that is not what we are intending to do with this bill.
- Sen. Whitley said, this bill is a policy statement. This may interfere with federal law. Could we have the Attorney General weigh in?
 - Rep. Lang said, yes, I always welcome the Attorney General to weigh in. If there is a problem, let's fix it, but I do not believe this bill violates federal law.

Representative Lang later testified again at the end of the hearing.

- Rep. Lang said, this bill will not affect vaccination rates. This about protecting those that choose not to get vaccinated. Where there is a risk there needs to be a choice.
- Sen. Bradley asked, what if the Senate made this bill just about the COVID-19 vaccine and left all the other vaccines for another day?
 - Rep. Lang said, I believe in compromise. I will take what I can get, but we'll need to come back to it again and again.
- Sen. Whitley said, I remain perplexed on the need for this bill. We do not have a mandate, a passport, or etc. is this trying to solve a problem that doesn't exist?
 - Rep. Lang said, there is a national conversation going on about COVID-19 passports. This bill prevents those forward events. This also goes back to foster parents being required to get vaccines by the state. I see steps being taken that I do not like.

Dr. Peter McCullough

- Dr. McCullough said he is an expert in COVID-19 and works at the College of Medicine at Texas A&M.
- Dr. McCullough said, COVID-19 is a treatable illness early. COVID recovered patients have no risk of getting it again and cannot receive or transmit virus. Frail seniors, pregnant women, children were excluded from trials.
- Dr. McCullough said, currently we are pressuring individuals with safety at risk. COVID recovered patients have 2-3 times increased safety risks after vaccinated. Any individual felt pressured to get a vaccine would have to contemplate complex safety data.

- Dr. McCullough said, there have been 2,342 deaths in the 60 million COVID vaccinations, as well as hospitalizations and reactions. The vaccine failure rate is higher than we thought. It is immoral, unethical, and illegal to pressure individuals into vaccination.
- Sen. Sherman asked about Dr. McCullough's expertise.
 - o Dr. McCullough said, I am considered to be a field expert. I am an epidemiologist.
- Sen. Sherman said, are you saying asymptomatic individuals cannot transmit the virus?
 - o Dr. McCullough said, asymptomatic transmission is less than 1% of transmissions.
- Sen. Sherman asked, if you wouldn't mind providing the committee with those references it would be helpful. Wouldn't you agree if they are already forming antibodies that they are well along and not contagious?
 - Dr. McCullough said, we concluded the case contact did not transmit it. These are my opinions. They may not align with other doctors' opinions.

Beth Daly, Bureau Chief of Infection Control, NH DHHS

- Ms. Daly testified in opposition to this bill.
- Ms. Daly said, it is critical for certain immunization requirements remain in place to protect individuals.
- Ms. Daly said, we appreciate the amendments made in the house, but we still have some concerns. We are worried about inconsistent application throughout the state. We are primarily concerned about the bill for vaccinations for employees in health care facilities. If we eliminate the employee vaccination requirement, employee vaccinations will decrease, and this will put our most vulnerable patients in health facilities at risk.
- Sen. Whitley said, it sounds like federal law handles the delicate balance.
 - Ms. Daly said, we believe there already is a balance and there would be harmful impacts for this legislation.
- Sen. Avard said, if an employer forced me to get a vaccine, that gives the employer the right to jeopardize my health?
 - Ms. Daly said, we are talking about balancing perspectives here.
- Sen. Avard said, what are the potential risks for taking the vaccines? There are always health risks. These vaccine risks are not advertised on TV. Shouldn't I have the choice?
 - Ms. Daly said, the vaccines in use today are very safe.
- Sen. Avard said, over the long term will these vaccines cause any birth defects?
 - Ms. Daly said, the recommendation is for pregnant women to get vaccinated.
- Sen. Sherman said, we lead the country for vaccinations in senior facilities. What would be the impact if we were not to require or encourage vaccination for those who work in these facilities?
 - Ms. Daly said, once COVID-19 is introduced into one of these facilities it spreads rapidly.
- Sen. Sherman said, at the hospital I work at, during flu season, if you opt to not get vaccinated then you must wear a mask. Don't we already have protections for people that do not want to get vaccinated at their workplace?
 - Ms. Daly said, yes, usually wearing a mask.
- Sen. Bradley said, do you have a definition for a health care worker in statute we could use?

- Ms. Daly said, we use a definition from the CDC. It is quite broad from health services to food services and environmental services.
- Sen. Bradley said, if you could get that to us that would be helpful.
- Sen. Whitley said, isn't there a definition in NH statute?

Deana Pollard-Sacks, esq.

ŧ.

- Ms. Pollard-Sacks testified in support of this bill.
- Ms. Pollard-Sacks said her expertise is in liberty jurisprudence and constitutional law.
- Ms. Pollard-Sacks said, we already have signs for how medical liberty is viewed by the courts.
- Ms. Pollard-Sacks said, one issue I saw in the bill is when a state can order treatment of the child over the state. No person can be compelled to receive unwanted medical intervention. In the state's interest for a minor, there is a very clear rule for age 18+ that no medical treatment may ever be mandated. An individual has a right to die by their condition, but not by assisted suicide.
- Ms. Pollard-Sacks said, no liberty has ever been protected stronger than medical liberty. Additionally, private hospitals may end up having more protections than public hospitals.

Dr. Christine Arsnow, NH Pediatric Society & NH Medical Society

- Dr. Arsnow testified in opposition of this bill.
- Dr. Arsnow said, autonomy is important to an individual's health, but should not be preserved at the expense of another person. The vagueness of the wording in this bill is dangerous. This is a danger to vulnerable people. Foster families should be vaccinated to protect children in the government's care. This bill is not necessary to ensure medical freedom.
- Sen. Whitley said, isn't it true that vaccines are held to incredibly high standards?
 Dr. Arsnow said, this is true. These vaccines are very well studied.
- Sen. Bradley said, all these COVID vaccines have been allowed on emergency FDA approval and have not been studied for decades.
 - Dr. Arsnow said, I was talking about routine childhood vaccines.

Representative Erica Layon, Rockingham 6

- Rep. Layon testified in support of this bill.
- Rep. Layon said her expertise on vaccines and medical supplies comes from her time on wall street.
- Rep. Layon said COVID-19 vaccines have not gone through the approval process and have not gone through rigorous study. The safety and efficacy of these vaccines does not have sufficient evidence. There is only an emergency use authorization. There are risks that a conscientious person can see. People can choose not to get this vaccine and that is a logical choice.

- Sen. Sherman said, I hope you mean instead of "logical choice," you mean a "personal choice." Where in statute right now is anyone compelled to get a COVID vaccine? Adults do have a right to refuse the vaccine.
 - Rep. Layon said, this is a clarifying issue that is emerging. We want to make sure people are not forced to choose between their livelihood and their health risks. I understand why a pregnant woman would think she is at risk, because pregnant women were not studied. This is especially a problem for women who have not yet disclosed to their employer that they are pregnant but may need an exemption from the vaccine because they are pregnant.
- Sen. Sherman asked, where currently is a woman, pregnant or not, required to be vaccinated?
 - Rep. Layon said, I am talking about where a woman could get that medical exemption.

Dr. Jay Bhattacharya, Professor of Medicine at Stanford University

- Dr. Bhattacharya said he has experience in infectious disease, immunology, and vaccine safety research with the FDA.
- Dr. Bhattacharya said he will only speak on the COVID-19 vaccine, which is the greatest invention in science.
- Dr. Bhattacharya said, vaccine passports and mandates undermine public health. These ideas create fear and hesitancy in the media. Skeptics are triggered by those who say you cannot live a normal life after the vaccine. We cannot create a two-tier society.
- Dr. Bhattacharya said, the risk of vaccine is asymmetrical. Comprehensive analysis concluded for individuals over age of 70, there is a 5% mortality rate and for individuals under the age of 70 there is a 0.5% risk of death from COVID-19.
- Dr. Bhattacharya reiterated some of Dr. McCullough's testimony on asymptomatic spread.
- Sen. Whitley said, your testimony was about vaccine mandates and vaccine passports. Do you understand this bill does not do that?
 - Dr. Bhattacharya said, I understand this bill prevents that, but I am testifying the medical aspect of this bill.
- Sen. Avard said, do you think any part of Dr. McCullough's testimony was misleading?
 Dr. Bhattacharya said, I did not hear it all, but no.

Thomas Renz, esq.

- Mr. Renz said, in terms of individual liberties, since Roe v. Wade, there has been a very clear mandate that medical liberties trump everything else.
- Mr. Renz said, there has been over 379 deaths nationally for children. When the CDC issued the rule for death counting for COVID-19, it required COVID to be "the underlying cause more often than not."
- Mr. Renz said, this bill prevents discrimination. Mr. Renz mentioned the story of Ryan White from the 1980's. He said, aids had an almost 100% mortality rate. COVID does not.
- Mr. Renz said, why would we mandate a COVID vaccine? It is not even approved.

- Mr. Renz said, an employer that wants to discriminate against vaccination status is discriminatory on a religious basis.
- Mr. Renz said, I am against the COVID-19 vaccine. I am against no other vaccine.
- Mr. Renz said, we should not be mandating a vaccine where the mortality rate is so low. I urge you to expand this bill. Let's not allow for people to be discriminated against the same way they were in the 1980's for aids.

Lisa Dean

- Ms. Dean testified in support of the bill.
- Ms. Dean said, parental rights and consent is very serious.

Ken Norton, NAMI NH

- Mr. Norton said, this bill does is missing a section about nonemergency psychiatric health admissions. It should include this.
- Sen. Bradley said, please get back to us offline about that.

Randy Hebert

- Mr. Hebert said, this bill needs some language included.
- Mr. Hebert said, you guys need to do better.
- Mr. Hebert said he is in opposition of the bill at this time.

Dr. Lawrence Palevsky

- Dr. Palevsky said he is a pediatrician in New York.
- Dr. Palevsky said, unvaccinated children are blamed for outbreaks but cannot be vaccinated. Unvaccinated children are not necessarily responsible for outbreaks. There is an assumption that once you are vaccinated, then you do not spread the disease. This is not true. But we have ignored this.
- Dr. Palevsky said, 1 in 5 children have neurological disorders. 1 in 5 children have Autism. 1 in 20 children have seizure disorders. No study has ever evaluated neuroinflammation from vaccines.
- Dr. Palevsky said, where there is risk, there needs to be choice. We are told to vaccinate with certainty, but there is a lot of uncertainty. We need the freedom to choose.

Dr. Gary Sobelson, NH Medical Society

- Dr. Sobelson testified in opposition to this bill.
- Dr. Sobelson said he is a family physician in NH.
- Dr. Sobelson said he is displeased with the amount of time spent on hearing testimony from out of state physicians during this hearing.

- Dr. Sobelson said, out of state physicians and attorneys previously testified information that contradicted national experts.
- Dr. Sobelson said, your privileges end when you incline on mine. You cannot harm others by your choice.
- Dr. Sobelson referenced the story of "Typhoid Mary." He said she was an early immigrant who infected others and was eventually detained.
- Dr. Sobelson said, our state has done one of the best jobs in the country on leading vaccinations. Bills that get in the way of that are not in public interest.
- Sen. Bradley said, did you testify in front of the House?
 - Dr. Sobelson said, I did not.

Representative Judy Aron, Sullivan 7

- Rep. Aron testified in support of this bill.
- Rep. Aron said, we need to make sure people can make their own choice. People should not be bullied by society or government to do something they truly do not want to do.

Thomas McLeod, Mount Vernon, NH

- Mr. McLeod said he is the Liberty Defense Fund chair.
- Mr. McLeod said, Jacobson v. Massachusetts has been undermined by recent developments.
- Mr. McLeod said, nobody should be discriminated against for not taking the vaccine.
- Mr. McLeod said he plans to submit written testimony with further detail.

Laura Condon, Bedford, NH

- Ms. Condon testified in support of this bill.
- Ms. Condon said she is a National Vaccine Information Center volunteer.
- Ms. Condon said, there have been over 200 vaccine deaths reported. On January 4, 2021 there was a death in NH of a 44-year-old woman that got the COVID vaccine. On March 9, 2021 there was a death in NH caused from the Johnson and Johnson vaccine due to a blood disorder, such as a blood clot. This was 35 days before the Johnson and Johnson vaccine was paused.
- Ms. Condon said, the public is not getting accurate information from the public health department.
- Ms. Condon told an anecdotal story about a nurse who worked remotely from home and was fired for refusing the flu shot.
- Ms. Condon said, other treatment options should be promoted. COVID is not a death sentence. It is essential to protect medical choice.

John Schmitt

- Mr. Schmitt testified in support of this bill.
- Mr. Schmitt said, we need an even stronger bill to protect against vaccine passports.
- Mr. Schmitt said, the German theory of disease is wrong. Disease comes from poor nutrition. Some examples are scurvy and polio.

My name is Kenneth Norton and I am the Executive Director of NAMI NH, the National Alliance on Mental Illness. I am a licensed Independent Clinical Social Worker in the State of New Hampshire with extensive experience in working in community mental health. I have served as a subject matter expert in the areas of mental health as well as suicide prevention for the US Substance Abuse and Mental Health Services Administration, the Department of Defense and the Veterans Administration. Closer to home I have served on numerous legislative committees and commissions. I have also served as a licensed foster parent and I have family members with mental illness as well as with co-occurring substance use disorders

NAMI NH takes no position in relation to the overall content of HB 220 with the exception of Section II (C) lines 12-14, which we currently oppose as written, as it neglects to address non emergency mental health admissions which are a key component of our mental health system of care.

Involuntary Emergency Admission petitions have a maximum stay of 10 days. The non emergency admissions are for anyone needing to be held for longer than 10 days as well as for other legal situations eg. people charged with certain crimes who have been found not competent to stand trial. These are the longer term commitments which are heard by probate court and can be for up to 5 years.

Our recommendation is that the bill be amended to include non emergency admissions under RSA 135-C 34-54. Suggested language is italicized below

(c) Supersede the involuntary emergency admission process pursuant to RSA 135-C:27-33; the non emergency admission process under RSA 135-C:34-54; the revocation of conditional discharge process under RSA 135-C:51; or involuntary treatment of patients compliant with RSA 135-C:57 III.

These are the reasons I will not be taking the COVID shots:

First some local stats: the COVID experimental vaccine began distribution in mid to late December 2020. On Dec 31st, Cheshire County (population 76,000) had had 7 deaths-with-Covid for the 10 months of 2020. In 2021 there have been 25 more deaths with COVID, as of March 31, just three months, with the experimental vaccine program in gear.

The Keene Sentinel <u>reported</u> on three congregant care facilities - each had a vaccine clinic on December 30th. At Court St 12 died in the month following the vaccine clinic. Court Street had about 85 residents. The Winchester facility reportedly had only 1 case during the 10 months of 2020, but an outbreak shortly following its vaccine clinic, The Main Street facility was more complicated, people coming and going, but also had an outbreak shortly following its vaccine clinic.

Please note that the VAERS system lists vaccine injury (and death) but reports at more than a week after the injury, and is voluntary. Very few vaccine injuries are actually reported and logged into VAERS. I couldn't find any of the 12 deaths above in screening for New Hampshire and a 12/30/20 injection date, see. Also note that there is little available liability or recourse for vaccine injury.

The Nuremberg Code (see Wikipedia) has 10 precepts for medical experimentation on human subjects. The first two are:

ONE: The voluntary consent of the human subject is absolutely essential.

TWO: The experiment should be such as to yield fruitful results for the good of society, *unprocurable by other methods or means of study*, and not random and unnecessary in nature.

We are being bullied by mainstream media to take the shots. I hear it every day on local radio, also from Governor Sununu. This contradicts the first precept which is generally taken to mean informed consent without coercion.

Maybe you didn't know that by taking the experimental vaccine you were agreeing to be a lab rat in an experiment. Surely you understand that a vaccine developed in eight months could not have tested its effects even just a few years out. Maybe you didn't know that the FDA has not approved them. The FDA has merely given EUA, emergency use authorization, figuring it would do more good than harm. The FDA did break rule 2 above in that it eliminated alternative therapies that have been successful elsewhere, *making them unprocurable* in most states. See also the Pfizer <u>document</u>, especially pages 123 to 125 regarding the absence in testing for pregnant and lactating women and contraceptive guidance; also the catchall exclusions on pages 37 to 39. Also, please note the word "healthy" in the title. (the link to the Pfizer document has died; the best substitute I can find currently is <u>here.</u>)

Lori Shibinette of NH DHHS signed an emergency <u>order</u> on April 3, 2020. This order separated patients, doctors, and pharmacists from life giving medications. This is a crime. The NH legislature should immediately cancel this order, cancel the State of Emergency, and relieve Shibinette of her duties. Shibinette's and the FDA's actions have violated principle 2 above.

In July 2020 Dr. Harvey Risch wrote <u>this</u> in Newsweek, explaining both the political situation and the life-saving remedy *available* to COVID patients before they become hospitalized. Other states began stocking the remedies. Then the FDA inhibited their use.

In Texas, it is still legal to effectively treat COVID patients before they are hospitalized. In testimony before a Texas Senate committee, Dr.Peter McCullough explains <u>here</u>. Dr. McCullough believes Texans have acquired 80% herd immunity. He believes, as I do, that natural immunity is superior to what injections can produce. He also believes that 85% of COVID fatalities could have been saved with early effective treatment, treatment he gives day-to-day in his clinics.

The Keene Sentinel has published my prior letters regarding Toney Baloney (Fauci), Donald Trump, and Joe Biden. I believe these three to be exceptionally venal conmen. There is risk for anyone in taking their recommendations; they all agree we should be taking the injections. Have you noticed there is no talk about costs, or more importantly future costs? Bill Gates has already said a third injection may be called for. Pharma has told Wall Street that prices will be increasing. There is too much profit in contrived death, war, cigarettes.

When COVID began I sat next to Rabbi Loewenthal at the synagogue. She saw the opportunity that we all would join together to fight COVID. I said, no, it is Amalek. Amalek was the tribe that attacked the Children of Israel as they were escaping Egyptian slavery. Like COVID, Amalek attacked from the rear, the stragglers, the old, the disabled, the infirm, those who had difficulty keeping up (economically, today). I could write much more on the various counter-productive frauds and deceptions (stay-at-home, lockdown, pcr test, Johns Hopkins inflated numbers in 2020, COVID with vs COVID because of, masking the healthy, masking children,...) that have occurred over the prior year. Gerhard Bedding, John-Michael Dumais, Johanna Laurie, and Becky Montrone have already done most of this in letters to the editor. Much more information can be found at <u>RiseupNH.org.</u> The headline of Gerhard's July letter said it well..."Why are we simply accepting this take?"

Lastly, I would like to leave you with two more videos; Dr. Lee Merritt discusses the fix we are in, war 5.0 <u>here</u>, please pay particular attention to her views on masking children. For a very deep dive into the virome and a hopeful future paradigm to replace our current medical system, see Dr. Zach Bush's 3-hour video What Happened Last Year <u>here</u>. Dr. Bush's analysis is different from what we have been force fed, his risk factors for COVID are attached.

I believe I became part of the herd immunity in the spring of 2020. The number of medical people (like Dr. McCullough) who believes we have already reached a high herd percentage is growing.

I hope this explains why I will not be taking the injections, which, like almost all medical procedures, bear risk. I hope this piece supports those with nagging doubts who feel bullied, by giving them the informed choice to which they are entitled.

Honorable Senators,

I am writing today to urge you to support HB220, which would protect health freedom and make sure that "Every person has the natural, essential, and inherent right to bodily integrity, free from any threat or compulsion that the person accepts any medical intervention, including immunization." Please know that I do not support any limitations on this right (as amended in the bill), and do not feel any private business has the right to compel a vaccine, either.

Here are some issues related to the so-called COVID vaccines that are not well known:

1. According to the British Medical Journal *and the manufacturers themselves) unlike traditional vaccines, the COVID vaccines are not designed for nor have they been scientifically proven to a) prevent infection or b) stop viral transmission. (1, 2) They are only designed to "reduce symptoms." Many doctors and scientists have been shouting about this not being a vaccine at all (it isn't, by any standard definition) (3). I would urge you to learn more and consider using your power to help initiate a lawsuit on behalf of the citizens of NH when you do.

2. The COVID vaccines are not FDA-approved as they are still in trials. They are only "authorized" under Emergency Use Authorization, which has a low bar for safety and efficacy. Under US and international law, no one can be forced to take this "vaccine." And it is against the Nuremberg Code. People should be free to take it or not take it, without public pressure or -- given the dangers -- any encouragement.

3. Traditional vaccines take between 7 and 10 years to develop for a very good reason. There is no way in God's Green Earth that any of the pharmaceutical companies can predict the possible side effects from this novel treatment that has taken less than a year to bring on line. Already the US Vaccine Adverse Events Reporting System (VAERS) has tallied, in relation to the COVID vaccines, 2,249 deaths and over 50,000 injuries, including some that are irreversible (4). Worse, VAERS is a passive and voluntary system and is notorious for underreporting events. Both the government and the mainstream press are not publicizing these deaths and injuries, and are dismissing any possible correlation with the vaccine without due process (like an independent investigative body). It is absolutely Orwellian, Mr. Doyle, and those of us who are looking at all the data are frankly aghast at what is being pushed on an unsuspecting public.

4. Vaccines are notorious for stimulating viral shedding, which is the off-loading of viral particles in large quantities for a period of time after having been vaccinated. I personally would not want to be anywhere near a person who was just vaccinated.

5. COVID-19 is not the killer that it was originally advertised to be. Over 99.75% of people survive, and that's in an atmosphere where highly effective medicines like hydroxychloroquine and ivermectin (6) (both of which can be taken prophylactically) have been suppressed and clinicians using them are still being censored. Estimates are that as many as 80% or more of patients could have been saved with early treatment -- yet this was precisely the opposite from guidance offered by

the NIH and CDC. (5) Plus, given that most age groups are less susceptible to SARS-CoV-2 than to the flu, most do not need the vaccine, which as noted above carries greater risk than the virus itself.

6. Finally, the vaccine issue (with such things as vaccine passports under consideration) will quickly become a way to separate people -- from resources, jobs, opportunities, travel, you name it. We do not want a two-tiered society under any circumstances. Already around half of US adults have said they would not take the vaccination, including a large number of healthcare workers -- they've been reading the studies and reports as well.

Vaccines are not the answer. Good nutrition, Vitamins C and D (7), zinc, melatonin, glutathione and other nutrients have been shown to be highly effective for both prevention and treatment. And there are literally dozens of other treatments that are also extremely effective. Those at high risk from COVID may want to consider the vaccine and should have the freedom to do so, but that is not most people.





I urge you to support H.B. 220 and protect NH citizens from discrimination for exercising their rights to refuse unwanted medical procedures, including vaccines. I am writing today on behalf of the Biotechnology Innovation Organization (BIO), a national trade association for the biotechnology industry, representing over 900 companies and academic institutions involved in the research and development of innovative healthcare, agriculture, industrial, and environmental biotechnology products. BIO membership includes vaccine developers and manufacturers who have worked closely with the public health community to support policies that help ensure access to innovation and life-saving vaccines for all individuals.

BIO and our member companies would like to express our **opposition to HB 220**, which would limit the ability to implement public health requirements for vaccinations. At its worst, this would very likely reduce immunization coverage in the state of New Hampshire, possibly resulting in an increase in cases of vaccine preventable diseases – the opposite of what we should be aiming for in the midst of a pandemic.

Vaccinations are held to high regulatory standards, making them one of the most effective and safe forms of preventive medicine. Vaccinations have led to a decrease or eradication of many significant infectious diseases such as polio, measles, mumps, and rubella. They are extensively tested for safety and efficacy prior to going on the market and continue to be monitored after introduction to the public.

The choice to delay or reject some vaccines entirely is not just a personal decision. When we choose to not receive vaccines or vaccinate our children, we put ourselves and others in our community at risk for serious disease. Putting others, such as those who are immunocompromised or too young to receive vaccines, at risk for vaccine-preventable disease arguably presents a challenge to their personal freedom to go to the store, to school, or anywhere else they come into contact with their community without the possibility of contracting a dangerous, preventable illness. Eliminating consequences for individuals who opt not to vaccinate only serves to transfer the consequences of not vaccinating to the broader community.

According to the New Hampshire government website, HB 220 is currently before the Senate's Health and Human Services Committee. I am writing in opposition to this bill.

It claims to be about "establishing medical freedom in immunizations," but this is misleading. The bill says (part III): "Employers may only mandate medical treatment or immunization as a condition of employment when a direct threat exists as defined in 29 CFR 1630.2(r)."

Employers have the right to set reasonable requirements for safeguarding their employees' safety. Walk into the restroom of any fast food restaurant, and you'll see that employees are required to wash their hands. This isn't an infringement of their rights. Dictating that employers may not set safety requirements is an infringement of the employer's rights.

When employees are working with vulnerable people, such as residents in nursing homes and patients in hospitals, a requirement that employees present the least possible risk is not just reasonable but morally necessary. No one has the God-given right to be given a job in such a situation and be exempted from conditions to protect the people they work with.

While I don't fully understand the "direct threat" case, it appears highly limited. It has to be applied on an individualized basis. Where it applies, immunization would seem to be too late (e.g., a person showing up for work with COVID).

HB 220 is NOT ABOUT FREEDOM. It's about legislators imposing their standards on private businesses, and it would interfere with the protection of employees' health. I urge rejection of this bill. Thank you for taking the time to read this.


