Dear Committee,

I am writing to express my support for HB 369-FN which changes the rules related to the use of physical agent modalities by occupational therapists. My support is based on the following:

- The previous certification requirement is redundant and unnecessary in that occupational therapy students are now trained in physical agent modalities, which was not the case when the original rules were created.
- In facilities where these modalities are used, they often require competencies for this type of skill as a matter of quality control.
- The professional ethical responsibilities related to competency and continuing education cover this skill area adequately for those who use these modalities.

As a NH licensed OT practitioner of more than 30 years and an educator of occupational therapy students, I am aware of the value of licensing of occupational therapists. It helps to ensure that qualified individuals are providing the needed service to those who need it. The change in the rules will not alter the quality of care or safety of our clients as it still requires that occupational therapists be trained in these techniques.

Dear Committee Members,

I intended to speak tomorrow regarding my opposition to bill HB369, however, I am unable to and cannot retract my submission from your website. Please accept my apologies, and my written position on the matter.

1. The proposed bill states:

I. An occupational therapist who is licensed under this chapter and who has been trained may utilize occupational therapy techniques involving ultrasound or electrical physical agent modality devices.

This wording is too vague and subjective, and potentially harmful for our practitioners and clients. It is my opinion that this language needs further clarification and objective guidelines regarding what constitutes adequate training.

Students typically do not receive adequate training in PAMs during OT school. Majority of clinicians receive "on the job" training rather than receiving higher level accredited education, and a majority of clinicians are not required to undergo competency testing at their facilities. The occupational therapy profession needs specific educational and competency guidelines to assure the qualifications of therapists using physical agent modalities. The consequences of improper use of PAMs include but are not limited to:

- skin burns
- muscle or bone burns
- heart attack
- eye damage
- changes in metabolic rate
- death

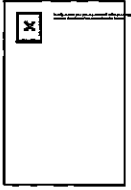
The state of NH currently requires OTs and OTAs to submit evidence of objective, continuing education hours, including 15 hours in electrical stimulation and 6 hours of ultrasound followed by completion of a signed supervision form in order to obtain a certificate which enables them to use PAMs in their practice. The NH PAMs certificate is evidence of our high standards, strong dedication to our clients, and a model to neighboring states. NH is the only state in New England to have educational and certification requirements regarding PAMs use. Clinicians from Massachusetts regularly participate in PAMs courses sponsored by a local NH business to gain further knowledge, skills and competency in performing PAMs.

In closing, I would like the board to consider my position of refining the language of this bill before eliminating the PAMs certification altogether. I would be happy to offer further suggestions for these language changes, given the opportunity.

To the members of the Senate Executive Departments and Administration,

I am writing to provide support in favor of HB 369 (to be heard on April 14th at 9:15am) which is the removal of certification by the Occupational Therapy Governing board for occupational therapy practitioners to utilize the physical agent modalities (PAMs) of ultrasound and electrical stimulation. This is a bill that is unanimously supported by the New Hampshire Occupational Therapy Governing board.

Once an Occupational Therapy Practitioner (an occupational therapist, OT, and an occupational therapy assistant, OTA) has completed the training in this area through academic course work or instructional course work and has demonstrated competency in this skill, it is within the scope of practice of occupational therapy to utilize PAMs on clients as appropriate as a means of treatment or intervention when a client is experiencing limitations in their occupational performance due to factors such as neurological issues or musculoskeletal issues. The use of PAMs on a client by a trained Occupational Therapy practitioner will allow for treatments and interventions that are very client centered and will help our clients with a return to a functional level that will allow them to engage in those tasks/occupations that are meaningful and purposeful to them.

Further certification/approval for the use of PAMs by the Occupational Therapy Governing Board beyond the training that the OT or OTA has received should not be needed. This can create more work for the Occupational Therapy practitioner as they need to supply the board with paperwork and forms resulting in a potential delay of the OT and OTA utilizing PAMs as mode/method of treatment for a client that could be very beneficial and advantageous for the client's return to function. Removal of this certification may provide indeterminable cost savings associated with the elimination of staff and Board time to process the requests of this PAMs certification.
