- 1 New Section; Right to Refuse a Consensual Search. Amend RSA 595-A by inserting after section 9 the following new section:
- 595-A:10 Consent to Search; Right to Refuse Consent.
- I. Before an officer attempts to conduct a search of a person, his or her vehicle, home, or other property, the officer shall inform such person of his or her right to refuse the search without penalty. If the person consents to the search, the officer shall first document the person's consent either in writing or by audio recording, and then may conduct the search. A person's refusal to consent to the search shall not be used to establish probable cause for a warrantless search or in an application for a search warrant, nor shall it be used to further extend any stop or interaction with a member of the public, provided all other lawful reasons for the stop or interaction have been concluded. An officer who fails to comply with the requirements of this paragraph, but proceeds with a search shall, as a matter of law, be conducting a search without consent.
- II. This section shall not preclude searches incident to arrest, those searches allowed under the United States Constitution for officer safety, or inventory searches of lawfully-seized property, including but not limited to vehicles towed in conjuction to the arrest of the operator.
 - 2 Effective Date. This act shall take effect 60 days after its passage.

 - I. A law enforcement officer may legally conduct a search of a motor vehicle without, a warrant under this chapter if the law enforcement officer expressly informs the operator of the motor vehicle that:
 - (a) The operator has the right to refuse to consent to a search;
 - (b) Any refusal to consent to a search shall not constitute a basis either for probable cause to arrest the operator or reasonable suspicion to detain the operator;
 - (c) The operator cannot be charged with any crime or violation for refusing to consent to a search; and
 - (d) The operator cannot be further detained for refusing to consent to a search.
- II. If the operator of a motor vehicle refuses to consent to a search, the law enforcement officer shall cease any further questioning concerning consent to a search.
 - III. A law enforcement officer shall document any consent to search either by the signature of the motor vehicle operator on a consent-to-search form providing notice of the provisions of paragraphs I and II at the time of the consent, or by means of a video and sound recording of the consent at the time of the consent. Such form or video and sound recording shall be retained until any criminal charge resulting from the consent to search is fully resolved.



Summary of testimony presented in support: Representative Roy

Representative Roy

- This simply requires officers, when they ask to search an individual's vehicle, to let that person know that they have the right to refuse that search.
- It is no longer the case that a lot of people understand what their rights are.
- NH already has something similar to this in the Miranda warning for an interrogation situation.

Gilles Bissonette (ACLU)

• SB40 is a similar bill, and arguably may be a little clearer to address this issue.

- Suggests replacing this bill with SB40's language with the amendment.
- Reiterates his SB40 testimony.
- It is important for people to know what their rights are.
- Senator Gannon asked if schools have exceptions to warrantless searches, especially in parking lots.
 - Does not know. In the interior of schools there is a looser requirement.
 Would defer to Mr. Buzz Scherr on that. There are places of exceptions for the warrant requirement.

Buzz Scherr

- Reiterates his SB40 testimony.
- Agrees with Mr. Bissonette that SB40 may be a little cleaner.
- Supportive of the DOC amendment.
- If a school is looking to search the property of a student, they have to have a lesser justification, reasonable suspicion.
- If the police or the school were to ask a student to search their locker, the student would have the right to refuse with the understanding that the authorities would not need as much justification to move forward with the search.

Summary of testimony presented in opposition:

Lyn Marie Cusack (Department of Corrections)

- When an individual comes on to prison grounds they are consenting to a search of their person and their vehicle, especially if the vehicle is unlocked and they are not in it.
- In the corrections setting if an individual refuses to be searched they are then asked to leave the premises and they may be put on a restriction that they cannot come back for a certain time.
- The bill as written says that if an individual refuses the search, they will not be penalized.
- Disallowing a person to come into the corrections setting could be seen as a penalty.
- The bill also requires that the Department would have to find and wait for the individual who belongs to the car, have them brought out, and ask search their unlocked car.
- The Department has no concerns about a locked car.
- However, with an unlocked car some residents in the transitional housing units know the car is present at the facility and will drop off contraband in it.
- There is implied consent already, as individuals are informed of that when driving on to the property.
- The Department does practice the way the current law is written.
- If an individual refuses to be search, the Department needs a way to continue to not allow them to be on the grounds.
- Senator Kahn asked if they provided this testimony to the House.

- o The Department was late in getting this to Rep Roy. Learned it had been put on the Consent Calendar in the House and it was determined that the Department should come to the Senate with this testimony.
- Senator Kahn asked if they could provide notwithstanding language for this.
 - o Believes Senator Carson has an amendment for that.
 - o Senator Carson noted that it is Amendment 1123s.

Neutral Information Presented:

Chief David Goldstein (NH Association of Chiefs of Police)

- Would support the notwithstanding amendment for the Department of Corrections.
- It is practice already to advise individuals that they have the right to refuse a search of their vehicle.
- There have been numerous legal decisions over the years to address this issue on the state and federal levels.
- It is best to leave it to the discretion of the courts to ensure due process relative to consent searches.
- Senator Gannon asked if there are other places besides a corrections setting, like police stations or government buildings, where there are exceptions to warrant requirements.
 - o There is no requirement at his department. In court buildings a person does have to go through metal detectors that may potentially lead to some sort of search. Does not think there is anything as definitive as what the DOC has brought up.

The New Hampshire Department of Corrections writes today with a concern relative to HB 485 as it is currently drafted. As such, we express opposition to HB 485 requiring law enforcement officers to inform a person of their right to refuse a consensual search, as written, and would request an amendment specifically exempting searches on NH Department of Corrections' grounds as more fully described below.

While the NHDOC does not take a position relative to local police officer's requirements regarding consensual searches, HB 485, as written, would have a deleterious effect on NHDOC's ability to control the potential introduction of contraband onto its grounds and facilities. As the law stands now, once a person enters the grounds or facilities of the NHDOC, they have impliedly consented to the search of their persons or property. Based on existing NH law and precedent the NHDOC Administrative rules state:

Cor 305.04 Visitor Requirement to Follow Rules.

- (a) All visitors who visit, or go on, or cross the grounds of a facility or area under the control of the NHDOC shall be subject to the rules established in Cor 305. Failure to follow such rules shall subject the visitor to removal from the grounds, arrest, or prosecution.
- (b) Everyone on prison grounds or in NHDOC facilities, regardless of whether they are a resident, visitor, staff, or anyone defined in some other category, shall be subject to search without warning of their vehicles, possessions, and persons pursuant to Cor 306.

Cor 306.02 <u>Contraband on Departmental Property Prohibited</u>. The possession, transport, introduction, use, sale or storage of contraband on departmental property shall be prohibited under the provisions of RSA 622:24 and RSA 622:25.

Cor 306.03 Searches and Inspections Authorized.

- (a) Any person or possessions on departmental property shall be subject to search to discover contraband. Searches shall be necessary to prevent the introduction of contraband into the facilities by-persons under departmental control and to prevent escapes, violence, and situations where violence is likely. Travel onto departmental property shall constitute implied consent to search for contraband pursuant to RSA 622:24-25, and RSA 622:39. In such cases where implied consent exists, the visitor shall be given a choice of either consenting to the search or immediately leaving departmental property. Nothing in Cor 306.03, however, shall prevent non-consensual searches in situations where probable cause exists to believe that the visitor is or has attempted to introduce contraband into a departmental facility pursuant to the laws of New Hampshire concerning search, seizure, and arrest or otherwise authorized by law.
- (b) All motor vehicles parked on departmental property shall be locked and have the keys removed. Correctional uniformed staff shall check to ensure that vehicles are locked and shall visually inspect the plain view interiors of the vehicles. Vehicles discovered to be unlocked shall be searched to ensure that no contraband is present. Contraband discovered during searches shall be confiscated as evidence and turned over to law enforcement authorities for use in possible prosecution.
- (c) All persons entering departmental facilities to visit with persons under departmental control or patients of the SPU, or staff, or to perform services at the facilities or to tour the facilities shall be subject to having their persons checked for contraband. In order to minimize the scope of such searches, items not needed for the visit such as purses, coats, and other baggage shall be left either in the vehicles or in the small lockers provided. All items and clothing carried into the institution waiting area shall be searched for contraband. Items left at the storage area shall be subject to inspection and search. Contraband seized shall be retained as evidence and turned over to law enforcement authorities for use in possible prosecution.

Under the existing state of the law, merely by stepping onto the property of the prison means we can conduct a search of a person or their property, including an unlocked vehicle. The language of HB 485 would change the state of the law, forcing NHDOC staff to ask a person on the prison property for consent to search their person or vehicle. While NHDOC never searches a person without his or her consent, this proposal under HB 485 would eliminate the Department's ability to intercept contraband by simply searching an unlocked vehicle.

NHDOC requests that the Legislature create a carve out for the Department in **HB 485**, similar to the one recently enacted in RSA 635:2 regarding criminal trespass, by inserting the following:

1 New Section; Right to Refuse a Consensual Search. Amend RSA 595-A by inserting after section 9 the following new section:

595-A:10 Right to Refuse a Consensual Search. Before an officer attempts to conduct a consensual search of a person, his or her vehicle, home, or other property, the officer shall inform such person of his or her right to refuse such a search without a penalty. Such refusal shall not be used in establishing probable cause for a warrantless search or in an application for a search warrant, nor shall it be used to further extend any stop or interaction with a member of the public, provided all other lawful reasons for the stop or interaction have been concluded. This section shall not preclude searches incident to arrest, those searches allowed under the United States Constitution for officer safety, on any grounds, lands, or parking areas of any state correctional facility or transitional housing unit operated by the department of corrections, or inventory searches of lawfully seized property, including but not limited to vehicles towed in conjunction to the arrest of the operator.

2 Effective Date. This act shall take effect 60 days after its passage.

In summary, we feel that the current state of the law, as it relates to searches in NHDOC property, is necessary and appropriate to ensure the safety and security of our grounds and facilities, and we would not want new law to be introduced that conflicts with or undermines that ability.

My name is Susan Cragin. I am the Merrimack County Register of Deeds. I would like to add a few comments about adding the Uniform Real Property Electronic Recording Act (URPERA) to New Hampshire's laws.

Terminology relating to electronic documents has changed, and laws developed years ago, such as URPERA, are not what they were when it was drafted. And so, a bill attempting to make New Hampshire's law "modern" by allowing "esignatures" and "electronic documents" is confusing at best.

(1) The legislation uses the term "electronic" signature when, I believe, it would be more appropriate to use the term "digital" signature.

Both "electronic" and "digital" signatures are fairly recent terms. "Electronic" signatures came out first, and are codified in New Hampshire law as follows:

NH RSA 294-E:2, VIII provides that an electronic signature may be represented by "an electronic sound, symbol, or process attached to or logically associated with a record and executed or adopted by a person with the intent to sign the record."

This of course is not a good definition, since only the "signer" knows what his "intent" was when he signed it.

More recently, the business world has realized that a tighter standard must be applied to certain documents, especially those where the agreements are long-term, and / or where the parties may not be able to face each other in court. Thus digital signatures were developed.

In land records, especially mortgages, a valid signature is important. A mortgage is between a regulated entity (bank) and an individual, who must sign whatever contract the bank offers. New Hampshire is a non-judicial foreclosure state, where foreclosure can be more or less automated. A homeowner should not be evicted based on a typed signature. But this is what may happen.

(2) Electronic documents and digital documents are not the same thing.

Your legislation refers to "electronic" documents, as "relating to technology having electrical, digital, magnetic, wireless, optical, electromagnetic, or similar capabilities." ... "Electronic document" means a document that is received by the register of deeds in an electronic form."

This definition is confusing.

My registry offers "e-recording" services, but the documents we currently e-record are merely snapshot copies of paper documents, with wet signatures. These are referred to as "digital documents."

"Electronic documents" are electronic with a visual representation, whereas digital documents are visual with an electronic representation.

Confused now? Think of the difference between making a snapshot of a book page, and reading that book on a web page.
