# **METHODOLOGY:**

This bill makes the following changes to the law governing the use of cannabis for therapeutic purposes (RSA 126-X):

- adds opioid use disorder to the list of qualifying medical conditions;
- allows "visiting qualifying patients" to purchase therapeutic cannabis at the New Hampshire Alternative Treatment Centers (ATC); and
- requires the Department of Health and Human Services to adopt rules regarding an ATC's verification of a visiting qualifying patient's registry identification card, or its equivalent.

Since changes to the definition of "qualifying medical condition" may increase the number of patients eligible for the Therapeutic Cannabis Program, the Department anticipates an indeterminable increase in state revenues based on additional application fees. The Department assumes that revenue received by the Therapeutic Cannabis Program will completely cover any costs that may result from the bill.





Summary of Testimony Presented:

# Representative Jerry Knirk, Carroll 3/Therapeutic Cannabis Medical Oversight Board

• Rep. Knirk said, this bill was originally an omnibus bill, but we found that the components are in other bills, so we left in two different parts:

- o The first part adds opioid use disorder (OUD) as a stand-alone condition for use for therapeutic cannabis use. It is very restrictive.
- o The second part allows visitors of NH who qualify for therapeutic cannabis to buy cannabis at ATCs.
- Rep. Knirk said, when dealing with qualifying conditions, a split recommendation is not useful. The therapeutic cannabis use medical oversight board (TCMOB or the board) has members with a variety of views and the board came to a consensus to support this bill.
- Rep. Knirk said, providers that treat opioid use disorder found evidence that cannabis use and THC triggers OUD. THC can also satisfy the need for opioids.
- Rep. Knirk said, the board does not support cannabis for OUD, but only the use for specialized guided treatment program.
- Rep. Knirk said, the board approved certification for cannabis for OUD when approved by certified addiction provider and while actively treating a patient with OUD. Appropriate treatment always requires a specific ratio of THC to CBD. Providers must closely monitor the patient.
- Rep. Knirk said, as for the second part of the bill, a lot of qualified patients from Canada
  and other states that stay in NH for an extended period of time are not able to purchase
  their therapeutic cannabis products in NH. This bill allows out of state individuals to
  purchase cannabis at a NH ATC.
- Rep. Knirk said, with this bill, individuals do not have to bring cannabis across a state or national boarder—which is illegal to do.
- Rep. Knirk said, an ATC must verify an individual's qualifying card.
- Rep. Knirk said, the TCMOB supports this bill.
- Sen. Sherman asked, the role of the certifying provider has always been just to certify and not prescribe. That first section, it does not put the provider in a prescribing role, does it?
  - Rep. Knirk said, I do not think so, but you are right that it comes right up to the line. At this point in time a provider can instruct a patient which product to get at the ATC. For example, a patient with a lung condition needs edibles instead of combustibles. It is not prescribing but there are rigid guardrails. We are looking to improve best practices, so providers do not certify and say goodbye to their patients. We want providers to take the active role of following up with their patients after certifying.
- Sen. Sherman said, I think what you are doing is saying who can certify rather than changing the process of certifying. One thing to keep in mind is the omnibus bill from the Senate did change re-certification to every three years.
  - Rep. Knirk, we did not want a primary care provider to give a certification and then send a patient away. We wanted to define very narrowly who can certify.

Sen. Bradley said, I know Rep. Marsh filed a minority report. Maybe we can ask him some questions.

Rep. Knirk later testified again.

• Rep. Knirk said, we explicitly said we do not support cannabis use in a widespread program for OUD. Our 2 most skeptical physicians treat addiction and came along on being in favor on this. We all share Rep. Marsh's concerns and that is why we came up

with rigid guardrails. A very small margin of people would qualify for therapeutic cannabis use for the treatment of OUD.

# Representative William Marsh, Carroll 8

- Rep. Marsh said, the reservations the minority have are the evidence seems to be debatable at this time. In some cases of cannabis use makes OUD worse.
- Rep. Marsh said, I support the rest of this bill.

# Lee Cooper, Administrator for Sanctuary ATC

- Ms. Cooper testified in support of this bill.
- Ms. Cooper said, allowed patients with OUD to be in the therapeutic cannabis program would expand our access to more qualified patients.
- Ms. Cooper said, out of state patients being able to purchase cannabis will provide local relief to those visiting our beautiful state.

# Michael Holt, Administrator of the Therapeutic Cannabis Program, DHHS

- Mr. Holt said Rep. Knirk already shared most of the same talking points.
- Mr. Holt said he supports visiting patients purchasing cannabis from NH ATC's. Currently NH law allows for limiting reciprocity for visiting card holders. NH Law allows out of state card holders to possess cannabis in NH, but not purchase cannabis in NH. Individuals cannot cross state boarders with cannabis. We know that cannabis is federally illegal. The law currently implicitly acknowledges cannabis will cross state boarders even though this is illegal. Reciprocity is limited. An out of state individual's qualifying condition(s) must be on NH list and patient must have a certifying doctor note for their medical diagnosis to show law enforcement.
- Mr. Holt summarized what this bill does:
  - o (1) Allows visiting patients to purchase cannabis from NH ATCs.
  - o (2) Makes explicit that a visiting patient cannot obtain cannabis from a NH patient or caregiver.
  - o (3) Clarifies and amends the definition of visiting qualifying patient to include our neighbors from Canada who have medical marijuana cards.
  - o (4) Removes the requirement of visiting patients to show law enforcement officers a copy of their doctor's certification of the medical diagnosis in order to be afforded the state's reciprocity.
  - o (5) And lastly, requires the department to adopt rules regarding the verification of a visiting patient's ID card prior to dispensing.
- Mr. Holt referred the committee members to his written testimony for amendment suggestions for two technical edits.
- Sen. Gray said, it seems to me that someone who could qualify in Maine or Massachusetts to get qualified, and then purchase in NH without one of the NH qualifications?

- o Mr. Holt said, this bill does not allow a NH patient to become qualified in another state. If someone qualified for the program under a condition, such as anxiety, in MA and that is not a qualifying condition in NH, then they would not be granted reciprocity here. Under this bill, they would be allowed that reciprocity here. This eliminates law enforcement from having to make clinical determinations in the field.
- Sen. Sherman said, we have pharmacists that fill prescriptions. They are not looking for indications for the prescriptions. There is an assumption the prescription is appropriate. If you have an out of state provider and out of state card, there is an assumption that state is appropriately using cannabis. It is like off-label use of medications. Is this something they would even have the ability to know: what the reason for the certification in the other state would be?
  - o Mr. Holt said, NH cards do not include the certifying diagnosis. That is personal and private health information. Sharing that with law enforcement seems odd. Out of state patients may not know the state law that limits their reciprocity here. Our patients do not keep their card on them, they send it to us at the department. Law enforcement officers have told us forcing patients to produce their card is virtually unenforceable. They will cease the cannabis until the patient can produce their card.
- Sen. Bradley asked, what if the OUD part were to have a sunset to see how it works for a period? How would that work administratively?
  - o Mr. Holt said, I would like that to be brought to the board. This is to be used seldomly. I would not recommend a sunset. The board could look at this, do a further evaluation, and then make a recommendation, but that would mandate extra work for them.

# Keenan Blaum, Prime ATC

- Mr. Blaum said he supports both parts of the bill
- Mr. Blaum said he has seen great results, although anecdotal, for patients treating their OUD with cannabis use.
- Mr. Blaum said, we have a number of patients that do not reside in NH year-round. They spend half a year in each place and really end up in a bind for the rest of the year.

# Grant Ellis

- Mr. Ellis testified in support of the bill in its entirety.
- Mr. Ellis said he does not know much about OUD part, but that he is in strong support for the out of state patient parts.
- Mr. Ellis said he is an out of state medical cannabis patient and that he is a homebound, disabled medical patient from MA with family in NH.
- Mr. Ellis said he is the president of medical cannabis coalition.
- Mr. Ellis said, without cannabis, patients are faced to take opioid based medications to treat their conditions.

- Mr. Ellis said, I do not believe a NH resident qualifies under a visiting patient in MA.
- Sen. Gray asked, if a college student had a condition approved in their state but not in NH, wouldn't that circumvent NH law?
  - o Mr. Ellis said, not for the first 90 days, but on the 91st day, yes. The bill defines a qualifying patient as a resident of the state for more than 90 days.

Senator Bradley.

HB 605 (hearing tomorrow in your committee) is the vehicle for all the TCP legislation that was laid on the table last session due to Covid. Only two proposals remain in this bill at this point; most of the other proposals found homes in stand-alone bills.

#### The two proposals are:

- (1) Adds opioid use disorder to the list of qualifying medical conditions for therapeutic cannabis. This is supported by the Therapeutic Cannabis Medical Oversight Board (TCMOB), and you will hear testimony from Rep. Jerry Knirk, as Chair of that Board:
- (2) Allows visiting qualifying patients (ie, registered cannabis cardholders from other states) access to NH's ATC dispensaries.

I'm sorry this is coming to you so late, but I've identified the need for two technical edits to make the visiting qualifying patient provisions of this bill complete. I've attached the draft language here, and will mention the need for a technical amendment in my testimony tomorrow.

I wanted to give you a heads-up on this, albeit late. And I would also request your assistance in presenting this amendment to the Committee before the bill is exec'ed.

#### HB 605, proposed amendment (visiting qualifying patients)

- 1. Use of Cannabis for Therapeutic Purposes; Protections. Amend RSA 126-X:2, IX(c) to read as follows:
- (c) Deliver, transfer, supply, sell, or dispense cannabis and related supplies and educational materials to qualifying patients who have designated the alternative treatment center to provide for them, to designated caregivers on behalf of the qualifying patients who have designated the alternative treatment center, to visiting qualifying patients, or to other alternative treatment centers.
- 2 Use of Cannabis for Therapeutic Purposes; Alternative Treatment Centers. Amend RSA 126-X:8, XV(b) to read as follows:
- (b) An alternative treatment center or alternative treatment center agent shall not dispense, deliver, or otherwise transfer cannabis to any person or entity other than:
- (1) A qualifying patient who has designated the relevant alternative treatment center; or
  - (2) Such patient's designated caregiver; or
  - (3) Another alternative treatment center[-]; or
  - (4) A visiting qualifying patient.

HB 605 has two parts. The first part adds opioid use disorder (OUD) as a standalone qualifying condition for the use of therapeutic cannabis with very restrictive guardrails set by the Therapeutic Cannabis Medical Oversight Board (TCMOB) and the second part allows patients visiting New Hampshire who have qualified for the use of therapeutic cannabis in their home state or Canada (which has a nationwide therapeutic cannabis program) to purchase therapeutic cannabis at New Hampshire ATCs.

TCMOB is composed of the Chief Medical Officer of DHHS, a qualifying patient representative, a clinical representative from an ATC and ten medical providers from various fields, charged with the task of advising the therapeutic cannabis program on medical issues, including qualifying conditions. When dealing with qualifying conditions, I strive to lead the board to a consensus as split recommendations do not convey much useful advice to the legislature. This is difficult given that the board is composed of individuals with very differing views of the role of therapeutic cannabis, including providers who initially opposed the therapeutic cannabis program. When we come to consensus, you can be sure we thought of every option.

TCMOB, which includes providers practicing addiction medicine, exhaustively reviewed the literature on the use of therapeutic cannabis in treating opioid use disorder. There is evidence for the use of therapeutic cannabis in OUD, but such use is complicated since THC stimulates reward centers and therefore can exacerbate OUD. However, CBD, the other major cannabinoid in cannabis, has been shown to help with symptoms of craving and withdrawal. Given that the use of therapeutic cannabis in OUD is complicated, TCMOB does not support the use of therapeutic cannabis for OUD except when used as part of a specialist-guided treatment program for OUD. By a 9-0 vote, TCMOB approved certification of a patient for the use of therapeutic cannabis only when certified by a board-certified addiction medicine or addiction psychiatry provider, who is actively treating the patient for OUD, to treat associated symptoms of craving and withdrawal. Such a highly specialized provider will have the skills to give specific instructions to the ATC regarding the

ratio of CBD to THC in the product to be dispensed and closely monitor the patient.

The second part of the bill allows patients visiting New Hampshire who have qualified for the use of therapeutic cannabis in their home state or Canada (which has a nationwide therapeutic cannabis program) to purchase therapeutic cannabis at New Hampshire ATCs. There are many qualified patients from other states or Canada who stay in New Hampshire for extended times vacationing or at a second home or as students. This bill will allow visiting qualifying patients to purchase therapeutic cannabis at a New Hampshire ATCs so they do not need to bring cannabis across state or international borders which is illegal to do. The therapeutic cannabis program will develop rules for the ATCs to assist them in verifying a visiting qualifying patient's registry identification card or its equivalent.

#### Explanation to Enrolled Bill Amendment to HB 605-FN

- This enrolled bill amendment renumbers RSA provisions to incorporate changes made by 2021, 46:2 (HB 89-FN) and 2021, 47:3 (HB 163-FN). The enrolled bill amendment also inserts contingencies to incorporate changes made by SB 38 and SB 162-FN of the 2021 general legislative session if they become law.

#### Enrolled Bill Amendment to HB 605-FN

Amend section 1 of the bill by replacing lines 1-3 with the following:

- 1 New Subparagraph; Use of Cannabis for Therapeutic Purposes; Definitions. Amend RSA 126-X:1, IX(b) by inserting after subparagraph (5) the following new subparagraph:
  - (6) Opioid use disorder, with the following restrictions:

Amend section 6 of the bill by replacing lines 1-3 with the following:

- 6 New Paragraph; Use of Cannabis for Therapeutic Purposes; Departmental Rules. Amend RSA 126-X:6 by inserting after paragraph VI the following new paragraph:
  - VII. The department shall adopt rules, pursuant to RSA 541-A, regarding an alternative

Amend the bill by replacing all after section 8 with the following:

9 Public Health; Use of Cannabis for Therapeutic Purposes; Definitions; Alternative Treatment Center. Amend RSA 126-X:1, I to read as follows:

## ENROLLED BILL AMENDMENT TO HB 605-FN - Page 2 -

- I. "Alternative treatment center" means a domestic business corporation organized under RSA 293-A, a domestic limited liability company organized under RSA 304-C, or a not-for-profit voluntary corporation organized under RSA 292 that is registered under RSA 126-X:7 and that acquires, possesses, cultivates, manufactures, delivers, transfers, transports, sells, supplies, and dispenses cannabis, and related supplies and educational materials, to qualifying patients, [and] designated caregivers, other alternative treatment centers, and visiting qualifying patients.
- 10 Contingency. If SB 38 of the 2021 general legislative section becomes law, section 9 of this act shall take effect 60 days after its passage and section 2 of this act shall not take effect. If SB 38 does not become law, section 2 of this act shall take effect 60 days after its passage and section 9 of this act shall not take effect.
- 11 Use of Cannabis for Therapeutic Purposes; Protections. Amend RSA 126-X:2, IX(c) to read as follows:
- (c) Deliver, transfer, supply, sell, or dispense cannabis and related supplies and educational materials to qualifying patients, to designated caregivers on behalf of the qualifying patients, to visiting qualifying patients, or to other alternative treatment centers.
- 12 Use of Cannabis for Therapeutic Purposes; Alternative Treatment Centers. Amend RSA 126-X:8, XV(b) to read as follows:
- (b) An alternative treatment center or alternative treatment center agent shall not dispense, deliver, or otherwise transfer cannabis to any person or entity other than:
  - (1) A qualifying patient; or
  - (2) Such patient's designated caregiver; or
  - (3) Another alternative treatment center; or
  - (4) A visiting qualifying patient.
- 13 Contingency. If SB 162-FN of the 2021 general legislative session becomes law, sections 11 and 12 of this act shall take effect at 12:01 a.m on the effective date of SB 162-FN and section 7 and 8 of this act shall not take effect. If SB 162-FN does not become law, section 7 and 8 of this act shall take effect 60 days after its passage and section 11 and 12 of this act shall not take effect.
  - 14 Effective Date.
    - I. Sections 2 and 9 of this act shall take effect as provided in section 10 of this act.
    - II. Section 7, 8 and 11, 12 of this act shall take effect as provided in section 13 of this act.
    - III. The remainder of this act shall take effect 60 days after its passage.
