Summary of testimony presented in support:

Representative Ross Berry

- This is a bill which would move the state Primary back into June.
- New Hampshire's late Primary has become an incumbent advantage.
- It is one of the last Primaries in the Country next to Rhode Island.
- One of the biggest problems is the disadvantage for a candidate who has to devote time and money to win the Primary, running against an incumbent who did not have to.
- Currently, there is only 6 or 7 weeks for the winner of the Primary to shift gears and campaign for the General Election.
- Moving the New Hampshire Primary back to June would put us in the middle of all Primaries held Nationally.
- The House amended the bill to allow the Secretary of State to move the primary date forward if redistricting is done.
- A UNH poll showed that this bill will have zero effect the number of people voting in the Primary.
- Voters should have the opportunity to hear from both sides equally, Democrats and Republicans.
- People have raised the issue that this change would move the filing period into the legislative calendar.
- He does not believe that will be a hardship for legislators.
- Primaries for incumbents are not an issue and do not affect them as it does other candidates.
- Senator Soucy asked if it is his intention that the Secretary of State have discretion over when the filing period would be.
 - Representative Berry replied that the SoS currently has the ability to move the filing date and they only tacked on the ability for him to move the Primary date. It is their intention to give him the discretion over both dates.
- Senator Soucy asked if there was any discussion about having the primary in August or another date.

- Representative Berry replied that there was some discussion about August but they do not believe August would accomplish the goal of giving all candidates equal opportunity in campaigning.
- Senator Gray asked if he would be opposed if the Committee moves the effective date to after the next Primary.
 - Representative Berry replied that they would probably still pass it but he would ask that they not do that.
- Senator Gray commented that there may be some complications this year due to redistricting and they would be resolved by changing the effective date.
 - Representative Berry replied that they believe this bill is good for the voters and they want it effective as soon as it can be. The last time New Hampshire changed the Primary date was in 1910.

- He believes this is a good bill.
- This bill has an effect on candidates filing by nomination papers.
- RSA 655-43 specifies the filing deadlines relative to the Primary.
- This makes the declaration of intent for a Primary due by April and the nomination papers would be due before the Primary he believes that may be too early.
- His suggestion would be to amend RSA 655-43 such that the declaration of intent would be due during May or June before the Primary and have the nomination papers due in August.
- This will ensure that any losing Primary candidate would not be able to file this way and the nominating papers would be submitted in ample time to prepare General Election Ballots.

Senators Birdsell & Soucy,

I wanted to reach out to you since you two will be working on some of the problems with HB98.

Normally, I would have testified against this bill; however I'm dealing with some health issues and have to take a year away from lobbying.

In addition to the April filing deadline being struck down in Anderson v. Quinn, 495 F. Supp. 730 (D. Me. 1980) which was affirmed by the 1st Circuit, Campbell v. Hull, 73 F. Supp. 2d 1081 (D. Ariz. 1999) found "no court has upheld a deadline for filing nominating petitions for independent presidential candidates as early as Arizona's June 27th deadline." In that decision, the court cited Fulani v. Lau, CIV-92-535-ECR (1992)which struck down Nevada's June 10th filing deadline.

The unconstitutionally early filing deadline for new parties, as well as minor party & independent candidates will most assuredly lead to a lawsuit. This deadline could instead be set as the first Wednesday of August to have petitions turned into the City & Town clerks, with certified petitions being due to the Secretary of State on the first Wednesday of September (see RSA 655:41 & 655:43). The current deadline of 5 weeks prior to the primary has the deadline for turning in petitions at either the first or second Wednesday of August, with collected petitions then being due to the SOS on the first Wednesday of September.

This modification would essentially keep the petitioning window at the status quo, while no longer having the deadline for petition submission being tied to the date of the primary.

One additional issue is the April filing period for all candidates. This requirement would especially burden minor party Presidential campaigns, since most political parties nominate candidates after this April deadline. The Green Party regularly nominates their Presidential ticket in July or August; while the Libertarian Party regularly nominates its ticket over Memorial Day weekend. Since NH does not have candidate substitution; this April filing period would essentially prevent the two largest minor parties in the US from having a Presidential candidate on the ballot in NH.

I hope this information has proven useful, and I look forward to your reply.

I am the elected Town Clerk/Tax Collector for the Town of Merrimack. I am reaching out today to respectfully request you find HB98 – Date of the State Primary Election, Inexpedient to Legislate or seek amendment with an alternative date.

I just became aware that this bill, if passed, would change the date of the NH State Primary election from September to the last Tuesday in June. The proposed date is what concerns me with this bill.

As a clerk in a combined position with a fiscal year end, I am deeply concerned about having an election during the last days of the month and on possibly <u>the</u> last day of the month, last day of the fiscal year, and the day before property tax bills are due. <u>The last week of June is the single busiest</u> <u>time of the year for my office outside of a presidential election year</u>. Due to the sheer increase in volume of work an election presents, having an election during this time frame will prohibit me from conducting the month end and year end balancing and reporting that is necessary and required to be done annually on June 30th. Without completing the month end and fiscal year end processes, I will be unable to open my tax books and collect property taxes on July 1st, which is the due date set forth in the statutes. This will result in a backlog of payments needing to be processed and could affect cash flow to municipalities.

In reaching out to my counterparts, I have found many are not aware of the implications of this bill which not only impacts town clerks, but rather significantly those in a combined town clerk/tax collector position.

I thank you for your time and consideration and hope you will find this bill ITL or offer an amendment for an alternative date.

HB98 proposes to move the State Primary Election from September to June.

While quite a few states do schedule their primaries in June, no state in New England does so due to conflicts that arise with schedules for New England town meetings. In NH, towns can hold their meetings in March or April or May.

During those months, supervisors of the checklist are meeting for purposes of voter registration, as required by law, and voter registration is being closed at different times across the state during those months so that checklists can be prepared for town meetings.

This bill requires the Supervisors of the Checklist to hold a session for the change of registration of legal voters on the Tuesday before the first Wednesday in March. However, checklists for March town meetings close <u>before</u> this date and town meetings are held <u>after</u> this date.

For example (from the Secretary of State's 2020-2021 NH Political Calendar):

In addition, state law currently allows voters to affiliate with or disaffiliate from a party the day prior to the start of the filing period. In this bill, the filing period begins on the fourth Wednesday in April (April 22 in 2020), while the last day to declare party affiliation is seven weeks earlier (March 3 in 2020). This will be a great inconvenience for registered voters and for political committees trying to recruit candidates to fill party slates.

Finally, due to the late release of the US Census redistricting population numbers, seven cities will need to hold special elections in the spring to amend ward lines in their city charters: Keene, Somersworth, Rochester, Laconia, Claremont, Lebanon, Dover, and Franklin. The charter amendment process can take four months or longer once new ward lines have been proposed. This delay will impact the House's ability to draw floterial district boundaries prior to the start of the proposed filing period in March. The proposed registration and filing deadlines simply can't be met for 2022.

HB98 still needs work and is not ready for passage.

Also, this bill interferes with town elections. I believe a better alternative would be to just move the primary date to first Tuesday in August. See my bill HB97.

Governor's Veto Message Regarding House Bill 98

By the authority vested in me, pursuant to part II, Article 44 of the New Hampshire Constitution, on July 30, 2021, I have vetoed House Bill 98, relative to the date of the state primary election.

I agree with the Secretary of State that House Bill 98 creates more problems than it solves. House Bill 98 would change our state primary from its current September date to the first Tuesday in August, moving our primary election - and the campaign season for that election - into the middle of the summer. This is a time when many Granite Staters are enjoying their vacations and are far less likely to be involved in the electoral process. This change could lead to depressed voter engagement in the election and reduced turnout. Furthermore, moving the primary election to the summer could hurt the ability of municipalities to recruit poll workers and Election Day volunteers, greatly exacerbating a challenge that many municipalities are already struggling with.

Some advocates of this legislation point to the supposed challenge of election officials meeting the deadlines to send absentee ballots to members of the military or other overseas Granite Staters. It is important to note that New Hampshire has never failed to meet those deadlines set forth by the Federal Government. In fact, according to the Secretary of State, New Hampshire is one of just a few states that have never been sued for such a failure. However, House Bill 98 gives the Secretary of State nine fewer days between the end of the filing period and the primary day elections to make and print ballots. Although partially intended to ease time constraints on the Secretary of State, this bill could add burdens onto their process.

New Hampshire's elections are the gold standard for the rest of the country, and our primary date schedule has stood the test of time. Our Secretary of State, who has run our state's elections for 45 years, believes this legislation will add significant challenges to a process that does not need to be changed.

For the reasons stated above, I have vetoed House Bill 98.
