Summary of testimony presented in support:

Senator Gannon (provided written testimony)

- Presented Amendment 0246s that clarifies the definition.
- The main intent of this bill is that law enforcement is having problems with people smoking marijuana while driving.
- This legislation is modeled after NH's Open Container Law.
- If a person is buying from a therapeutic cannabis center and it is a sealed container that is fine, the problem is if it is unsealed.
- This will require an unsealed container to be placed in the trunk or the furthest place from the wingspan of the driver.
- This will make the roads safer.
- Senator Kahn asked what a seal looks like on these containers.

- o When you buy cannabis at a therapeutic cannabis center there is a visible seal. Once that label is damaged, law enforcement would count that as being open. Law enforcement is testifying and can give more accurate examples.
- Wants to clarify the bill with another amendment that states this is only
 applicable when a car or boat is being used/in motion. Not when it is parked or
 at home in the driveway.

Chief Andrew Shagoury (NH Chiefs of Police)

- Has seen this come up in a number of cases himself.
- This is about public safety in vehicles.
- This is important when talking about how marijuana affects people.
- Edibles especially take a while to take effect on an individual.
- Over 50% of the market is edibles.
- Someone could pass a sobriety test after consuming marijuana, but down the road they become impaired when it takes effect.
- MA, VT, WA, OR, OK, NV, CO, IL, and CA all have very similar laws as this.
- 16-17-year-olds are caught in the middle of this, if they have a personal use amount they are actually transporting and could lose their license for 60 days.
- This will provide a better tool to use in these situations.
- Supports Amendment 0246s.
- Senator Gannon asked if a vehicle or boat being turned on would constitute as being in motion.
 - o Not sure if this applies to boats. It does cover OHRVs. This is primarily focused on public ways. Private driveways and residences would not apply. The cases he sees this applying to is someone driving down the road and they get stopped. Would be happy to work on some language on this. The language is mirrored exactly after the Open Container Law.
- Senator Kahn asked if the word 'operating' is in this.
 - o It says, 'no driver shall transport, carry, or possess or have any marijuana'. It is the same as the Open Container Statute. It is meant to target private vehicles. Before the Open Container Statute was in place, an officer would stop someone who has been drinking but the passenger is holding it and claims it after just passing it from the driver. The problem with using the word 'operating' is that officers have to catch the driver with it.

Summary of testimony presented in opposition: None

Neutral Information Presented:

Michael Holt (Department of Health and Human Services)

- Requested the technical correction in Amendment 0246s.
- This bill adds the proposed open container prohibition to the alcohol or drug impairment statute, RSA 265-A.

- Believes the intent of the bill is to apply to the general public.
- However, the statutory cite in the bill on the definition of marijuana, references to the definition in the Therapeutic Use Cannabis law, RSA 126-X.
- If the bill is intended to apply to the public, a more accurate citation would be the definition in the Controlled Drug Act statute, RSA 318-B.
- The way it is currently written may be confusing as to the bill's applicability, suggesting it only applies to therapeutic cannabis patients and caregivers, not the general public.
- If a container is dispensed from an alternative treatment center, program rules require that they have a tamper proof seal, a shiny sticker. Those seals are applied at manufacturing facility.
