Dear Committee Members,

My name is Keriann Haruza. I am not yet a resident of NH, (for full transparency). I currently live in Connecticut. My husband and I are making all the arrangements to move out of Connecticut in the next 2-3 months. My husband is a physicist-turned-engineer who works for ASML in Wilton, CT. I am a full-time homeschooling mother of four.

I am writing because NH is our intended destination-home, though, and the bills currently in consideration have enormous impact on our family. Our dissent with vaccines started when we had our first child almost ten years ago; we investigated the decisions we made medically for each of our children in great detail, as many others did and do. But in our research we discovered that many "essential" vaccines on the schedule were intimately connected with abortion-based research and/or production; over time, we found that the trials on many of them were moreover conducted in utterly reprehensible ways, where consent was impossible by the participants (as with the Willowbrook scandal, and the Hep-A vaccine, for example, or the many many problems with pre-Roe abortion as a coerced procedure done in conjunction with sterilization of "the feeble-minded," as the eugenics aspect of public health policy and ethics lasted for decades; some might argue it is still present.) As for the argument that this has never gone away, Leonard Hayflick's "water bag method" of abortion and subsequent harvest of the baby's parts, apparently alive, has been utilized at least as recently as 2015, with the development of the Walwax cell strain. That strain, created in China, with nine abortions of candidates and the final person murdered and utilized being one little girl of between twenty and thirty weeks gestational age, still could obviously be a result of coerced abortion because it was China and significantly because in their description of methodology they specify the Hayflick water-bag method, traditionally used to abort and sterilize simultaneously, and is/was frequently employed in government-mandated abortions ...but coerced or not, they removed and dissected babies. That is simply the fact. Over 1,550 cell strains created from dozens to hundreds of abortions for each one, exist today.

Our consciences, as informed by our Christian faith, are in utter condemnation of these actions, and participation in their outcome absolutely impossible.

I do not write about our personal convictions in the hope that anyone on the committee may be convinced similarly--if facts and ethics could persuade, there would be enough dissent to have changed this heinous practice of abusing children and other innocent minorities in medical experimentation long before COVID. But I do write, asking you from the bottom of my heart to consider HB1003 with an open mind. When my husband and I first had children, pediatricians who were willing to admit us as patients were easy to find. He was in graduate school in Rochester, NY; it was no pro-life, pro-freedom hub; but still, we found care. When we moved to Missouri, we also found care providers. After moving to Connecticut, however, we were shocked to find that while religious exemptions to vaccines existed legally (at the time), actual care for unvaccinated children was virtually non-existent. We pursued practice after practice; the crazy part was, here you aren't ever even allowed to talk to the doctor, until you have filled out all the paperwork in their system and compromised your child's privacy, for which doctors and state alike are totally unaccountable, all to be told "No, we won't take you." It has been several years, and we

have moved around to several communities within this state and tried numerous times, yet our care has been relegated to telehealth appointments through our Christian costshare and urgent care centers. I cannot elaborate enough on how much this has been a difficulty over the years, and an increasing worry for my children. I know that to someone not similarly convicted the dilemma is nonexistent, but I must ask you to consider that to those of us whom it is morally tainted, it is morally tainted. Taking them is not an option. When this part of the equation is taken seriously, as it must be for religious exemptions to be remotely meaningful (or indeed any reference to religious liberty at all), the result of being denied from practices becomes terribly clear. In fact, doctors have been under a great deal of pressure to NOT provide care to unvaccinated patients from their own boards, and those that do so openly get written up and vilified by newspapers, publications, and lobby groups, to the extent where they cannot risk openly saying they accept unvaccinated patients, which makes them still more difficult for the unvaccinated to find.

This gross lack of care for any population of children, whatever you do or do not agree with in their religious, cultural or ethnic features, does not bode well for the future of healthcare ethics as a whole. I do not agree with the veganism of some of our Hindu friends from Rochester; I cannot imagine denying their children access to medical care because I didn't agree with their beliefs about meat. One can also argue that there is a negative risk to child-bearing and growth of young children, from a lack of protein and iron and other nutrients. Care providers generally tend to agree that it is difficult to achieve a healthy pregnancy or childhood for a vegan. But no one has yet assumed that it is the role of the provider to banish vegans until they change their convictions. This is not a matter of whether you agree with someone else's conscientious convictions: this is the next step, of whether it is the majority's role in society to penalize those with whom the majority does not agree. I speculate perhaps in this region of the country with it's early heavy Puritan influences, the normalization of forcing minorities out of society and driving them out of existence by methods largely today regarded as genocidal (such as forcing Quaker children into Puritan public schools, there to deliberately force them to reject their family convictions and heritage, and charging so heavy financial penalties that it was nearly impossible for Quakers to support their own meetings or schools or structures in addition to the ones created by the Puritan communities around them, which all were forced to support....a feature still present in public schools today), is an old cultural feature that may be hard for some to objectively consider.

Whatever the old or new cultural influences guiding this practice, the fact remains that denial for care to our children is our primary and most essential reason for fleeing the state we are currently in the process of leaving (Connecticut). We have already begun to search for practitioners in NH; we started with DPCs, thinking our chances of being accepted would be higher. We have already discovered two, however, who blatantly state on their websites that vaccination is required to be admitted as their patients. My greatest fear, is to throw everything financially into removing us from the situation we find in Connecticut, only to find ourselves "out of the frying pan and into the fire," somewhere else. It shouldn't be this difficult. Practitioners already have to have a plan in place, an alternative, for those who do not receive vaccines for medical reasons; and religious objectors have existed since the inception of vaccines as well, so it has been at least a century or so for thinking about other ways of handling the risk. In fact I cannot praise highly enough, two of our care providers in Rochester, who simply kept unvaccinated parents abreast of any sort of infectious outbreak that occurred, and advised as to what we could do. It doesn't happen terribly frequently, and is usually associated with international travel.

I am sure practitioners dislike the idea of being responsible to treat or manage cases of illnesses which are unfamiliar to them (standard treatment of measles in the US is grossly outdated by comparison with say, the EU); but then, I would guess it is easier to tell a vegan they ought to eat meat than to advise them from within the confines of their convictions, as well. This is the very heart of what makes an advisory role, like a doctor, so difficult to begin with. It is not unlike parenting adult children; you advise, and you may be positive you are right, but it is in the end

your child's life, and it is a poor parent who casts off their child with a shrug anytime they don't do exactly what you "advise" (at which point "advice" becomes coercion.) While I am empathetic to the difficulty, I am not empathetic to any authority figure who takes on a coercive role in order to shortcut to what they believe to be the paramount outcomes, by bypassing genuinely free consent. I have been listening to the hospital board reps and practitioners testifying on a lot of these bills in NH, trying to keep abreast of what we may face after moving, and what strikes me most is that they refer to "consent" frequently as "making people comfortable" with "the decision." (I added the emphasis.) They do not admit that there is more than one choice; which is already a statement of coercion. Consent, in their rhetoric, means just coaxing or convincing people to settle down about the decision that has been made for them by someone else. Legally however, and morally or ethically, this is not what the terms "consent" and "choice" refer to. There is certainly plenty of case law that refers to consent, and it has generally been ruled that the term "consent" is only meaningful when the person granting it has not been compelled by the threat of losing something necessary to the ordinary course of life--whether their jobs, or their medical treatment, and so on, this cannot be referred to as meaningful consent. Anyone can take pause and consider the rational definiton of the term "consensual" with regard to the crime of rape, and know that the medical field's testimonies are in the moral and definitive wrong over this. Maybe intentionally, and maybe not. I wouldn't assign intent; only God sees the heart. But outcomes and methods matter, whatever the intent. Law cannot examine the heart, only the fruit of the behavior. And the attempt to wrest medical decision making out of the moral or physical scope of the person themselves, and place it instead in the hands of the medical community, has born very bad fruit before and is bearing terrible fruit now.

In most eras, this would be called persecution. But each generation's persecution looks justified in its own eyes, in a way that history does not permit us, and it is my experience as one of those affected, that this is such a moment. Please consider the bill HB1003, this week. It impacts a minority in the immediacy; but it impacts everyone in the long run. Everyone is a minority in at least one respect or feature of their lives--everyone is unique from the majority in some way or other. Please think of that feature in your own life, whether it be religious, or cultural, or something else; and vote as you would if your own children were denied care on the basis of that feature. Please.

Importance: Normal

Dear members of the committee,

Close to half of all prescriptions are for uses of drugs that are off label. That is done for a number of reasons. For a use to be on label there must be significant testing done at great expense for each new use. Even if it is widely known in the medical community that the drug is useful for such a use it is unlikely that such testing will be done because there is no money in it if the drug is off patent or the number of potential users of the drug is small.

Once the FDA OKs a drug doctors have been able to use it for the treatment of any health problem on or off label. That is as it should be. While our understanding of the human body and disease processes has improved greatly there is much that we don't know. Much of medicine is trial and error guided by what is know and a doctor's judgement. Not only is there much that is not known in general but the way a disease progresses in each individual varies as does the way they respond to particular drugs.

This ongoing experimentation, with the patients informed consent, leads to rapid discoveries of effective treatments. That information is shared in the medical community to the benefit of others. This method of discovery is particular important for a widespread serious medical condition that develops relatively quickly. It is much quicker to respond to a rapidly changing situation than centralized trials and decision making.

Doctors and their patients should not be constrained by centralized authorities. At best they can respond too slowly. If such authorities make a mistake that can have serious effects for many people since their recommendations will be quickly be used widely. Individual or small scale informal trials are safer for society. Both benefits and risks of treatments can be discovered quickly with risk to a limited number of people. There is also the risk that the central decisions may be influenced by financial or political concerns. Again the damage caused by such errors could cause harm across the nation and correcting such errors is very difficult because reputations and vested interests become on the line.

This bill is an effort to fix these sorts of problems in one area and return control to individual doctors and their patients. Please support this bill.

Dear Representatives,

I am writing to urge you to support HB 1003. I unfortunately was unable to attend today's hearing in person but would have enthusiastically done so with my husband and kids if possible.

I am a resident of NH today because of the loss of religious and medical freedom in New York State. Prior to that experience, one of my first experiences as a mom was being kicked out of our very first pediatrician's practice in 2006. My daughter was just a few months old and had already spent more than a month in a NICU receiving a variety of medications, interventions, food formulas, and procedures every day. I was of course grateful to the care providers that helped her when she first arrived on the planet.

Not long after however, during a follow up visit, an MD verbally threatened to kick us out of her practice if I did not adhere the infant vaccination schedule which we were behind on. I discussed my concerns and beliefs with the doctor, and she seemed to understand them, though clearly wasn't celebrating. I attempted to engage in a truly informed consent type of conversation so these issues could be addressed by our physician in a meaningful way. There was no time for that. One-page fliers were handed to me that offered few details.

At the next well visit, the issue was raised again and this time the doctor was more insistent about following the schedule. I again attempted to have a meaningful dialogue beyond scheduling and deadlines. About a week later I received a written letter indicating our family was no longer welcome in their office and that we must find another provider. The letter was not personal to me or my family. It clearly indicated that the practice was no longer accepting any family who failed to give their infants or children every vaccine on the CDC schedule, on time. It was stated, basically, "How can we help you if you don't take all of our advice and follow our instructions?"

Luckily, we were able to find a better provider who respected our questions and perspectives. That new provider, several years later, began disallowing new families who sought to follow alternative vaccination schedules or chose to not vaccinate their babies entry into their practice. Fast forward a few more years, and this has become a very common practice across a variety of settings, medical modalities, and states. The insurance companies are dabbling with denying care to the unvaccinated or up charging them. It's likely to get worse before it gets better. This bill is desperately needed.

I have heard many stories about this denial of care and these "kickout" types of letters. Some of them arrive at a time when a child or other family member requires immediate, ongoing, or extra levels of care. Recently, my mother was moved from her home to a memory care facility. In addition to multiple COVID vaccinations she was required to receive several additional vaccines all at once in order to be eligible for care and residency.

Her rapid physical and mental decline after this was obvious to anyone who knows her, and this was not a choice should would have made otherwise. It was extremely upsetting to watch her trade her medical autonomy and human dignity away in the very last years of a life lived with the utmost integrity, dignity, and autonomy. Just a few years prior, I attended an MD appointment with her, where she was offered many of these same interventions, and her response was met with respect and understanding. The nurse at that time commented, "This is probably why you're so healthy compared to most of my patients!" We all laughed a bit nervously—ha, ha, ha. I am not making this up.

This time, she had no choice. We had no choice in 2006 and 2019—but hopefully we will never be denied medical or other care in NH.

More and more people have no choice right now—being forced to choose between something they need or earned and are indeed entitled to, and something they really do not wish to do or cannot do because of medical, religious, or other reasons. Those reasons are not to be judged in a free society. Our governance system was designed to protect the minority from the overreach of the majority, not the other way around.

Those reasons are especially not to be leveraged by medical care providers. Pay-to-play should never be a strategy when it comes to people's access to medical care, education, nor anything else. As our society has become more and more transactional and our bodies have become more and more commodified, I fear this model is not only almost completely normalized but is a preview of a future where concepts of true consent are nothing but a distant memory.

Pay-to-play is a violation of informed consent principles and basic human rights. It is coercion. Some people who view it differently, say there is always a choice. You choose not to go to work, or school, or college, or the Emergency Room, or to a restaurant, store, or sporting event, or for surgery, dental work, or to the elder care facility. Or, you choose to follow the rules and get vaccinated. Simple.

Anyone with the most basic moral compass understands that this is an offensive and false dichotomy.

It has been enormously difficult to watch hundreds of thousands of families across this nation go through what we have already endured. It's been especially hard to see it begin to happen here in NH. COVID is not an excuse for letting our core principles of medical ethics, human respect, and individual dignity be discarded like trash.

Dear Chairman Pearson and Members of the HHSEA Committee:

Bi-State Primary Care Association and our members respectfully request HB 1003, prohibiting health care providers from refusing to provide care and services based on patient vaccination status, be recommended inexpedient to legislate. Bi-State staff and our members will not attend legislative hearings due to the risk of COVID-19, and we thank you for the opportunity to submit written testimony to your committee electronically. Bi-State and our members write to you in strong opposition of HB 1003 because we believe it is overly broad, provides for no exceptions, and is unnecessary.

Bi-State Primary Care Association (Bi-State) is a 501(c)(3) nonprofit organization, formed by two health and social service leaders in 1986 to advance access to comprehensive primary care and preventive services for all, with special emphasis on those most in need in New Hampshire and Vermont. Today, Bi-State represents 28 member organizations across both states that provide comprehensive primary care services to over 300,000 patients at 146 locations. Our members include community health centers (CHCs), federally qualified health centers (FQHCs), rural health clinics (RHCs), area health education center programs, and Planned Parenthood of Northern New England. New Hampshire's 13 health centers serve approximately 112,000 patients at locations across the state, including in those districts represented by the members of this esteemed committee. While not all health centers fall under the health facility licensing requirements, all health centers treat patients regardless of ability to pay, regardless of insurance status, and regardless of vaccination status.

Bi-State and our members oppose HB 1003 because of its broad application.

As introduced, HB 1003 applies to residential care facilities and health care facilities licensed under RSA Chapter 151; however, the use of "health care provider" is broad and not limited to facilities in RSA Chapter 151. Additionally, as the Department of Health and Human Services noted at the hearing, the language in the bill addresses providers and not the licensed facilities themselves, as Chapter 151 applies to facility licensure and not provider licensure. The testimony and conversations earlier today

to expand this bill to apply to all health care providers and types of care are also concerning. We do not believe tying the hands of clinicians who treat very medically complex patients during a pandemic in statute is appropriate given the amount of time it takes to amend statutes.

Bi-State and our members believe that the medical ethics and applicable scopes of practice address the issues raised during the committee hearing and that the most appropriate venue to have those issues raised is with the licensing boards, including the Board of Medicine. We ask that the committee consider adding resources to those boards if the committee members do not feel issues are being resolved in a timely manner.

For these reasons and more, Bi-State Primary Care Association and our members respectfully request the Committee recommend HB 1003 be inexpedient to legislate.

Good morning, Committee,

I'm emailing you, asking for you to SUPPORT HB 1003 that prohibits health care providers from refusing to provide care or services based on patient vaccination status. I am unable to make it today to testify, but I wanted you all to know that this happened to my 17 year old son! This should NEVER happen to anyone.

In early December, my son broke his nose playing indoor soccer. It was late on a Friday night and the bleeding stopped pretty quickly and he didn't have any problems breathing, so instead of going right to the ER (and sitting for hours and hours while also being exposed to all sorts of sick people) we waited until the next day to see how it was. It was a little crooked, so I called Concord Hospital's Otolaryngology's office to make an appointment. I was asked his vaccine status when making the appointment and told them that he did not get the Covid shot. They appeared to be fine with that. Then they wanted him to come in separately in order to do a Covid test (he had zero symptoms and had already recovered from the virus a while ago) so I said we didn't want the Covid test, we only wanted them to check out his nose. She said they wouldn't be able to do the scoping to see exactly what is going on without the Covid test. I told her I didn't want the test and then I asked if he would still be able to come in without the Covid test and she said yes. Fast forward to his appointment (in which I took time off from work for), I filled out his paper work and was asked again if he was vaccinated to which I replied no. We get into the appointment and Dr. Wood takes a quick look and then informs me that he cannot take him on as a patient due to him not being vaccinated. WHAT?! I was speechless not only because he was denied care, but also because they KNEW his status when I booked the appointment and yet they still had me come in?! I told him that was disappointing and ridiculous, to which he replied something to the effect that "yeah, well, with the Covid cases rising, they are just overly cautious about it", eluding to the fact that it was an OFFICE policy. However, when I got the bill for services not rendered and called the office, I learned that it was Dr. WOOD who was refusing to treat, NOT the practice! And, I learned that the practice KNEW this, yet scheduled my son with him instead of another provider. Infuriating!

This is not an isolated incident and this practice has got to stop. I know of a person that was denied monoclonal antibodies after she was told she could have it, was sent to the ER to receive it, AND, after spending the night in the ER was finally admitted into a room at 5:00am, was immediately discharged WITHOUT receiving any treatment as soon as they asked her vaccination status! Again, infuriating! I also know of at least one other that was denied treatment at ConvenientMD because of her status. She had a sinus infection (she gets them frequently so she knows when she has one... AND she's a nurse), but they wouldn't even look at her once they knew her vaccination status. When denied care, she went to another facility where she told them she was vaccinated (they didn't ask for proof) and they treated her immediately. Thankfully, because she was in so much pain!

Again, please SUPPORT HB 1003 to stop the inhumane segregation going on due to an UNAPPROVED medical procedure.

Representatives,

Over the last several years I've had countless conversations with New Hampshire families regarding the treatment they've received from medical providers within our state, specifically pediatricians and pediatric practices. A lot of the feedback has been positive; parents felt heard, supported, and respected. However, I have also heard from parents who have been denied medical care for their children and/or asked to leave a practice *based purely on their child's vaccination status*. I'd like to share with you some of the feedback that I've received from these families. I've removed any kind of identifying information for obvious reasons. These are all direct quotes from different individuals, regarding different providers and pediatric practices, in the state of New Hampshire.

Individual Providers:

"They just kicked my family out of their practice for not vaccinating – we had been going there for 15 years."

"He said either I catch her up to the [vaccination] schedule provided or get out. We got out."

"Within 5 minutes of us being there, he told us that since I wasn't getting my 16 yo. any vaccines at that visit, he wouldn't keep him as a patient. He was rude, condescending, and awful."

"I was fired for not vaccinating."

"She tried to bully us and threatened to kick us out of her practice because we wanted to follow a selective vaccine schedule. We left."

"He and Dr. ____ asked me to vaccinate or leave. It was a terrible experience."

"She refused to care for my 24-hr newborn and said by not vaccinating we were putting other lives at risk. I told her my son was my #1 priority and she laughed at us."

"We were asked to leave the office after I refused to continue vaccinating my child whom had just been diagnosed with an autoimmune disease."

"She bullied us and gave us a choice to either change our vaccine approach or leave the practice. We ended up leaving."

"I told her I wasn't vaccinating and she was so rude. She told me that I was a bad mother, and not to bring my child back."

Pediatric Practices:

"They said they would no longer see me because I wanted to follow a delayed vaccine schedule."

"They did not sugar coat their answer to me when I asked. They just said no, they will not offer care to my child since we will not be vaccinating."

"We were told we were no longer welcome if we do not vaccinate our children."

"They won't accept patients unless they follow the CDC's vaccine schedule."

"We received a letter stating that 'medical services at this office have been terminated due to non-compliance with our medical treatment plan," just because we declined vaccinations."

"They told me to find a new practice if I wasn't going to vaccinate."

"They won't even converse with parents questioning vaccines. Avoid them at all costs."

"When we started there a few years ago they were fine with us not vaccinating, but they fired us during the last measles outbreak."

"We've been there for two years. I was told at my last visit by Dr. _____ that if we don't vaccinate my youngest we need to find a new doctor."

"Dr. _____ said they would allow a delayed schedule, and maybe one at a time, but that we would have to have all of them or leave the office."

This type of exclusionary behavior is not limited to New Hampshire, and is occurring nationwide. It's not new, though it has become increasingly more common over the past five years. I want to emphasize that, historically, this refusal of care has had nothing to do with COVID-19. However, with the authorization and expected licensure of the COVID-19 vaccination(s) for children of all ages, along with the CDC's recommendations, **I have reason to believe that will change.** How many more families will be denied healthcare services based on their vaccination status?

Please, vote HB 1003 as 'ought to pass.'

Dear Chairman Pearson and Members of the HHSEA Committee:

Bi-State Primary Care Association and our members respectfully request HB 1003, prohibiting health care providers from refusing to provide care and services based on patient vaccination status, be recommended inexpedient to legislate. Bi-State staff and our members will not attend legislative hearings due to the risk of COVID-19, and we thank you for the opportunity to submit written testimony to your committee electronically. Bi-State and our members write to you in strong opposition of HB 1003 because we believe it is overly broad, provides for no exceptions, and is unnecessary.

Bi-State Primary Care Association (Bi-State) is a 501(c)(3) nonprofit organization, formed by two health and social service leaders in 1986 to advance access to comprehensive primary care and preventive services for all, with special emphasis on those most in need in New Hampshire and Vermont. Today, Bi-State represents 28 member organizations across both states that provide comprehensive primary care services to over 300,000 patients at 146 locations. Our members include community health centers (CHCs), federally qualified health centers (FQHCs), rural health clinics (RHCs), area health education center programs, and Planned Parenthood of Northern New England. New Hampshire's 13 health centers serve approximately 112,000 patients at locations across the state, including in those districts represented by the members of this esteemed committee. While not all health centers fall under the health facility licensing requirements, all health centers treat patients regardless of ability to pay, regardless of insurance status, and regardless of vaccination status.

Bi-State and our members oppose HB 1003 because of its broad application.

As introduced, HB 1003 applies to residential care facilities and health care facilities licensed under RSA Chapter 151; however, the use of "health care provider" is broad and not limited to facilities in RSA Chapter 151. Additionally, as the Department of Health and Human Services noted at the hearing, the language in the bill addresses providers and not the licensed facilities themselves, as Chapter 151 applies to facility licensure and not provider licensure. The testimony and conversations earlier today

to expand this bill to apply to all health care providers and types of care are also concerning. We do not believe tying the hands of clinicians who treat very medically complex patients during a pandemic in statute is appropriate given the amount of time it takes to amend statutes.

Bi-State and our members believe that the medical ethics and applicable scopes of practice address the issues raised during the committee hearing and that the most appropriate venue to have those issues raised is with the licensing boards, including the Board of Medicine. We ask that the committee consider adding resources to those boards if the committee members do not feel issues are being resolved in a timely manner.

For these reasons and more, Bi-State Primary Care Association and our members respectfully request the Committee recommend HB 1003 be inexpedient to legislate.
