This bill gives public bodies the option to meet by electronic or other means of communication in lieu of meeting in person. The majority of the Judiciary Committee expressed concern that the bill allowed for 100% remote access without the need for any physical location. The complete absence of a requirement for any physical location could lead to a lack of access for those that do not possess the technology required to attend. While the minority amendment does seek to address this shortcoming, the bill also directs that the meeting be adjourned if the public is unable to access the meeting. The committee felt that this section of the bill was problematic as the public is poorly defined, and that it forces a full adjournment for any technical issues. Options, like recessing temporarily to address any technical issues, are not available in this bill.

(c) Each member participating electronically or otherwise [must] in a meeting required to be open to the public shall be able to simultaneously hear each other and speak to each other during the meeting, and shall be audible or otherwise discernable to the public in attendance at the meeting's location. Any member participating in such fashion shall identify the location from which the person is participating and the persons present in the location from which the member is participating. No meeting shall be conducted by electronic mail or any other form of communication, including an online chat function, that does not permit the public to hear, read, or otherwise discern meeting discussion contemporaneously at the meeting location specified in the meeting notice.

Rep Simpson Sponsor When we discussed remote meetings last year, we had concerns I have tried to address. This bill is much narrower than previo8us versions. I only give public bodies the option of having remote meetings and, it adds riles that must be followed by the public body under RSA 91-A. It gives the decision about having remote meetings to the local body, not to an individual. The need for remote meetings is very important to many people who can't physically attend meetings. Currently, the public body can't hold remote meetings and the public can't participate remotely. Q Wuelper: ,Is there a required physical locations in this bill? Ans: No. There is an option for a completely remote meeting in it. Q: If you are having a remote meeting, do you have to allow access from the public in that meeting? Ans: I believe RSA 91-A leaves public input to the public body. I am unsure if the answer to your question is in HB 1014. Q: 'It's my understanding that one part of having public meetings is for the public to interface with their elected officials in one form or another. If the meeting is totally remote, isn't public input a necessary part of the meeting? Ans: Yes, and I don't see that requirement being changed from the current law.

Q Sylvia: If a meeting is totally remote, how much transparency is there if, for example, members of the body are texting each other during the meeting? Ans: I don't know if that would be different if the meeting is in person or remote Wouldn't it be more apparent if the meeting were in person"? Ans: I doubt we can tell what people are doing behind their screens now. Q Horrigan: Would this allow non-public meetings if needed? Ans: I think that is addressed elsewhere in 91-A. Q Chase: What about a quorum? Ans: I would be easier to make a quorum. Q Sylvia: What happens to those who may not have access? Ans: There is a requirement that if people can't access they must be able to notify about the problems

Rep Steve Smith Sullivan 11 Opposed This bill is neither Implementable nor enforceable. If there is a problem with access, the meeting will be adjourned: We all have deadlines and repeated meetings will make it very difficult to meet those deadlines. Someone from Oklahoma calls in and can't access the meeting, the meeting is over with no chance to investigate. Who is the public? We have seen disrupters and this is a perfect opportunity for miscreants to disrupt the entire process. Imagine if every hearing in this House had to be stopped by a single complaint. What happens when someone calls in to report access failure. If you have good technology remote meetings can work pretty well. Many people do not have this level of technology. Remote meetings could force people to spend money to upgrade their technology just to participate. We are public servants and ghe least we can do is give e the people face-t-face meetings.

Jake Berry VP Public policy New futures Support There are thousands of people across the state who don't believe they can't attend meetings in person. The bill is totally optional. Communities have spent the last year figuring our the issues Rep Smith brought out. We have working people and elderly, etc. who cannot get here to make there voice heard in person. Giving them remote access would enable them to be heard. Our geographic and

demographic problems won't go away. If Q Notter: Do you see any value to in person meeting? Ans: Yes, but the improved access remote meetings would give is important too. Q Horrigan: What can be done for the technology challenged? Ans: Many people who are least able to afford the technology may be the same as those who can't attend in person. Some of the greatest challenges are in the broadband area and we are working on that. Q DiLorenzo: Do you think the expansion of technology in school will mitigate that problem? Ans: Maybe. It certainly is worthy of investigation. Once you open the door there are ways of bridging that gap.

Rep Jess Edwards Rockingham 4 Opposed As I read this bill it strikes me that we are conflating two different populations which we should keep separate. The public body and the public itself. We probably all agree we like transparency. Given we have experience with the technology, I think its great that bodies can broadcast to the public. Watching the General court during the pandemic showed me things about how difficult it is to have remote meetings compared to in person. A lot of interpersonal communication is non-verbal. Because of that, if you have no physical location the public can communicate by telephone and this is an inadequate way of communicating the public bodies awork to the public. If I were running a public meeting and felt there was a lot of public interest where the public might want to come to us, the opportunity to go remote could be very influential and the public could lose a big part of their ability to communicate. We already allow some flexibility to the public body member to participate remotely. I don't think we should have fully remote meetings.

*[Web Portal] Polly Campion NH Nurses Association Support This bill establishes requirements for remote meetings. Remote access was available pursuant to emergency order #12. This allowed the public to participate via video of telephone. It significantly increased the participation from the public. During the pandemic, Nurses have found it very difficult to participate in meetings due to workloads or health concerns., Removing the possibility of remote meetings has exacerbated these difficulties. I also submitted slightly different testimony on behalf of the Council on Aging. We have been unable to get an in-person quorum, which for us is 13 people, for a meeting since the expiration of the emergency orders. We completely support HB 1014. Q Horrigan: Has technology helped those who can't get to the State House? Ans: Absolutely. Q What should we do to make physical location more accessible. Q Smith: How did you submit testimony to us? Ans: Through the web portal. Colleagues of mine have submitted testimony that way. Q Wuelper: Was the Nurses Association able to meet before the pandemic? Ans: The Nurses association is not a public body and is not subject to RSA 91-A. Q: Perhaps I'm confused. Was she Council on Aging able to meet before the pandemic? Ans: Yes, in part because the body was smaller and they were reimbursed for mileage, which they can't do now. The pandemic just exacerbated those problems, ow, and the membership has expanded. For example we have a CEO from Coos county and you can imagine his difficulty in attending meetings in other parts of the state. I do understand your question though: you are asking what is the change. Getting people to serve on boards has been a problem right along because of the time required to travel to meetings and we've long desired a way to mitigate that concern and increase the numbers of people willing to serve and access to the public for those who are interested. Q: Has the Council on aging taken advantage of the provisions in current law for remote participation? Ans: Actually, it's the Commission on aging. We have. The problem for that particular body is the quorum requirement. We had 40-60 people participating but only 11 in the physical location.

Rep Andrus Self Opposed This bill leaves a lot to be desired. I do not do video for remote meetings. Everyone doesn't have the technology to access remote meetings. People are lazy and I'm one of them it is easy to sit at home and do a remote meeting. NH was built on public meetings and public bodies. When people run for an office, they know they have to go to meetings.

Tom Mullins City of Keene Support Listening to the testimony here is almost a disconnect. Public bodies in Nh cover a wide spectrum booth geographically and in size and membership. We need to give more people githe opportunity to participate in government. Some local boards approached me about having remote meetings due to health concerns. I would be in favor of having a physical location, if nothing else for those who want to attend. I further advise you to require a free telephone access for remote participation. Q Chase: how did the remote telephone system work? Ans: we had an 800 number with a phone tree so people could be called in order. Q Horrigan: Did you have problems with the physical locations? Ans: Yes. We had to scramble to find locations where we could meet with physical distancing.

*Laurie Ortolano: RTKNH Support with Amendment We believe that the physical location is critical to a public meeting. The non-verbal communication obvious in a physical meeting can't be dismissed. A simple expression of discontent can mean a lot and would be lost in a remote meeting. When our local officials choose to meet via Zoom, they choose to turn the video off. That is wrong. Some board members are on social media during the meeting which they never could do if they had been physically present. I have handed out the final report of the

HB108 study committee which we used to develop our proposed amendment which you also have. There are a lot of suggested changes to this bill to make it workable. Telephonic communication really hurt me in a court case and when we met in person that changed.

Natch Greyes NHMA Support I haven't had the chance to review the amendment proposed by Right to Know NH, but it doesn't sound bad. The quorum requirement ant a physical location needs to be addressed. Even under existing law, municipalities have been trying to figure out how to accommodate the public. we have no objection to the physical location but the quorum needs work. Q Chasse: How can that be done? Ans: I am not sure. The current law requires a quorum which, without further definition, means a majority of the members. There ae emergency provisions, but they rarely apply.

HB1014 Testimony

To the Honorable Members of the Judiciary Committee.

My name is Laura Colquhoun and I live in Nashua NH. I am writing to support HB1014 with amended language to include maintaining a meeting physical location. Remote participation through hybrid meetings has increased public access and participation and this is a good thing. I embrace the public hybrid accessibility while maintaining the need for the public body to have a physical location with a defined quorum of the board.

Eliminating a physical location assumes that any interested citizen has access to the technology to participate in the meeting. This is not always the case. Additionally, a physical location allows the elected body to engage in face-to-face, verbal and non-verbal forms of communication that enhance the public's understanding of the business conducted and allows members of the public to personally address their officials. This is essential for public meetings.

On November 1, 2021, a final report was issued from the committee to review authorizing governing bodies of municipalities to hold virtual meetings and study remote access to meetings under RSA 91-A. Much of amended language for this bill was taken from the recommendations of this committee.

The amended language would include:

- a) a physical location must be provided and a quorum of the board as defined by the public body must be present.
- b) public notice of the meeting, with all information necessary to access the meeting telephonically and by other means, shall be given as provided in this chapter. The notice shall provide a mechanism for the public to alert the public body during the meeting if there are problems with access. The meeting shall be adjourned if the public is unable to access the meeting.
- c) Members of the public body participating remotely must identify that they are attending alone or identify who is with them at the meeting.



Commission Charge and Study Purpose:

163:5: The committee shall review authorizing governing bodies of municipalities to hold virtual meetings and to study remote access to meetings under RSA 91-A.

Process and Procedures:

The committee organized on September 20, 2021 and elected Representative Kurt Wuelper Chair. The Chair appointed Representative Bob Greene Clerk.

The committee met four times throughout the study period. The minutes of each meeting are attached.

Findings and Recommendations:

With the backdrop of the recent experiences holding remote meetings during the pandemic and the dramatic increase in public participation at those meetings, the public and many public bodies strongly favor them. While increased public participation is a very good thing, we recognize that RSA91-A, governing public body meetings, deals primarily with the public body's conduct and responsibilities and not with public participation, which is left to the local body to control.

Our tasking speaks solely to "municipal governing bodies," but RSA 91-A speaks to all public bodies. We decided to consider the rules for all public bodies and avoid the complications of having to define and separate the "municipal governing body" from all other public bodies. Also, since the extent and conditions of public participation is left to those local bodies, we thought that principle should govern our recommendations.

The primary question about remote meetings is: "Is there any need for a physical location at all?" Without any such requirement, anyone could set up and control a totally remote meeting

from any location. We unanimously agreed a physical location must remain required. We believe citizens should always have a physical place where they can observe their public servants conducting their business and speak to those chosen authorities face-to-face. This thought was buttressed by the consideration that many citizens remain disconnected from and/or uncomfortable with technology required to participate remotely.

Since a physical location would remain required, the question of how many members of the body must be present there for a meeting to take place comes to the fore. We heard many objections about the current requirement of a quorum of the body as the threshold. With "quorum" undefined in the law, the word takes its common meaning of fifty percent of the body plus one unless defined by the governing body.

We recommend all public bodies establish rules and procedures for conducting remote meetings to include:

- The minimum number of people (2 or more) required to be physically present
- How many remote members be counted toward the quorum requirement
- Procedures for conducting hybrid meetings

Many public bodies are geographically diverse, some spanning the entire state; others are quite large, over 50 members, making gathering over half of them in one place a major challenge. We received many suggestions from stakeholders about the minimum number required, ranging from one person through various iterations of some portion (10, 30, 40 percent) of the whole body to some real (2,5, etc.) number of people. We learned that some bodies define "quorum" in their governing documents at a far lower number than half and with or without other attributes. We also think a citizen having only one person from the body present seriously reduces the citizen's perception of "being heard" by the whole body.

As to remote participation for members, we believe this should be allowed under non-emergency situations with restraint. The idea of a public meeting is for the public to see, hear, and address the public body. The larger the part of the body present, the better that end can be met. Thus, the "not reasonably practical" standard for remote participation with documenting such reason in the minutes should remain. Only with these constraints can the public be assured their representatives are fulfilling their responsibilities.

We considered how remote member participation should be conducted. Current law requires remote participants "be able to simultaneously hear each other and speak to each other during the meeting and shall be audible or otherwise discernable to the public in attendance at the meeting's location." Insufficient broadband capability in many areas inhibits us from recommending a requirement for both voice and visual participation simultaneously. We do think the roll call vote standard remain in place.

Another concern with remote meetings is public access. Since local boards control public access now, we think that should continue. The body may allow partial or full public participation, and any requirements added in RSA 91-A would have to be paid for by the state.

Instructions on how the public can access and participate (to whatever degree permitted) in any meeting remotely should be included in the notice of meeting along with a means of notifying the body if transmission to the public is interrupted. While public access is unavailable, no actions taken should be legitimate.

We do recommend that people present in the room be given priority over remote participants when public comment is allowed. We strongly encourage all bodies to allow the greatest possible public access.

Dear Chair Gordon and Members of the House Judiciary Committee,

I am providing this verbal and written testimony today on behalf of the NH Nurses Association in support of HB 1014, an act allowing public meetings to be conducted virtually.

This bill:

- Establishes requirements for remote access to public meetings under RSA 91-A, the right-to-know law
- Strikes the requirement that persons be present at a specific physical location
- Strikes the determination of an emergency be made by the chair or presiding officer
- Adds that public access can be provided by telephone, video or by other means; excludes chat rooms

Remote access to public meetings was available pursuant to Emergency Order # 12, during the declared state of emergency brought on by the Covid-19 pandemic. This allowed members of the public to participate safely, regardless of their location, via the use of video or telephone. This significantly reduced barriers to participation.

Nurses throughout the state seek to be engaged in the activities of public bodies – local, regional or statewide boards, committees, commissions or legislative bodies. With more than 20,000 licensed registered nurses in New Hampshire, they work in a wide variety of roles and institutions. As you can imagine, they also bring a wealth of knowledge and experience to policy deliberations, particularly those related to a public health emergency.

During the pandemic, nurses have been stretched to their limits and find it increasingly difficult to carve out time to travel to meetings that require in-person presence for participation. In addition, as the pandemic continues to rage, many nurses are hesitant to participate in indoor gatherings that may put them at further risk of exposure, as they contemplate further stressing their colleagues and healthcare agencies already functioning with limited staff. It is particularly difficult for those that may be immunocompromised or living at a great distance.

The expiration of the executive order allowing fully remote meetings of public bodies has exacerbated the difficulty many nurses experience in participating in the discourse of public bodies, include those of the NH General Court.

HB 1014, removing the requirement for a physical location, would allow greater flexibility for those wishing to participate, creating equity of access between and among all residents and public office holders.

Thank you for your time and attention, and on behalf of the NH Nurses Association, I ask that you find HB 1014 Ought to Pass.

My name is C. Peter James and I am a resident of Grantham. I am on several local boards here and like nearly 100% of the members, I am a senior citizen volunteer on these boards. Also, like most of the members, I have "underlying health conditions" and am very cautious about trying to protect myself and my wife from Covid. Until last summer, we were allowed to conduct board and committee meetings fully remote with remote public access via both telephone and and Zoom. The permission to do this stopped at the end of the "Declaration of Emergency" and now we are required to have a quorum physically present. This is subjecting us citizen volunteers to unnecessary risk. The technology and experience have improved greatly in the last two years and the acceptance by the public has shown approval by the fact that more of the public are being involved than when we did not have the remote option.

This winter we are having difficulty gathering a physically present quorum due to members not willing or able to meet in person because of the escalating Covid numbers. At some point, we may have to actually cancel meetings of the some of the local boards and committees because we cannot raise the "required" physical quorum. Skipping a meeting or two for some groups is not a major issue, but for boards like the Planning Board and the ZBA, it can be a much larger problem because of delayed permits and decisions.

I am providing this verbal and written testimony today on behalf of the NH Nurses Association in support of HB 1014, an act allowing public meetings to be conducted virtually.

This bill:

- Establishes requirements for remote access to public meetings under RSA 91-A, the right-to-know law
- Strikes the requirement that persons be present at a specific physical location
- Strikes the determination of an emergency be made by the chair or presiding officer
- Adds that public access can be provided by telephone, video or by other means; excludes chat rooms

Remote access to public meetings was available pursuant to Emergency Order # 12, during the declared state of emergency brought on by the Covid-19 pandemic. This allowed members of the public to participate safely, regardless of their location, via the use of video or telephone. This significantly reduced barriers to participation.

Nurses throughout the state seek to be engaged in the activities of public bodies – local, regional or statewide boards, committees, commissions or legislative bodies. With more than 20,000 licensed registered nurses in New Hampshire, they work in a wide variety of roles and institutions. As you can imagine, they also bring a wealth of knowledge and experience to policy deliberations, particularly those related to a public health emergency.

During the pandemic, nurses have been stretched to their limits and find it increasingly difficult to carve out time to travel to meetings that require in-person presence for participation. In addition, as the pandemic continues to rage, many nurses are hesitant to participate in indoor gatherings that may put them at further risk of exposure, as they contemplate further stressing their colleagues and healthcare agencies already functioning with limited staff. It is particularly difficult for those that may be immunocompromised or living at a great distance.

The expiration of the executive order allowing fully remote meetings of public bodies has exacerbated the difficulty many nurses experience in participating in the discourse of public bodies, include those of the NH General Court.

HB 1014, removing the requirement for a physical location, would allow greater flexibility for those wishing to participate, creating equity of access between and among all residents and public office holders.

Thank you for your time and attention, and on behalf of the NH Nurses Association, I ask that you find HB 1014 Ought to Pass.

Thank you for accepting this written testimony in SUPPORT of House Bill 1014, allowing public meetings to be conducted virtually.

New Hampshire is comprised of many small towns, whose business is done by volunteer committees. In this time of COVID, it is frequent that a committee member must remain at home. Perhaps that committee member is immunocompromised, so that remaining home is a medically prudent precaution. Perhaps that committee member has been exposed to COVID, or has been infected with COVID, and must remain isolated for the medically recommended quarantine period.

For whatever reason a committee member cannot attend in person, it may be that a quorum cannot be met, and an important committee cannot meet. The business of the town is held up.

If HB 1014 were to pass, these towns could continue to conduct business virtually.

In the State House, elected Senators and Representatives who are immuno-compromised, exposed to, or infected with COVID cannot engage in debate and cannot cast a vote. The community that these lawmakers represent are thus deprived of their legal representation at the State House. We saw last year that the technology exists for remote participation.

The Americans with Disabilities Act seems to require that a disability NOT deprive an individual of participation and legal rights. Even so, the NH State House has NOT provided for the participation of these immuno-compromised, exposed, or infected members. It seems likely that COVID has been spread among attendees at State House deliberations, regardless of the size of the venue.

Therefore we need HB 1014 to ensure the protection of our lawmakers' health, to ensure that all towns continue to have the representation of their lawmakers in Concord, and to ensure that the many committees doing the business of New Hampshire's many town can continue to function, with our governing bodies able

to accept testimony and votes both in person and remotely, given individuals' various medical needs and the ever-changing status of our state's infection levels.

Thank you for accepting this testimony IN SUPPORT of HB 1014, allowing public meetings to be conducted virtually.

STATE OF NEW HAMPSHIRE

AN ACT allowing public meetings to be conducted virtually.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 Access to Governmental Records and Meetings; Meetings Open to the Public. Amend RSA 91-A:2, III to read as follows:
 - III. A public body may, but is not required to, allow one or more members of the body to participate in a meeting by electronic or other means of communication for the benefit of the public and the governing body, subject to the provisions of this paragraph.
 - [(a) A member of the public body may participate in a meeting other than by attendance in person at the location of the meeting only when such attendance is not reasonably practical. Any reason that such attendance is not reasonably practical shall be stated in the minutes of the meeting.
 - (b) Except in an emergency, a quorum of the public body shall be physically present at the location specified in the meeting notice as the location of the meeting. For purposes of this subparagraph, an "emergency" means that immediate action is imperative and the physical presence of a quorum is not reasonably practical within the period of time requiring action. The determination that an emergency exists shall be made by the chairman or presiding officer of the public body, and the facts upon which that determination is based shall be included in the minutes of the meeting.
 - (e) Each part of a meeting required to be open to the public shall be audible or otherwise discernable to the public at the location specified in the meeting notice as the location of the meeting.]
 - (a) A physical location is not required for any meeting, provided the meeting complies with the provisions of this paragraph.
 - (b) If a meeting has no physical location, public access shall be provided to the public by telephone, and additional access may be provided by video or other electronic means.
 - (c) If a meeting has no physical location, public notice of the meeting, with all information necessary to access the meeting telephonically and by other means, shall be given as provided in this chapter. The notice shall provide a mechanism for the public to alert the public body during the meeting if there are problems with access. The meeting shall be adjourned if the public is unable to access the meeting.
 - (d) Each member participating electronically or otherwise [must] in a meeting required to be open to the public shall be able to simultaneously hear each other and speak to

each other during the meeting, and shall be audible or otherwise discernable to the public in
attendance at the meeting's location, if the meeting has a physical location. Any member
participating in such fashion shall identify the location from which the person is participating

function, that does not permit the public to hear, read, or otherwise discern meeting discussion
contemporaneously at the meeting location specified in the meeting notice.

- [(d)] (e) Any meeting held pursuant to the terms of this paragraph shall comply with all of the requirements of this chapter relating to public meetings, and shall not circumvent the spirit and purpose of this chapter as expressed in RSA 91-A:1.
- [(e)] (f) A member participating in a meeting by the means described in this paragraph is deemed to be present at the meeting for purposes of voting. All votes taken during such a meeting shall be by roll call vote.
 - 2 Effective Date. This act shall take effect 60 days after its passage.
