It is even more dangerous to trust "unelected" personal that taxpayers have no direct control to hire and fire at the ballot box. The Ethics Committee evaluation is a good strategy. I remind you of Jefferson famous warning: "Speak not to me of confidence in men, but bind them down from mischief to the chains of the Constitution." The federal government when it created the DHHS, did so outside the boundaries of the Supreme Law of the Land." Without the Chains of the Constitution limiting their behavior, we had better have legislative oversight. Vote OTP on HB 1045.
