ANALYSIS

This bill broadens the locations where mileage for legislators can be calculated to include venues other than the state house where the house, senate, or both bodies joined meet.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 Legislative Officers and Proceedings; Travel Allowance for Members; Including Venues Other 1 2 Than the State House. Amend RSA 14:15-a to read as follows: 3 14:15-a Travel Allowance for Members. A member of the general court shall be allowed mileage by choosing the method in either paragraph 4 5 I or II prior to the first mileage reimbursement payment in the term: 6 I.(a) In the computation of mileage under the provisions of this paragraph, the word "day" 7 shall be deemed to be a calendar day; and, whenever a legislative session shall be continued beyond 8 12 o'clock midnight, the members present shall be entitled to additional mileage for another day's attendance; provided, however, that any member of the general court absent for any cause from such 9 10 attendance shall not be allowed mileage for the day the member is so absent. 11 (b) A member of the general court shall be allowed mileage for the round trip to and 12 from the member's home to the state house in Concord, or any other location where the House, 13 Senate, or both bodies in a joint session are meeting for each day of attendance at the following 14 rates: 15 (1) For the first 45 miles, \$.38 per mile; and 16 (2) For all miles in excess of 45 miles, \$.19 per mile. 17 II. A member of the general court shall be allowed compensation for actual travel expenses 18 of the round trip to and from the member's home to the state house in Concord, or any other 19 location where the House, Senate, or both bodies in a joint session are meeting. Mileage 20 shall be paid at the maximum rate established in the United States Internal Revenue Code and 21 Regulations for the number of miles traveled.

2 Effective Date. This act shall take effect 60 days after its passage.
