STATEMENT OF INTENT

This bill, as amended, provides access to an employee restroom for persons who have certain medical conditions including Crohn's disease, ulcerative colitis, use of an ostomy device, and other medical conditions that may require immediate bathroom access at retail establishments which do not provide public restrooms. The existence of the medical condition would be proven by a card signed by a health care provider, by an identifying card from a national association or by other reasonable evidence of a qualifying condition. Access is required only when the employee toilet facility is not located in an area where providing access would create a health or safety risk for the customer, or a safety risk to an employee of the establishment. The amendment also removed a penalty of \$1000 for retail establishments not complying with the statute. Committee members believe that \$1000 is too great a burden on a small retail establishment, and although this leaves the statute without the "teeth" that would be provided by a penalty, this was a good balance between the access needed by the customer and the potential burden on the business.

Mr. Chairman and Members of the Health, Human Services, and Elderly Affairs Committee:

My name is Matthew Sullivan, and I am a resident of Bedford. I was before the committee in January to voice my support for HB 1130 FN, related to providing restroom access for those with certain medical conditions. I write to you this morning before the Executive Session to once again express my support for the bill as one that ought to be quick to pass to the floor.

As stated at the hearing, I live with two of the applicable conditions: Crohn's disease and an ostomy. Both can create a sudden need for a bathroom, where seconds and minutes matter. While most retail establishments have public restrooms, it can become a form of roulette to pick the right one. When the wrong business is chosen, it can be an embarrassment for the patient.

With this type of uncertainty in our lives, especially when a disease is causing a "flare", sometimes a patient needs to weigh the potential consequences when deciding to leave the house. This could mean missing work, not being able to go out, and not conducting business & shopping in the community. We can all remember the sense of isolation from the early COVID lockdowns, and this is akin to what Inflammatory Bowel Disease (IBD) patients can experience time and again.

Several members of the committee expressed expanding the bill to include other medical conditions, and I will go out on a limb to express the sentiment of all IBD patients: YES! We lose nothing from increased equity for those that need a restroom, whether it be from a disease, pregnancy, or even just a bad lunch. But, a similar bill with broad uses has come before the committee in the past, only to be deemed ITL. The language in this bill is more narrow, and could likely serve as a means to test the waters before reviewing expanded uses in the future. There is no need to rush into something that has already been proven to be an obstacle in the past.

Besides being a patient of chronic illness, my wife and I are partners in a small business in Rochester. We understand the concerns related to the safety of employees and patrons. I believe the bill has language to cover such issues, allowing denial to a bathroom if there is a safety issue for either party involved. I know that we keep our restroom facilities clean and safe for our staff, and I hope that all businesses would do the same. In the case of a single employee, let them deny access. The supporters of this bill are not asking for carte blanche access to every toilet in the world, just increased access to what we experience today.

I will say that in the nearly 30 years of living with this illness, I have only been denied restroom access 8-10 times. Most employees and businesses are kind and generous for those in some obvious plight. But, the times where I was denied was simply because of "policy" or "liability, two words often just thrown around like some sort of unmovable force. The last thing I want to do is kindness, but this is more than that; this is about giving hope to a group of Granite Staters that need just a little bit more in their lives.

People often love to quote the line from Robert Frost's poem "Mending Wall", "Good fences make good neighbors." But it is often overlooked that it is the poem is a story of two neighbors coming

together to build and repair a wall, part of their community. That is what this bill has the opportunity to do: build a better New Hampshire.

Thank you for all your efforts, and I hope I get to see this bill be designated as "Ought to Pass."

HB764 (ITL) – This bill would require any private business to offer lavatory facilities to any person in cases of emergency. Current law requires only public buildings as well as bars and restaurants (or businesses that serve food) to provide lavatory facilities. The committee was unanimous with the difficulty of first establishing the definition of emergency and second mandating businesses to allow the public use of their facilities which for many would require extensive remodeling to meet access needs of the public as well as ADA compliant. The committee further felt that local control of building codes is the appropriate authority having jurisdiction beyond existing law.

HB831 (ITL) – This bill would require the pharmacist or designee to notify a consumer that a particular prescription needed to be renewed. By allowing this bill as written, the pharmacist would bear the burden of liability which is clearly unintended. The consequences could very well mean eventual higher costs to the consumers due to increased liability, handling and administrative costs of the pharmacies. The committee unanimously viewed this bill as the consumer's responsibility to manage his or her own prescriptions.

HB853 (ITL) – This bill would have no effect or demands on the federal government to change our federal reserve system and therefore would be a poor use of our legislative resources. Although the sponsors intent is to surface the discussion of fiat currency, the majority of the committee felt strongly that it should not be part of our legislative process. However, in support of the sponsors intent, Thomas Jefferson was claimed to have said that, "If the American people ever allow private banks to control the issue of their money, first by inflation and then by deflation, the banks and corporations that will grow up around them will deprive the people of their property until their children will wake up homeless on the continent their fathers conquered." With that said, the Federal Reserve (a private bank) which controls our money (paper aka "fiat money" which is defined as inconvertible paper by a government decree which is backed insufficiently by gold and by the levying of future taxes) falls exclusively under the jurisdiction of the United States government, not the State of New Hampshire.

Inflammatory Bowel Disease can affect anyone, no matter their gender, age, race, or ethnicity. People, both children, and adults with IBD all too often suffer for years before they begin the journey toward an accurate diagnosis and treatment, often there is no known cause or cure. They live with symptoms, such as diarrhea, fatigue, abdominal pain and cramping, blood in their stool, reduced appetite and unintended weight loss, and even inflammation and sores (ulcers) along the superficial lining of the large intestine and rectum.

However, there is another aspect that people with these conditions have to live with. They have to live with the fact that at any time, anywhere they could have a flare up and they have to have access to a restroom immediately or they will have an embarrassing accident, something completely out of their control. Many IBD patients worry about whether or not they will have access to a restroom in public. Unfortunately, not all public retail establishments have public restrooms available, and there have been incidents in which IBD patients have been denied access to employee-only restrooms.

The Restroom Access Act (also known as Ally's Law or the Crohn's & Colitis Fairness Act) seeks to ensure that people with certain medical conditions have access to employee-only restrooms when a public one is unavailable. This is truly a bill that would show some human compassion, give people their dignity and truly help people. I urge you to please support our local community members and pass this bill.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 1 Title. This act shall be known and may be cited as the "Crohn's and Colitis Fairness Act" or 2 the "Restroom Access Act".
 - 2 Purpose. The general court hereby finds and declares that:
 - I. Crohn's disease and ulcerative colitis, collectively known as inflammatory bowel disease (IBD), are painful, medically incurable diseases that affect the digestive system resulting in symptoms that include loss of bowel control and require urgent and sudden use of a restroom.
 - II. Denying restroom access to IBD patients can lead to embarrassing, avoidable accidents that can cause extreme emotional distress.
 - III. As IBD affects numerous people in this state, and as increasing numbers of people are being diagnosed with IBD, it is in the public interest to ensure that these patients can access a restroom in an emergency.
 - 3 New Subdivision. Amend RSA 155 by inserting after section 80 the following new subdivision:
- 13 Restroom Access Act
 - 155:81 Definitions. In this subdivision:
 - "Eligible medical condition" means Crohn's disease, ulcerative colitis, any other I. inflammatory bowel disease, irritable bowel disease syndrome, or any other medical condition that requires the use of an ostomy device or immediate access to a toilet facility.
- 18 II. "Retail establishment" means a place of business open to the general public for the sale of goods or services.
 - 155:82 Restroom Access. A retail establishment that has a toilet facility for its employees shall allow any individual who is lawfully on the premises of such place of business to use that toilet facility during normal business hours, even if the place of business does not normally make the employee toilet facility available to the public, provided that the following conditions are met:
 - I. The individual requesting the use of the employee toilet facility suffers from an eligible medication condition or utilizes an ostomy device, as evidenced by a signed document from a health care provider, an identification card from a national association, or other reasonable evidence of a qualifying medical condition.
 - II. A public restroom is not immediately accessible to the customer.

METHODOLOGY:

This bill requires retail establishments to allow individuals with eligible medical conditions to use employee toilet facilities under certain circumstances as well as establishing a fine for any retail establishment or an employee of a retail establishment in violation of the statute. There is no method to determine how many violation charges would be brought as a result of the changes contained in this bill to determine the fiscal impact on state General Fund expenditures or revenue.

It is assumed any fiscal impact from this bill will not occur until after FY 2022.
