STATEMENT OF INTENT

This bill, as amended, addresses ballots with cross-outs, stray marks, corrections, or those with more than the permitted number of ovals completed for an office-so-called, over voted ballots. The bill requires machines to immediately return overvoted ballots to the voter so that the voter can deposit the ballot in a separate box of ballots that will be counted by hand. Previously, such ballots were accepted by the machine, but not counted for the overvoted office. As it stands now, in towns that do not use machine scanners, such overvoted ballots are hand-counted. The intent of this bill is to place all voters, those in hand-counted towns and those in machine scanned towns and cities, on equal footing.

AMENDED ANALYSIS

This bill requires that ballots which contain more than the allowable number of votes for an office on the ballot be returned to the voter to be hand counted by election officials after the polls close. The bill also requires the number of over voted ballots, as well as the number of overvotes and undervotes, be included in the return for each election.

Amendment to HB 1163

1 Amend the bill by replacing section 1 with the following:

New Paragraph; Electronic Ballot Counting Devices; Rules; Over Voted Ballots. Amend RSA
656:42 by inserting after paragraph IX the following new paragraph:

5 X. The electronic ballot counting device shall be programmed to require that a ballot which 6 contains more than the allowable number of votes for an office or ballot question on the ballot, 7 known as an "over voted ballot", be returned to the election day voter by the device. The voter shall 8 be instructed to place the ballot in an auxiliary compartment to be hand counted by election officials 9 after the polls close. Over voted ballots of absentee voters shall be placed in the auxiliary 10 compartment by the moderator or his or her appointee to be counted after the polls close.

Rep. Sweeney

- Question: **Cited** AB Ballots in Derry. How (to) notify AB person vs. someone previously voting in person?

Testimony in Support of HB 1163, Overvoted Ballots

To Honorable Members of the House Election Law Committee:

If I were the Secretary of State or Attorney General, I would ask you to support this bill.

Summary:

- Non-partisan
- No extra cost (Source: LHS Associates, Jan. 2022)
- Voter privacy protected
- More voters using computers will have their votes counted.
- Voter education. If voters are aware computer can't read ballot, they're more likely to mark a computer-readable ballot next time.¹ (See p. 4 for examples.)
- Optical scanners are known to misread legal votes as overvotes. (Folds, dust, stray marks, etc.) Legal votes on those ballots would ONLY be counted if there was a recount. That disenfranchisement wouldn't occur in hand count towns. (See my linked testimony on HB 1486 in 2018, p.4.)
- Require reporting overvotes and undervotes separately so overvote anomalies like we saw in Windham and Derry can be found and corrected election night.² See p. 3.
- Treats absentee voters the same. See p. 2 for suggested ballot directions.

In his testimony opposing SB 79 last year, Mr. Scanlan estimated that 2-3% of legal votes aren't counted by scanners on election night. He had no estimate to compare disenfranchisement rates for hand counted votes.

Non-scientific voter sample of overvotes in Nov. 2020 (in 3 AccuVote towns, 1 city and 2 Nashua wards) showed total of 1,246 overvoted ballots, 2.6% of 48,953 ballots tabulated by AccuVote.) The one hand-count town showed 3 overvotes of 1,602 total ballots counted, .19% IF they occurred on separate ballots.

Basis in NH Law:

NH law doesn't disenfranchise voters for not following directions. Voter intent is the legal standard.

"The goal must be the ascertainment of the legally expressed choice of the voters. <mark>The object of election laws is to secure the rights of duly qualified voters, and not to defeat them</mark>." *Appeal of McDonough*, 149 N.H. 105, 112, (2003). RSA 659:64, RSA 40:4-g.

RSA 40:4-g Intent of the Voter. – In any vote conducted pursuant to this chapter, every ballot shall be counted if the intent of the voter can be determined, regardless of whether the voter followed any instructions relative to marking the ballot provided before the vote. **Source.** 2019, 148:1, eff. Aug. 30, 2019

¹ **RSA 659:64 Determining Intention of Voter.** – If a ballot is marked for any office in a way which does not readily admit of counting or if a disagreement over how to count the ballot for any office occurs among the election officers present and counting votes, then the ballot shall be counted for that office in accordance with the majority vote of the election officials present and counting votes; provided that, if no alternative count receives a majority vote, the ballot shall be regarded as defective for that office as provided in RSA 659:65.

Research and anecdotal evidence show less-experienced voters, those of lower income and education are more likely to be disenfranchised by overvoted ballots. That has been known since the 2000 general election and reported by the Election Assistance Commission. ³

Voting systems used for in-person voting where ballots are processed immediately should allow voters to verify their vote before the ballot is cast and counted, notify the voter of overvotes, and provide voters with an opportunity to change the ballot before it is cast and counted. 52 U.S.C. § 21081(a)(1)(A).

Absentee ballots, p.7

The Help America Vote Act ("HAVA"), 52 U.S.C. § 21081(a)(1)(B), requires that mail-in ballots for federal elections notify the voter of the effect of casting multiple votes for an office and contain instructions on how to correct a ballot before it is cast and counted. This includes telling voters how to get a replacement ballot if necessary.

Treating Absentee Voters the Same

Currently, it is unlikely that absentee voters will request a replacement ballot if they make an error.⁴ If voter intent is clear, law requires votes to be counted for preferred candidate.

Possible directions for all absentee ballots: (Source: Mesa County, CO where all voters vote by mail. Their election system identifies questionable markings so officials can examine them and determine voter intent.)

To vote for a candidate, completely fill in the oval to the left of your choice using blue or black ink. (Shows visual example.)

To make a correction, draw a bold line through the oval and candidate name marked by mistake. Then, completely fill in the oval next to the correct name. (Shows visual example.)

IF the AccuVote rejects an absentee ballot identified on the LCD screen as containing an overvote, HB 1163 requires election officials to put it in the auxiliary bin, with ALL contests counted by people after polls close election night. The AccuVote has an override button that would allow it to accept a ballot, invalidate the overvoted race but tabulate all others. CT and VT also use the AccuVote. See their procedures to deal with absentee overvoted ballots,

p.6-7 below. The SoS and clerks may have a better idea for dealing with computer-read overvotes on absentee ballots.

Why NH Should Report Overvotes and Undervotes separately:

Currently, NH poll tapes report overvote and undervote totals together as "blanks" for each contest. See p. 5 for Nashua Ward 1 example. For the 2020 Presidential Primary, this poll tape shows 11 overvoted and 8 completely blank ballots (no vote recorded). In the separate contests, you can see 9 R voters and 10 D voters had no vote recorded for any candidate (total of overvotes and undervotes). Some of these were probably legal votes. See p. 4 for overvote examples.

HB 1163 would require the 9 blanks in the R contest and 10 in the D to report two numbers, overvotes/undervotes for each contest, included in reports to Concord, on the SoS website and available as public records.

Example: If Windham or Derry elections officials had seen an unusually high overvote number for a particular Nov. 2020 race, they could have checked to find why and correct any error, BEFORE they sent results to Concord. That's what our NH Constitution requires.⁵

VT requires those overvotes and undervotes ("blanks") to be reported separately and they are included on the SoS website for each contest and location.⁶

4) "Best practice" protocols to ensure voter intent honored whenever possible:

A. VT/ election-day ballots Vermont Tabulator Guide as of April 2018

https://sos.vermont.gov/elections/town-clerks/election-supplies/ (See "Vote Tabulator Guide" link.)

If a ballot is rejected by the tabulator, read the message on the tabulator LCD Screen:

C. "Overvoted race"

1 means the voter marked more candidates for an office than the "Vote for Not More Than #" for that race, OR

2 a stray mark or fold on the ballot may have been read as an extra vote.

3.Discreetly explain to the voter that too many choices were marked for one race.

ASK the voter to review the ballot to see if too many candidates were marked for one office or to look for stray marks. If the voter can't see the error, feed the ballot again.

If the ballot is returned again with "over voted race" on the LCD screen,

i. Ask the voter if they want to return the ballot to the entrance checklist officials to obtain and mark a new ballot.

ii. If the voter chooses not to mark a new ballot, explain that the machine will count all properly marked races but will not count the vote in the "over voted office."

The election official can use the plastic key to open the upper front panel access door and hold the YES button while instructing the voter to insert the ballot **OR** the voter may place the ballot in the Auxiliary compartment.

B. CT/Absentee Ballots: (see p. 12-14)

In CT, there are teams that ONLY deal with absentee ballots.

1. If a quick look at the ballot shows the computer won't read voter intent, put it in the auxiliary bin to be counted later.

A. If it contains an actual overvote (ovals filled in for both Biden and Trump, for example), you can use the override button and the AccuVote will read other votes and invalidate that one as an overvote.

2. If computer rejects a ballot, try inserting another way.

3. If it is still rejected, put in auxiliary bin to be counted by people.

Step 10. Set aside ballots to be handcounted.

B. Ballots with obvious marking errors.

Before feeding the ballots into the tabulator, take a quick look at them. Any ballots which obviously cannot be processed by the tabulator (e.g., mutilated, completed in red ink, non-No. 2 pencil, etc.) should be set aside for hand counting. **Also** set aside any ballots which contain markings that will obviously result in lost votes (e.g., some races marked with a check or an "X"; candidate name circled; name written in on the write-in line but the oval is not filled in). The point of this quick look is to spot obvious errors, not to substitute a hand count for tabulator processing. **Remember:** all offices and questions will have to be hand counted on these set aside ballots.

Step 11:

If the tabulator indicates that a ballot contains an **overvote**, check the ballot to be sure it is a true overvote (see: EXAMPLE 3) and not a stray mark through one of the ovals. Unless the ballot clearly shows an attempt by the voter to cast more than one vote for an office, the ballot should be put aside to hand count all offices. Subtract from the number of Absentee ballots machine counted. If the ballot does contain a true overvote, reinsert the ballot and press and hold the **"yes"** key at the same time to perform an *override*. When the tabulator performs an *override*, it does not count any votes for the office in which an overvote occurs, but *does* count all other properly marked votes.

Step 12:

Some ballots will have to be hand counted. The **rule for counting ballots** is that **the intent of the voter governs**....

p. 16 To avoid unnecessary lost votes and to give effect to the intent of the voter, WHENEVER an **"overvote"** message is displayed while processing **absentee ballots**, the official processing the absentee ballot should inspect it to be sure that it is a genuine overvote--an attempt by the voter to vote for more candidates than allowed for an office. If it is a genuine overvote, such as the one shown in Example 3, the **override** procedure described in 11a above should be used. Unless you are sure that it is a genuine overvote, the ballot should be put aside for hand counting.

p. 44 Closing procedures:

1. Process any remaining ballots that were set aside during the day. If there are any ballots that continually reject, and the ballot is marked correctly, but contains an over-vote, over-ride the ballot in the tabulator by pressing and holding the YES button while feeding the ballot through the tabulator.

2. If there are any ballots that continually reject, and the ballot is mis-marked, hand count these ballots in accordance with the this Handbook.

This bill requires that ballots which contain more than the allowable number of votes for an office on the ballot be returned to the voter for possible correction before the ballot is counted.

GST supports revising New Hampshire voter law to make our voting system simple to understand and execute, resistant to fraud, and available exclusively to bona fide residents of New Hampshire.

The election strategy with the most accuracy, and the least opportunity for fraud, is one where:

- individuals themselves, in person, go to a polling place

- they show proof of identity, citizenship, and residence in New Hampshire in order to vote

- they receive a ballot, mark it in private, and place it in a counting machine or other secure container

- voted ballots are under control of local and state election officials for counting, archiving, and recounts

The proposal to return over vote ballots to voters for further processing by either them or election officials adds complexity and additional handling.

I write in opposition to HB 1163. This bill corrupts ballot processing, degenerates ballot integrity preservation and introduces probable fraud in recounts.

Over-voted ballot curing process already exists in NH-RSA 659:22. Also, this bill would count votes on spoiled over-voted ballots and then allow those spoiled ballots to be marked as CANCELLED.

NH-RSA 659:22 SPOILED Ballots. - If any voter spoils a BALLOT, he may receive others, one at a time, not exceeding 3 in all, upon returning each SPOILED one. The ballots thus returned shall be immediately marked "cancelled" by the moderator over his signature and, at the close of the polls, shall be preserved as provided in RSA 659:95.

This bill would allow over-voted ballots containing both counted and uncounted votes to be segregated as spoiled ballots, apart from good ballots in ballot box.

NH-RSA 659:59 Optional Counting of Votes at Additional Polling Places. - The moderator may order the assistant moderator in writing to process absentee ballots and to count the votes cast at the additional polling place in the presence of and with the assistance of the assistant town clerk and election officials in the manner prescribed by this chapter. After the processing of absentee ballots and the counting are complete, the assistant moderator shall place the counted ballots in the BALLOT box and shall seal it, and the assistant town clerk shall certify the same. The assistant moderator shall also seal in a package the duplicate checklists used at the additional polling place together with the absentee envelopes and the SPOILED and unused ballots; and he, together with the assistant town clerk, shall immediately deliver the BALLOT box, checklists, absentee envelopes, unused and SPOILED ballots, and a written report of his count signed by him and the assistant town clerk to the moderator of the town at the central polling place. If the moderator does not order the counting as provided herein, the assistant moderator shall comply with the provisions of RSA 659:62.

NH-RSA 659:62 Return of Materials From Additional Polling Place. - Except as provided in RSA 659:59, upon the closing of the polls at each additional polling place, the BALLOT box at such polling place shall be sealed by the assistant moderator. Such sealing shall be done in the presence of the inspectors of election and shall be certified by the assistant clerk at such polling place. The assistant moderator **shall also seal in a package the duplicate checklists used at the additional polling place together with the unused and SPOILED ballots**. The BALLOT box and the package shall be delivered to the moderator at the central polling place without unnecessary delay and with the seals unbroken by 2 election officials designated by the assistant moderator. Such 2 election officials shall be of different political parties.

This bill throws a huge monkey wrench into doing a recount by requiring an unspecified process to recount spoiled over-voted ballots containing previously counted votes. No marking identifies which spoiled over-voted ballots were had previously counted votes and which were not. A recount would be guaranteed to grossly miscount votes.

Please reject this dangerous HB 1163 as Inexpedient-to-Legislate (ITL).

The time has come to allow LHS Associates to program our voting machines (as they have done in Massachusetts and Vermont) to permit voters to correct their over votes rather than have them invalidated without informing the voters of that outcome.

Enabling overvote notification on the AccuVotes was one of the recommendations of the Windham auditors. "Overvote notification alone would not have prevented the problem in Windham: almost certainly, a full hand count would have been necessary to establish the winners. But the problem would have been identified quickly." P. 107, https://www.doj.nh.gov/sb43/documents/20210713-sb43-forensic-audit-report.pdf.

This bill would also bring New Hampshire into compliance with Section 301(a) of the Help America Vote Act (HAVA), stipulating that voters in federal elections must be given the opportunity to correct an over vote.

Our ideal would be to return to paper ballots for all elections, but failing that we feel it imperative that voting machine results be tabulated with 100 percent confidence. (We also believe that voting machine be fully subject to proper audit, as well, but will leave that to other efforts to bring to fruition.) We feel this bill would serve that end and, again, respectfully request your full support.

Please support HB 1163.

Too many voters are disenfranchised by machines erroneously tabulating over votes. This needs to be addressed.

There are way too many "over votes" that are improperly "counted" by voting machines across NH. Not all machines - but some - tabulate excessive numbers of over votes, thereby disenfranchising thousands of voters.

An over vote is counted when the voting machine tabulates too many votes for a race on the ballot. For instance, if the race allows for up to any four candidates to be chosen, and five ovals are counted as filled in, then the machine would count this as an over vote - and disallow all of the votes in that race.

But the machines also make mistakes and tabulate over votes when the voter properly followed directions.

During the November, 2020 general election, one Merrimack voting machine tabulated a massive number of 396 over votes on 1,738 ballots (22.78% of ballots), while another Merrimack voting machine tabulated only 14 over votes on 1,856 ballots (.75% of ballots).

Here's more examples...

- One machine in Manchester tabulated 263 over votes on 1,755 ballots (14.99%), another machine tabulated 60 over votes on 2,531 ballots (2.37%).
- One machine in Windham produced 292 over votes on 3,276 ballots (8.91%), another machine tabulated 18 over votes on 1,373 ballots (1.31%)
- One machine in Hampton produced 121 over votes on 1,273 ballots (9.51%), another machine produced 26 over votes on 1,573 ballots (1.65%)

This type of anomaly can be seen in town after town - and it is unacceptable to those who care about their votes being accurately counted.

PLEASE, if you are a true American, who loves our country vote for election integrity. If we do not have clean fair elections we will further lose our country.

ANALYSIS

This bill requires that ballots which contain more than the allowable number of votes for an office on the ballot be returned to the voter for possible correction before the ballot is counted. This bill also requires the number of over voted ballots, as well as the number of overvotes and undervotes, be included in the return for each election.

X. To comply with section 301(a) of the Help America Vote Act of 2002, Public Law 107-252 3 $\mathbf{4}$ and RSA 659:64, programming the electronic ballot counting device shall require that a ballot which contains more than the allowable number of votes for an office or ballot question on the ballot, $\mathbf{5}$ 6 known as an "over voted ballot", be returned to the election day voter for possible correction before 7the ballot is counted. The secretary of state shall establish protocols for local election officials to 8 ensure that voters have the opportunity, in a private and independent manner, to change the ballot 9 or correct any error before the ballot is counted, including the opportunity to correct the error 10through the issuance of a replacement ballot. Ballots of absentee voters and those who choose not to 11 correct or replace the ballot shall be placed in an auxiliary compartment and counted by election officials. 12
