For the purpose of this section, "companion animal" means a cat, dog, 9 or other legally-owned animal kept in an enclosure that might typically be found in a home. During 10 such emergency, any volunteer who has been vetted by the department of health and human services and is a member of the disaster animal response team and is assisting evacuated persons and 11 companion animals shall be considered an emergency worker under RSA 21-P:41, VI(c). 12

Honorable Members of the House Environment and Agriculture Committee,

Thank you for considering my testimony in support of HB 1186 which requires that shelters and hotels that function as shelters during a declared state of emergency with evacuation orders must accommodate companion animals.

My name is Jean Slepian. I live in Stoddard, in Cheshire County. I am not employed by any animal protection organization, but I have been a citizen lobbyist for animal protection legislation for many years.

In 2005, in the aftermath of Hurricane Katrina, animal lovers all over the country watched in disbelief as beloved pets were ripped from the arms of screaming children and people were forced to leave their animal companions behind in order to be evacuated from flooded homes. These images left an indelible impression of vulnerable people who had already lost their homes and possessions being treated with cold cruelty by those who were sent to rescue them.

In response to this tragedy, in 2006, the US Congress passed the Pet Evacuation and Transportation Safety Act which requires that in order to receive federal funding for disaster management plans, states must have a plan in place to include companion animals in disaster evacuation plans. The remarkable speed with which the US Congress passed the PETS Act indicates that our US Congressional representatives understood how important this issue was to their constituents.

Here in New Hampshire in 2006, we passed a law that requires that all efforts be made to keep service animals together with their human companions during a declared state of emergency (RSA 21-P:37-a).

We also have a very loosely organized network of volunteer Disaster Animal Response Teams (NH-DART) at several locations throughout the state. Some of the teams are affiliated with local animal shelters, some are not. In addition, private national animal protection organizations like HSUS and ASPCA sometimes provide assistance in disaster rescue situations. In 2020 the NH DHHS Department posted an employment opportunity for a part time manager for the NH DART system, but I don't know the current status of that position.

I believe that HB 1186 will bring much needed organization and clarity to New Hampshire's disaster evacuation plans for companion animals, and will also ensure that we are able to receive federal funds for disaster plans. I know that this is an extremely significant issue for NH citizens who love their animal companions and I strongly urge you to support it. Thank you.

According to <u>RSA 21-P:41 VI(c)</u>, "emergency management workers" that are not public employees are afforded the same rights as to compensation for injuries as are provided by law for state employees. Without a definition for "emergency management workers" it is uncertain what liability protection, if any, trained volunteers could expect. This makes it very difficult to recruit an emergency evacuation team for these purposes. Our recommendation is to explicitly provide disaster animal response team volunteers with the same protections outlined in this statutory section.

Dear Chair Pearl and Members of the House Committee on Environment and Agriculture:

Founded in 1884, the American Kennel Club (AKC) is a recognized and trusted expert in canine health, breeding, and training. We represent over 5,000 dog clubs nationally, including 14 in New Hampshire, which represent thousands of dog owners. We advocate for the purebred dog as a family companion, advance canine health and well-being, protect the rights of dog owners, and promote the ideals of responsible dog ownership.

HB 1186 would require shelters to accept companion animals during a declared state of emergency. AKC supports Representative Gallager's initiative in raising this safety issue. AKC Reunite, working in conjunction with AKC clubs, raises funds to help supply stocked mobile AKC Pet Disaster Relief Trailers, which deliver essential, nonperishable necessities to local emergency management to assist in sheltering pets when and where needed. The trailers provide animal care services during the first critical hours following a disaster, before FEMA support and services can be deployed. To date, 95 trailers have been deployed across the country and 12 more are on the way (according to this map).

Past experience indicates that pet owners will refuse to evacuate if leaving their companion animals in danger is their only option. After Hurricane Katrina, the United States Congress passed the <u>"Pets Evacuation and Transportation Standards Act of 2006,"</u> which requires State and local emergency preparedness operational plans take into account the needs of individuals with household pets and service animals prior to, during, and following a major disaster or emergency. In 2006, New Hampshire law required emergency shelters to also shelter service animals in accordance with <u>RSA 21-P:37-a</u>. *A detailed plan for the needs of New Hampshire individuals with household pets appears to be sorely lacking*.

AKC encourages the committee to consider two recommendations. First, fund a program manager position to work collaboratively with the state's emergency preparedness stakeholders in the identification of suitable and sufficient animal sheltering options. Individuals may be emergently sheltered at public schools or other large open areas, but sheltering unfamiliar animals together may not be appropriate. Second, these emergency evacuation efforts require a

Massachusetts also centrally coordinates reunification of pets with their owners after an emergency passes, rather than requiring individual owners to wholly take responsibility for reclaiming their animals. Their emergency preparedness plan reads, in relevant part, as follows:

"Coordinate resources to support animal rescue, evacuation, sheltering, and reunification." ⁹

There are states who do not handle reunification efforts however. For example, Louisiana requires that all registered animals be microchipped or photographed. After an emergency passes owners use these tools to find their animal and claim them. Owners are required to show identification and proof of ownership when reclaiming their pets. The state only supports reunification efforts as needed by individual municipalities who lack infrastructure to properly track pets via microchip or photograph.¹⁰

On the issue of what is done with unclaimed animals post emergency, states also differ. In states like Rhode Island, unclaimed pets are put up for adoption.¹¹ In other states like Tennessee unclaimed pets are "disposed of" after the emergency has subsided.¹²

3. How do other states handle the issue of pet sheltering in their emergency preparedness plans?

As previously discussed, states with an emergency preparedness plan are required to have a carve out for disabled people with service animals as prescribed by federal law. However, there are a variety of approaches that states take regarding how non-service pets are sheltered during an emergency. Requirements on what sort of measures must be taken at the state and local level on the issue of sheltering non-service pets in federal law (the PETS Act) are vague. None of the state laws, regulations or plans as of the writing of this memo require all hotels and community shelters state-wide to shelter pets with their owners.

The main area of difference between the various approaches state by state are in:

- (1) Who is responsible for making shelter arrangements (state / local emergency workers or individual citizens);
- (2) Who is responsible for reuniting sheltered animals with their owners after the emergency has passed (state / local emergency workers or individual citizens); and
- (3) What happens to unclaimed animals after an emergency passes.⁸

New Hampshire is an example of a state that places the burden of making shelter arrangements on individual citizens of the state. Other states, like our neighbor Massachusetts, make arrangements to shelter animals "in close proximity" to their owners. Massachusetts sees this as an important measure in assuring pet owners that they can visit their pets and easily be reunited with them after the emergency passes. Their emergency preparedness plan on this issue currently reads, in relevant part, as follows:

"... agencies and organizations will anticipate shelter missions and coordinate with MAESF-6 Mass Care, Emergency Housing, Human Services to identify emergency animal shelter facilities to ensure human sheltering and companion animal sheltering are in close proximity."

Massachusetts also leaves the decision as to how many, and which animals can be sheltered to the individual municipal governments. Their emergency preparedness plan on this issue currently reads, in relevant part, as follows:

"NOTE: Each municipality remains responsible to determine what animals they are able to shelter."

The state's emergency preparedness plan directs citizens who have non-service animal pets to do the following in relevant part during an emergency:

- "If you plan to shelter your pet work it into your evacuation route planning."
- "Pet shelters will be filled on first come, first served basis. Call ahead and determine availability."⁶

The state's current policy is that individual citizens make arrangements at pet shelters for their animals during emergencies. Currently, there are 48 pet shelters across the state in the following towns: ⁷

evacuate lost their lives.¹ The following year, Congress passed the Pets Evacuation and Transportation Standards Act of 2006 (PETS Act).

The act in relevant part, allows the Federal Emergency Management Agency (FEMA) to:

- (1) Provide funding to states and localities for the creation, operation, and maintenance of pet-friendly emergency shelters, along with other emergency preparedness actions for companion and service animals.
- (2) Reimburse state and local governments for rescuing, caring for, and sheltering animals in an emergency.

The PETS Act also defines how states and localities can receive funds for this opt-in program. It says that emergency preparedness plans created by states and localities must "account for the needs of individuals with household pets and service animals before, during and following a major disaster or emergency."² As of the writing of this memorandum, 30 states have adopted an emergency preparedness plan that meet this standard in various forms (statutes, administrative rules, and / or internal agency plans). Currently, none of them require that hotels and community shelters must shelter pet owners with their owners.

The only exception to this in every state's plan is a carve out for individuals who require service animals due to a disability. The Americans with Disabilities Act (ADA) exempts service animals from hotel and community shelter pet policies. Since this is a requirement imposed by federal law, all hotels and community shelters participating in emergency sheltering plans must accommodate disabled people with service animals in a state of emergency.³ Virtually every state with an emergency preparedness plan that addresses the issue of pet sheltering has this exception written into it.

2. What measures regarding the sheltering of pets during a state of emergency does New Hampshire currently have on the books?

RSA 21-P:37 directs the New Hampshire Department of Safety (DOS) to:

"VI. To prepare a comprehensive plan and program for the evacuation of search and rescue dogs and service animals, as defined in RSA 167-D."⁴

RSA 21-P:37-a further defines the state's policy on the issue of sheltering service animals:

"In cases of emergency, it shall be the policy of the state that service animals shall not be separated from the persons they serve. Every effort shall be made to keep service animals and the persons they serve together, and all appropriate state emergency planning and state sponsored emergency training shall be based on such assumptions."⁵

SUBJ: Laws in various states regarding the sheltering of animals with their owners during a state of emergency

- I. You asked whether there are laws currently on the books in various states similar to the idea proposed in HB1186, which would require both hotels and community shelters to shelter people with their companion animals in the same location.
- I. Short Answer: A federal law passed in 2006 sought to address the issue of a lack of shelter for pets during states of emergency. In response, 30 states adopted statutes, administrative rules, or created agency plans of action to accommodate pets and their owners during states of emergency. None of them currently require that pets and their owners be sheltered together in hotels and community centers. Most of them have an exception for service animals that assist people with disabilities.

1. What actions has the federal government taken on the issue of pet sheltering?

In 2005, Hurricane Katrina devasted New Orleans Louisianna and surrounding areas. One of the issues that faced evacuation and rescue efforts in the New Orleans area, was people who refused to evacuate. Of the individuals who refused to evacuate, 44% of them did not wish to evacuate because there were no animal friendly shelters in the near vicinity. Pet owners faced the choice of evacuating and leaving their pets to die or try to survive on their own as the hurricane devasted the community. As a result, countless people who refused to
