## Rep Baldasaro sponsor Support

For the last 5 or 6 years the school board has been denying any real opportunity for public comment, by taking public comment only at the end of the meeting. Sometimes that means they will have passed the item about which you wanted to speak. I hear this is happening around our state. Parents and all citizens have the right to speak before agenda items are dealt with. I went to the school board and told them we would do just what we are doing here.

**Q** Gordon: Should the period you desire be limited to Agenda items or wide open??

Ans: the door should be wide open. Q Langley: did the board give a reason for what they are doing? Ans: They said this was not a meeting for the public.; it was for the board to do the people's business.

Q DiLorenzo: How would putting the comment period at the beginning affect the agenda:

Ans: Why would people show up then? At the end is too late. It's a form of government control.

**Q Simpson**: At times we allow public comment just prior to the relevant agenda item. Is that flexibility for that?

Ans: I like that, so maybe that could be included. I hate to see every item held up for public comment though.

## Barrett Christina NHSBA Opposed

We are not opposed to public comment and our boards allow for that. The definition section needs help. All committees in this House hold hearings vice meetings. If this bill passes, each hearing will have to be preceded by a public comment period. The State Board of Education hasn't taken public comment in about a year.

**Q Notter**: The bill is about the start of the school board? The language of the bill applies it to all public bodies, as defined in RSA 91-A.

Q Gordon: Town meeting includes the election of officers. Comment period before?

**Ans**: The election is kind of a public meeting, kind of not. You may have to allow a public comment period, about anything, first.

## Natch Greyes NHMA Opposed

There are no exceptions included in the bill. Every board, even those where no ne normally attends, would have to hold the first 15 minutes for public comment. Town meeting would be the same. Non-public sessions might be in that position as well.

### Laurie Ortolano RTKNH Support

We propose the bill be amended as in my written testimony. I will send the Nashua public comment policy we adopted from Nashua. The idea boards would have to wait for comment when no one is in attendance has been addresses by ghe courts in other contexts and they have said that is similar to a provate meeting. Boards have been found to be justified of going into non-public session without stating gthe specific reason if no one was here. We are seeing a lot of interest in making the public voice louder at all kinds of meetings. It could be put on the agenda and everyone would know but few would avail the opportunity. Q Gordon: Have you thought about limiting it to school boards? Ans: If that would get the bill through, I guess it would be b better than nothing, but it also applies in other contexts.

Dear Honorable House Judiciary Committee Members:

I am writing to you as a cosponsor of **HB 1195** relative to public comment periods at public meetings. A public comment period at a public meeting is essential as it provides the opportunity for members of the public body to hear directly from the people who they govern and who are also affected by the decisions made by the public body. The opportunity for public input should unquestionably be placed at the beginning of a public meeting. This allows for the public to weigh in on topics on the agenda noticed for the present meeting before these items are discussed by the public body. Importantly, by placing a public input period at the beginning rather than at the end of a meeting, the public body may obtain relevant and important information from the public that serves to inform the public body regarding agenda items for which they may be acting upon, voting, during the course of the meeting. For this reason, waiting until the end of the meeting to allow for public input particularly on agenda items is unsound as well as counterproductive.

Public input placed at the end of a meeting, as some may suggest as preferable, would be most purposeful in allowing the public to comment upon topics *not* address at the present meeting and subsequently enable the public body to place such topics on a *future* meeting agenda.

Finally, while I understand that a public meeting is a business meeting, a balance must be achieved in order to both ensure and uphold the right of the people being governed to be heard at a public meeting. As a former Budget Committee member and chair, I understand this tradeoff firsthand; and that is why our state needs HB 1195. Public input governed by social norms at a public meeting should never be thwarted nor suppressed. The opportunity for public input at a public meeting is essential. In closing, HB 1195 serves to protect the voice of the people at public meetings in New Hampshire.

Therefore, I urge the committee to vote OTP on HB 1195.

## To the House Judiciary Committee:

I urge you to recommend ITL on **HB1195** requiring 15 minutes at the start of all public meetings to be set aside for public testimony. In a much earlier life I chaired the Atkinson Recreation Commission. More recently I served for 12 years on the Newbury Public Library board of Trustees, 8 of those years as chair. We rarely had anyone besides the board and library director, and when we did they were allowed to testify at the beginning or right after our discussion of a change to policy or at the end to comment on the budget. Reserving time at the beginning of a meeting would make no sense if the public comment were intended to apply to a decision or discussion we had not yet had.

I respect the intent of the bill, but I ask you to please respect that elected and appointed officials on NH's many local boards and committees should be the ones to decide when in a meeting it makes the most sense to allow public comment.

The Rivers Management Advisory Committee (RMAC) is writing to express its support with amendment of House Bill 1195, which would require a public comment period as part of any public meeting. The RMAC suggests amending the bill to strike "at the beginning of the agenda," and leave to the discretion of the chair when during the meeting to provide for public comment.

The RMAC supports this bill with specified amendment because

- Public comment allows members of the public body to hear from those most directly affected by the subject of the meeting;
- The material presented during the meeting may address the public's questions or concerns, meaning it will sometimes make sense for comment to be at the end of the agenda rather than the beginning; and
- Public bodies are diverse in their membership and missions. Chairs should have the discretion to place public comment at the time best suited for the way their meetings operate.

The RMAC is a legislatively created body charged to work with the New Hampshire Department of Environmental Services (NHDES) to administer RSA 483, the Rivers Management and Protection Program. The Governor and Council appointed Committee is composed of members from business, agriculture, hydroelectric, municipal government, water supply, conservation, recreation, fish and game, and historical interests.

Dear Representative Gordon:

The New Hampshire Municipal Association opposes HB 1195, requiring that "all meetings of a public body open to the public" governed by the Right-to-Know Law include a minimum 15-minute "public comment period" at the beginning of the meeting. The bill does not provide any exceptions to this 15-minute rule but does allow the chair to determine the length of time for each speaker and whether to extend the comment period.

Forcing a one-size-fits-all mandate on all boards for all meetings doesn't make sense, and doesn't allow boards to take into account different types of meetings. Take, for example, a board that must convene for the sole purpose of conducting a nonpublic session on a serious personnel-related matter. The board would be required to allow 15 minutes of public comment before they proceed. Yet, the board is only present for a nonpublic session. As all nonpublic sessions start in a public meeting, if this bill were enacted, the board would be required to have 15 minutes of public comment.

The thousands of municipal boards across the state already have public comment periods, and tailor those periods to the kinds of attendance that they see and the type of meeting that is being conducted. Boards that don't see much public attendance, such as cemetery trustees, often wouldn't need 15 minutes for public comment on the rare occasion that a member of the public shows up, and board that *do* see broad public attendance by-and-large already have created public comment periods. It is unnecessary to mandate that every board have a 15-minute comment period at every board meeting. For these reasons, we ask the committee to vote to recommend HB 1195 as Inexpedient to Legislate.

A public comment period at a public meeting is essential as it provides the opportunity for members of the public body to hear directly from the people who they govern and who are also affected by the decisions made by the public body. The opportunity for public input should unquestionably be placed at the beginning of a public meeting. This allows for the public to weigh in on topics on the agenda noticed for the present meeting before these items are discussed by the public body. Importantly, by placing a public input period at the beginning rather than at the end of a meeting, the public body may obtain relevant and important information from the public that serves to inform the public body regarding agenda items for which they may be acting upon, voting, during the course of the meeting. For this reason, waiting until the end of the meeting to allow for public input particularly on agenda items is unsound as well as counterproductive.

Public input placed at the end of a meeting, as some may suggest as preferable, would be most purposeful in allowing the public to comment upon topics *not* address at the present meeting and subsequently enable the public body to place such topics on a *future* meeting agenda.

Finally, while I understand that a public meeting is a business meeting, a balance must be achieved in order to both ensure and uphold the right of the people being governed to be heard at a public meeting. As a former Budget Committee member and chair, I understand this tradeoff firsthand; and that is why our state needs HB 1195. Public input governed by social norms at a public meeting should never be thwarted nor suppressed. The opportunity for public input at a public meeting is essential. In closing, HB 1195 serves to protect the voice of the people at public meetings in New Hampshire.

Therefore, I urge the committee to vote OTP on HB 1195.

## In the Year of Our Lord Two Thousand Twenty Two

AN ACT relative to public comment periods at public meetings.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 1 New Paragraph; Access to Governmental Records and Meetings; Meeting Open to the Public; 2 Public Comment. Amend RSA 91-A:2 by inserting after paragraph III the following new paragraph: 3 IV. All meetings of a public body open to the public under this chapter shall include a period 4 of public comment at the beginning of the agenda for the meeting. The chairperson may determine the length of time, for both total time and individual time, for the public comment but shall not limit 5 6 or censor the content of the public comment; provided, however, that the period of public comment 7 shall not be limited to a total time period of less than 15 minutes unless no further public comment 8 is offered.
  - 2 Effective Date. This act shall take effect 60 days after its passage.
