2 New Section; Game Animals; Transportation of Deer; Online Registration. Amend RSA 208 by inserting after section 15-g the following new section:

208:15-h Online Deer Registration. The executive director shall cause to be established an online registration system on or before September 1, 2023 for the purpose of registering deer killed in the state. The executive director shall act as the registration agent for deer registered through the online registration system. The requirements, procedures, and fees for online registration shall be similar to those used at deer registration stations. The executive director shall adopt rules pursuant to RSA 541-A specifying the necessary requirements, procedures, and fees for the use of the online registration system.

- 3 Emergency Closure; Limitation on Availability. The executive director may, by administrative rule adopted pursuant to RSA 541-A, limit the availability of online registration on days designated for biological sample collection and suspend online registration in the event of a wildlife or public health emergency, with the consent of the commission.
- 4 Effective Date. This act shall take effect 60 days after its passage.

<u>Rep Pearl</u> – Allows online registration of deer, department working on navigating process and thought they might need legislation, there is an amendment that will be spoken to which changes the bill to exactly to what they need

*<u>Dan Bergeron, NHFG</u> – amendment allows in person sampling from deer, collect weight, antler characteristics, reproduction, biological samples, for example blood samples in conjunction with HHS for covid screening. This allows requiring occasional physical presentation on deer

Spillane – biggest reason to need requirement is to keep a handle on chronic wasting disease, can wildlife management require it for certain parts of the state only and not all

Bergeron – I believe so, often take samples from butchers but we need to be able to collect from stations in case we get CWD

Rep Lekas - any concern if hunters switch to online that we will lose our check in stations

Bergeron – we are still trying to figure it out but we went to online for turkey and about half register in person 2 years later, but this is an internal issue to work out but this allows us to set up the online

Rep Howard - I don't see fees, will there be

Bergeron - there is wording to allow fees by rule

Howard - same price?

Bergeron - should be but through a contracted vendor, but similar

Rep Khan – every year we hear other states are doing it why can't we...why can't we follow what other states are doing

Bergeron – Currently MA and VT both do what we are proposing with both, in Maine it is completely in person. Most states that have fully remote options have many more deer than we do, those states harvest over 100k deer, which is what we have in person

Rep Laflamme – I am not sure if you can answer but does enforcement have reservations about access to online registration information?

Bergeron - it will be an adjustment, we have had this conversation and started this with turkeys but we are working on it so they can access it

Dear esteemed Committee Members -

I write to voice my strong support for HB 1230-FN, which would allow for the online "check-in" of deer harvested in NH. As you are likely aware, hunters who take a deer must check it in at a predetermined site, often a local general store. In recent years, the list of proprietors offering check-in services appear to be dwindling — the check in process is somewhat administratively taxing (a clerk must fill out a form while other customers wait, and visually observe the deer being tagged by the hunter), and as such these retailers appear to be making the decision that the increased foot traffic and the *de minimus* check-in fee are not worth the administrative burden.

Practically speaking (and depending on the weather conditions), the check in process impedes the cooling of the carcass, and increases the risk of spoilage and bacterial growth. A long check-in process can allow for too much bacterial growth and risks the food-safe nature of the meat, especially if a deer is "gut shot", allowing the bacteria rich contents of entrails and organs to touch muscle tissue. Personally, I took a deer in November of 2020 during an unseasonably hot day (it was 72 by mid-morning); I felt I had to race to break the deer down after a long trip to the closest station, an extended wait while the overextended clerk checked in a long line of hunters (and attempted to service customers simultaneously), then a return drive. Had my deer been gut shot, I likely would have lost a significant amount (if not all) the meat from the animal.

To state the obvious, online check-in of deer will ameliorate this problem. I will miss the camaraderie of the check-in process, but the reality is that the number of check-in stations have shrunk to such a degree that it is not practical to have all successful NH deer hunters physically bring their deer to a dwindling number of check-in stations. I think online check-in will also result in a more accurate tabulation of the season's take, which is vital to herd management: we should make it as easy as possible for hunters to report their sucess, such as to get the most accurate numbers possible. To that end, I ask that you find that HB1230-FN Ought to Pass.

I also take this opportunity to voice my opposition to HN 1308 – this will cripple hunting dog training in NH, as well as destroy hunting club and dog trial operations; I suspect this is the ulterior motivation behind the bill. To the extent the concern is that captured hares are being mistreated in captivity, animal cruelty laws exist to address that concern – those who are cruel to animals may be prosecuted criminally. To that end, I ask that you find that HB 1308 is Inexpedient to Legislate.

Testimony in support of HB 1230-FN as amended, an act permitting online presentation of deer for registration.

House Fish and Game and Marine Resources Committee January 14, 2022

Mr. Chairman and members of the Committee, thank you for the opportunity to speak with you today. My name is Dan Bergeron. I am the Chief of the Wildlife Division for the Fish and Game Department. I'm here today representing the Department and the Fish and Game Commission in Support of HB 1230-FN as amended, an act permitting online presentation of deer for registration.

The Department relies on data collected through mandatory registration of harvested deer to effectively manage the state's deer herd. Historically this data has been collected at physical deer registration stations. These stations are typically operated out of local businesses such as sporting goods shops, convenience stores, and hardware stores. In the past few years however, it has become more difficult for the Department to find businesses who are interested in registering deer and the number of stations across the state has declined. As a result it has become more difficult for hunters to find a convenient, open station to register their deer in a timely manner.

Moving forward, the Department would like the ability to allow hunters to register their deer themselves online to provide a more convenient option. Current language in RSA 208:15 does not allow the Department to institute an online deer registration system. Therefore we are supportive of the intent of this bill as it would provide that authority. However, the Department also needs the flexibility to require hunters to register deer in person at a physical registration station at certain times throughout the season. Mandatory in-person registration allows the Department to collect necessary, detailed biological information to help track the health of the state's deer population. Currently, Biologists are staffed at our highest volume stations, during the busiest days of the season and collect information on ages, weights, antler measurements, productivity measurements, and various other biological samples. This past year for example the Department partnered with NH Health and Human Services and USDA APHIS to collect blood samples from deer to screen for various mosquito borne diseases and SARS-CoV-2 antibodies in deer. The ability to require hunters to register deer in person allows us to obtain an adequate and unbiased sample of harvested animals. The amendments which have been proposed to this bill would provide us that ability.

I would like to thank the Committee for allowing me to testify before you today and respectfully request the Committee members vote in Support of HB 1230-FN as amended.
