It was suggested that this might be better handled as a contractual issue. While it is important to ensure that there are defined rules for business contributions directly to NH state agencies, candidates, or PACs that are self serving in nature, this legislation is too broadly worded and could have unintended consequences on work outside of the State.

I am writing to urge you to support several bills to help us maintain election integrity in NH. I personally believe that election integrity is the most important issue was are facing, since all our other rights and freedoms stem from a fair and free election.

I closely followed the events that happened in Windham, and attended several meetings to try to understand what could have caused such a large discrepancy in the vote. As a result of what I learned, I also went to my own town hall in Goffstown to request the machine tapes to see if we also had problems. As I learned about duplicate tapes and overvotes, I realized how confusing and time consuming this process is to ensure we have transparent and fair elections. I would urge you to support the following bills:

HB1470 Requires Voting Machines to show the number of Overvotes for each Race on the Ballot The Windham vote showed a machine error, when compared with the hand recount. The overvotes were incorrectly registered by the machines for those individuals. We need to know if the machines are not functioning properly.

HB1527 Voting Machine Paper Tapes & Results for each Machine, for each Town Published on NH SOS Web Page.

I learned first hand how time consuming and confusing it is to go to my Town Hall to request the Voting Machine Tapes. It took several trips to get all the information, since I was given copies of duplicate tapes, but not all the originals. It is imperative to have access to this data to ensure election integrity for each town.

HB1496 Mandate Voter Checklists are Available in Spreadsheet Format Allow for the access of voter checklists to allow the public to verify the integrity of elections.

HB1252 Prohibits Any Business Organization That Receives Grants from the State of NH from Making Political Contributions to Candidates and Political Committees

This bill is essential to ensure that organizations who receive grant money do not then make political contributions to the politicians that wrote and supported their bill. This is an obvious conflict of interest.

HOUSE BILL 1252

AN ACT relative to political contributions made by certain business entities.

SPONSORS: Rep. Love, Rock. 6; Rep. Potucek, Rock. 6

COMMITTEE: Election Law

ANALYSIS

This bill prohibits any business organization that receives grants from the state of New Hampshire from making any contribution to any candidate or political committee.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Two

AN ACT relative to political contributions made by certain business entities.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 New Paragraph; Political Expenditures and Contributions; Prohibited Contributions. Amend 2 RSA 664:4 by inserting after paragraph V the following new paragraph:
- 3 VI. By any person or business entity that has received any grant from the state of New
- 4 Hampshire in the last 2 years.
- 5 2 Effective Date. This act shall take effect 60 days after its passage.
