STATEMENT OF INTENT

This bill seeks make immunization status a protected class under the state's anti-discrimination law. If passed, this proposed law would apply to all immunizations, even the CDC-recommended disease prevention protocols and laws requiring children to be vaccinated before attending public schools. In the case of the COVID-19 vaccination, immunization is a choice. There are no laws; federal, state, or local, that mandate COVID-19 vaccinations. Because there are no laws that mandate COVID-19 vaccination, it would be an error to add immunization status protection to RSA 354-A, New Hampshire's Human Rights Statute. If passed, this bill would allow citizens to file a civil rights complaint with the New Hampshire Human Rights Commission if they were denied a job, housing, or entrance to public accommodation sectors, based on immunization status. If this bill were to pass, this could place a heavy burden on the staff of the Human Rights Commission and prevent work on serious matters from being adjudicated.

Rep Harvey-Bolia Sponsor Support

The bill adds immunization or vaccine status to the protected classes list in RSA 354. This is an extension of already identified disability status. It would protect those who refuse

vaccines/immunization under employment law and public accommodations law, etc. Civil rights are a class of rights protecting people's views/ Msomi physical disabilities can be controlled so

immunization falls into that category. When personal health autonomy is a growing concern, we need to choose which side we are on in terms of this civil right. People of color and Hispanics are by far the least vaccinated and allowing discrimination on that basis is tantamount to racism, this type of bill is under consideration and has already passed in Montana. In Colorado, black leaders testified the black community is very hesitant to take the vaccines because of history of other government actions.

Q Notter: Have you consider "conscientious objection" language?

Ans: There are other bills using that language.

Q Sylvia: Would this give those who refuse vaccines immunity from getting/spreading the disease? **Ans:** There is evidence the vaccines have no benefit.

Q Horriggn: Does this apply to all vaccines?

Ans: Yes,

Q Do we have a natural/civil right to spread disease?

Ans: Having viral disease is a natural condition.

Q Do we have a right to spread a deadly virus? Ans: We have a civil right to bodily integrity and this falls into that category.

Q Smith: Are you saying there is no circumstance under which the government has the right to interfere with the bodily integrity of any individual?

Ans: This bill deals only with employment and other protected categories.

Q Sylvia: At what point should people be considered to be carrying viruses hazardous to other people?

Ans: I am not a medical professional and can't say.

Q Should we presume everyone around us is carrying a disease that will harm us?

Ans: I guess so. We have virologist to help us, but the more widespread a virus is the less lethal it is, it seems. That is the typical development of a virus. Each variant of

Covid had been less lethal.

Q: DiLorenzo: Please expand on th idea that physical disabilities can be controlled?

Ans: I think I said some disabilities, like overweight, can be controlled.

Q Gordon: Currently schools require immunizations, how would this effect that?

Ans: I believe it is possible this could affect schools just as gender identity applies to them.

Q Immunizations isn't the same as the vaccine for Covid. Would this cover the Covid shots?

Ans: You could have immunity by having had Covid, but that isn't how its working out for people. The question is do you believe it is a civil right that needs protecting.

Q Wouldn't it be better to say vaccination status?

Ans: I'm open to that. I was only thinking about the Covid situation where the Covid shots is not really a vaccine. In the future they may not even call it a vaccine. Another possibility would be to call it medical treatment.

Q Would this apply in the Australian situation with a noted Tennis player?

Ans. All kinds of specific cases could arise as they do with other rights.

Q Sylvia: Do you think school children are discriminated against based on their age?

Ans: Not sure what you are getting at. If you mean sorting them by age isn't discrimination or a civil rights violation.

Q If a child could sue against discrimination for age, would they also be able to sue over this? **Ans:** I don't know if they can in either case.

Q Notter: The law exempts relifgio8us belief but not consicientio8us objection? **Ans**: Don't know.

Q Are you aware of that CDC has changed the definition of vaccine?

Ans: Yes. It makes it difficult here.

Q Smith: Do you think it would be a legitimate case if one representing a three-year-old could sue the government over the rule that that child could not be vaccinated because of their age? which is discriminatory

Ans: This isn't really ab out forcing vaccines or taking vaccines and the particulars surrounding that like the age for which vaccination is safe. We could probably do the speculative 'what ifs' all day, but the way I see it, it's not much different than a physical disability or a choice like gender or marital status.

*Kathy Bizarro-Thunberg Exec VP NH Hospital Association Opposed

We don't believe it is appropriate to include this kind of thing in discrimination law. It will only lead to more conflict and confusion between employees and employees. The vast majority of our employees have been vaccinated or gotten exclusions.

Q Sylvia: If 60% of staff would refuse shots, would that be a problem for the health care system? **Ans**: We haven't seen that.

Q: Have staffing levels been affected by the vaccine requirement?

Ans: We have had shortages since before the vaccine mandate and we have had very few who have left because of it.

Q DiLOrenzo: Would this bil affect [payments from Medicare to hospitals?

Ans: I am not sure. We have a serious concern with adding vaccination status as a protected class because I we have a mandate:

Q Sylvia: So, you are discriminating again those with natural immunity?

Ans: No. We require everyone to be vaccinated regardless of their personal experience.

Gary Yorks Humanity Supports

I see this as medical information which we shouldn't be required to share with other people. There is no difference between asking about vaccination than from asking if you have been treated for STDs or many other questions of similar nature. The vaccination mandates have been implemented out of fear. We have done little to find treatments for Covid and have sold the vaccines as the only hope to allay that fear. Some people feel it is a human right to not have things injected into their body. The CDC VAERS system has reported over 20,000 deaths thought to have come from the vaccine. The vaccinated population should have no need to know the vaccination status of anyone else. We are discriminating against the unvaccinated and this bill is necessary to protect them. **Q** Sylvia: Are you familiar with Dr Mark McDonald?

Ans: No.

Ahni Malachi Exec Dir Human Rights Commission Information only

When we looked overt his bill, there were questions for us, the definition speaks to employment only while the text talks to other areas. Regarding the question of schools, the law covers education.

Q Sylvia: Can you clarify the difference between civil right and human rights? Ans: No.

Q Have there been complaints brought against employers discriminating against the unvaccinated? **Ans**:I would have to dig through our records. Since immunization status isn't currently covered by the statutes, I would have to see if we have gotten any calls.

Q Could not being vaccinated be considered a mental disability under the statute?

Ans: We would have to consult the appropriate experts on the law.

Q How would you handle these cases?

Ans: The same way we handle all others. This would cover education, schools, access to stores, and many other potential areas. The question would be what the workload wou9ld be.

 ${\bf Q}$ Historically there had been a concern about the speed of enforcement. Is there a concern over the potential volume of claims.

Ans: With only five investigators, we would need more hands. We've taken actions to reduce some of the burden on the investigators, additional staff, improving our process, etc. The new work could be a problem, but there is no way of knowing. When education was added, we didn't see any significant increase in cases.

Q DiLorenzo: How can vaccine status become a protected class when it doesn't seem to meet the definition of protected class?

Ans: The original civil rights act dealt only with immutable classes, but if the law changes, we will do what is required.

Wayne Knightly Suports

I work in a local hospital and there are certain exemptions, but from what I have seen, people are being discriminated against based on their vaccination status. Things like where they eat lunch and other things. Vaccination status should be protected information.

Q Chase: Do people know others' vaccination status?

Ans: Not explicitly, but yes, people know who is and is not vaccinated.

Q DiLorenzo: How do people at your work know?

Ans: I can't say exactly. I see this bill as saying you don't have any right to know if I have taken the shots or not.

Our high-school-aged daughter wonders which colleges she will be eligible to apply to? Even if she can choose freely, are they in towns that will welcome her and allow her to enjoy social activities with her friends?

Professionally, as adults, we have been forced to consider that, in addition to educational rights, we may lose the right to earn an income, take a trip to see family, enter the nursing home where our mother resides, or any other myriad of freedoms.

Our family is currently essentially banned from enjoying much of anything to enjoy in the United States cities of: New York City, Boston, Minneapolis/St. Paul, Los Angeles, Salem, MA, Washington DC, San Francisco, and Los Angeles. We are likely missing some additional locations—as the list grows longer, our sense of doom, exclusion, and fear for our children's future increases and we begin to lose track of some of the details—but the message of where we now stand could not be any clearer.

Do you have any idea how it feels to know your children will potentially never see the historical collections in Boston or experience the museums of New York City? Never eat real NY Pizza in a restaurant, or see a rock concert in San Francisco? Despite the fact that a mere six months ago they could have? It feels like a G-damn nightmare that will never end. It feels like our entire connection to story and collective artifacts and generational experiences, and identities as Americans--born here because our grandparents and great-grandparents came here for more freedom--has been severed. But not by choice. Without an ounce of ceremony or even public debate, this was taken from us. So fast, most days we aren't even fully able to process it.

We are among a group of "refugees" who have fled to NH in the last two years for something very simple and which many of us perhaps took for granted—freedom.

Anyone who cannot see that as a nation have sped toward creating an entirely second-class of citizens based on one criteria; with many of our fellow citizens gleefully willing to circumvent their own rights along with others for an easy solution to a complex problem—is just plain blind.

In so many ways, and for so many people, the protected class status tied to immunization status is now absolutely required.

We know we can do better than this as Americans, and we believe NH has the right leaders to make sure we do. Being proactive about this matter couldn't be anymore essential than it is at this moment. Clearly we are in the process of losing this battle in multiple states across the US right now. Do not let NH fall! Please miss this opportunity to protection under the law for our family and so many others in NH.

Thank you to the authors and sponsors of this bill and to all who vote to support it. To those who do not, I hope you consider what you would say to our family in person and how ethically and morally you could justify looking us in the eye and uttering any such explanation.

Testimony

Good morning, Mr. Chairman and members of the committee. My name is Kathy Bizarro-Thunberg, Executive Vice President with the New Hampshire Hospital Association (NHHA), representing all 26 of the state's community hospitals as well as all specialty hospitals.

The NHHA is opposed to HB 1260. The bill before you would make immunization status a protected class.

We do not believe it is appropriate to include "immunization status" as a protected class under the State Commission for Human Rights. This committee heard a similar bill last week, HB 1519, which we also testified in opposition. This bill as well as other bills before this committee, attempts to insert additional "classes" into the statute that protects individuals from discrimination is not appropriate. We believe all these bills are focused on, without explicitly stating such, an attempt to insert vague language into the statute against the COVID-19 vaccine. The result of all these bills will just lead to lawsuits and further confusion among employers and employees.

It is NHHA's position that employers have the right to determine what is best for their employees and their clients, patients, and/or patrons. Requiring vaccinations of healthcare workers from communicable diseases is not new for hospitals in New Hampshire. Hospitals have required vaccination against several communicable and deadly diseases such as mumps, measles, rubella, chicken pox, diphtheria, tetanus, pertussis, and influenza as a condition of employment, with the same type of medical and religious exemptions allowed for the COVID-19 vaccine. We believe requiring vaccinations is absolutely the right thing to do for the health and safety of our patients, our staff, and the citizens of New Hampshire. The vast majority of hospital staff have been vaccinated against COVID-19 or have received exemptions, and we've heard from many healthcare workers who support the vaccine requirement to protect their health and that of their patients.

We are opposed to HB 1260, and we urge the committee to find this bill Inexpedient to Legislate. Thank you for the opportunity to provide our comments on HB 1260.

- Children must have proof of all required immunizations, documentation of immunity, or valid exemptions, in order to be admitted or enrolled in any school in New Hampshire. Documentation of immunity by confirming laboratory test is acceptable for Measles, Mumps, Rubella, Varicella, and Hepatitis B.
- A child may be "conditionally" enrolled when the parent or guardian provides:
 - 1) Documentation of at least one dose for each required vaccine; AND
 - 2) The appointment date for the next dose of required vaccine.
- All immunizations must meet minimum age and interval requirements for each vaccine. A 4-day grace period is allowed; however, live attenuated vaccines (MMR, Varicella, or nasal influenza vaccine) that are not administered on the same day must be administered at least 28 days apart.

This is an important and needed bill. It would be good if "immunization status" were recognized for all diseases for which there is a vaccine and even those without vaccines. It's science. Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Title and Purposes of Chapter; Immunization Status Added. Amend RSA 354-A:1 to read as 2 follows:

3 354-A:1 Title and Purposes of Chapter. This chapter shall be known as the "Law Against 4 Discrimination." It shall be deemed an exercise of the police power of the state for the protection of the public welfare, health and peace of the people of this state, and in fulfillment of the provisions of 56 the constitution of this state concerning civil rights. The general court hereby finds and declares 7that practices of discrimination against any of its inhabitants because of age, sex, gender identity, 8 race, creed, color, marital status, familial status, physical or mental disability, *immunization* 9 status, or national origin are a matter of state concern, that such discrimination not only threatens 10the rights and proper privileges of its inhabitants but menaces the institutions and foundation of a 11free democratic state and threatens the peace, order, health, safety and general welfare of the state 12and its inhabitants. A state agency is hereby created with power to eliminate and prevent 13discrimination in employment, in places of public accommodation and in housing accommodations 14because of age, sex, gender identity, race, creed, color, marital status, familial status, physical or 15mental disability, *immunization status*, or national origin as herein provided; and the commission established hereunder is hereby given general jurisdiction and power for such purposes. In addition, 1617the agencies and councils so created shall exercise their authority to assure that no person be 18discriminated against on account of sexual orientation.

19 2 New Paragraph; Religious Belief. Amend RSA 354-A:2 by inserting after paragraph IX the
 20 following new paragraph:

IX-a. "Immunization status" means immunization history as it relates to employment immunization requirements. In this paragraph, "immunization" means the process whereby a person is made resistant to an infectious disease, typically by the administration of a vaccine.

3 Opportunity for Employment Without Discrimination; Immunization Status. Amend RSA
 354-A:6 to read as follows:

26 354-A:6 Opportunity for Employment Without Discrimination a Civil Right. The opportunity to 27 obtain employment without discrimination because of age, sex, gender identity, race, creed, color, 28 marital status, physical or mental disability, *immunization status*, or national origin is hereby 29 recognized and declared to be a civil right. In addition, no person shall be denied the benefits of the 30 rights afforded by this section on account of that person's sexual orientation.

31 4 Unlawful Discriminatory Practices. Amend RSA 354-A:7, I-III to read as follows:

I. For an employer, because of the age, sex, gender identity, race, color, marital status, physical or mental disability, *immunization status*, religious creed, or national origin of any individual, to refuse to hire or employ or to bar or to discharge from employment such individual or to discriminate against such individual in compensation or in terms, conditions or privileges of employment, unless based upon a bona fide occupational qualification. In addition, no person shall be denied the benefit of the rights afforded by this paragraph on account of that person's sexual orientation.

8 II. For a labor organization, because of the age, sex, gender identity, race, color, marital 9 status, physical or mental disability, *immunization status*, creed, or national origin of any 10 individual, to exclude from full membership rights or to expel from its membership such individual 11 or to discriminate in any way against any of its members or against any employer or any individual 12 employed by an employer, unless based upon a bona fide occupational qualification. In addition, no 13 person shall be denied the benefit of the rights afforded by this paragraph on account of that person's 14 sexual orientation.

15III. For any employer or employment agency to print or circulate or to cause to be printed or circulated any statement, advertisement or publication, or to use any form of application for 1617employment or to make any inquiry or record in connection with employment, which expresses, 18directly or indirectly, any limitation, specification or discrimination as to age, sex, gender identity, 19race, color, marital status, physical or mental disability, *immunization status*, religious creed or 20national origin or any intent to make any such limitation, specification or discrimination in any way 21on the ground of age, sex, gender identity, race, color, marital status, physical or mental disability, 22*immunization status*, religious creed or national origin, unless based upon a bona fide 23occupational qualification; provided, however, that nothing in this chapter shall limit an employer 24after the offer of hire of an individual from inquiring into and keeping records of any existing or preexisting physical or mental conditions. In addition, no person shall be denied the benefit of the 2526rights afforded by this paragraph on account of that person's sexual orientation.

5 Equal Housing Opportunity Without Discrimination; Immunization Status. Amend RSA 354A:8 to read as follows:

29 354-A:8 Equal Housing Opportunity Without Discrimination a Civil Right.

The opportunity to obtain housing without discrimination because of age, sex, gender identity, race, creed, color, marital status, familial status, physical or mental disability, *immunization status*, or national origin is hereby recognized and declared a civil right. In addition, no person shall be denied the benefit of the rights afforded by this section on account of that person's sexual orientation.

6 Unlawful Discriminatory Practices; Immunization Status. Amend the introductory paragraph

It shall be an unlawful 15discriminatory practice for any person, being the owner, lessee, proprietor, manager, superintendent, 16agent or employee of any place of public accommodation, because of the age, sex, gender identity, 17race, creed, *immunization status*, color, marital status, physical or mental disability or national origin of any person, directly or indirectly, to refuse, withhold from or deny to such person any of the 1819accommodations, advantages, facilities or privileges thereof; or, directly or indirectly, to publish, 20circulate, issue, display, post or mail any written or printed communication, notice or advertisement 21to the effect that any of the accommodations, advantages, facilities and privileges of any such place 22shall be refused, withheld from or denied to any person on account of age, sex, gender identity, race, 23creed, *immunization status*, color, marital status, physical or mental disability or national origin; 24or that the patronage or custom thereat of any person belonging to or purporting to be of any 25particular age, sex, gender identity, race, creed, immunization status, color, marital status, 26physical or mental disability or national origin is unwelcome, objectionable or acceptable, desired or 27solicited. In addition, no person shall be denied the benefit of the rights afforded by this section on 28account of that person's sexual orientation.
