Rep. Rung: Are governing boards the ones that make the decision? ANS: Usually town managers grant those permits. The town should be the people to grant the closure.

Rep.Gallager: I live in a city. Warrant articles are for towns not cities. Would this apply to cities? ANS: Yes.

Rep. Vann: What is the problem we are trying to solve? ANS: The closure of roads is taking money from the people. It is a fraud.

Rep. Maggiore: You need to declare the road and sidewalks that are to be closed. We would have to state the roads to be closed. ANS: That is correct. The town's people should be able to use the roads that they paid for.

Katherine Heck, NH Municipal Association - Opposes the bill. RSA 32:10, municipal budget law. Governing body can make the decisions.

Rep. Vann: You keep me from driving on the road? ANS: I am not sure what the sponsors intent is.

HOUSE BILL **1267** 

AN ACT relative to municipal authority for road and sidewalk closure.

SPONSORS: Rep. Yokela, Rock. 33

COMMITTEE: Municipal and County Government

### ANALYSIS

This bill requires cities and towns to grant power to their governing board to shut down public roads and sidewalks for recreation or parades, and permits cities and towns to revoke that power.

Explanation:

#### HB 1267 - AS INTRODUCED

#### STATE OF NEW HAMPSHIRE

### In the Year of Our Lord Two Thousand Twenty Two

AN ACT

relative to municipal authority for road and sidewalk closure.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Legislative Findings. The general court find that municipal budgets have a purpose listed for 2 the sum to be raised from taxes, and that raising taxes for one purpose and then allowing use of 3 those funds for another purpose is fraudulent. Furthermore, the general court finds that the 4 taxpayers in a community should have a say in determining whether and to what extent travel 5 within their community is interrupted, and taxpayers may wish for community events to be held in 6 recreation areas so as to limit any interference on travel within the community.

2 Powers and Duties of Towns; Street Fairs. Amend RSA 31:100 to read as follows:

31:100 Street Fairs.

9 I. Interference with the intended use of roads and streets for uses other than 10 maintenance and safety is prohibited without the passage of a warrant article that grants 11 the selectmen of a town or governing body of a city [may] power to grant a license in writing to any 12 person or persons to use and occupy a portion of any street or sidewalk specified in such warrant 13 article, as may be designated in general or in specific terms, for the purpose of conducting thereon 14 street fairs or other community events, including but not limited to the sale of merchandise by 15 commercial retailers, or by community associations conducting street fairs or other promotions. 16 Such licenses may include the right to encumber the designated area with boxes, shelves, stands and 17 other devices useful in conducting such sales and shall be issued for not in excess of 3 consecutive 18 business days. Licenses may also be subject to such other terms and conditions, to be expressed in the license, as the public convenience and safety may require. Warrant articles granting the 19 20 power to the governing body pursuant to this section shall include:

(a) The specific dates or maximum number of days or hours per year travel on
 the road and/or sidewalk may be interrupted for uses other than maintenance or safety.

(b) The road and/or sidewalk which are to be granted the exemption.

(c) If the exemption is perpetual or time-limited.

II. The power granted under a warrant article may be revoked by passage of a
warrant article stating the road(s) and/or sidewalk(s) and the date of the end of the power
granted.

3 Games, Amusements, and Athletic Exhibitions; Parades. Amend RSA 286:2 to read as follows: 286:2 Theatricals; Parades; Meetings. No theatrical or dramatic representation shall be 30 performed or exhibited, and no parade or procession upon any public street or way, and no open-air 31 public meeting upon any ground abutting thereon, shall be permitted, unless *the power to grant a*

- 1 license has been adopted for that public street or way pursuant to RSA 31:100, and a special
- 2 license therefor shall first be obtained from the selectmen of the town, or from a licensing committee
- 3 for cities hereinafter provided for.

4 4 Effective Date. This act shall take effect 60 days after its passage.
