Testimony for HB 1271 Limiting the authority of the Department of Health and Human Services to mandate vaccinations and relative quarantine costs Health and Human Services Elderly Affairs Committee, Legislative Office Building Monday, February 14, 2022

Dear Chairman Pearson and Members of the Committee:

The Department of Health and Human Services is opposed to HB1271. The proposed legislation intends to amend RSA 21-P:53, V which relates to the authority of the Commissioner of Health and Human Services guided by RSA 141-C, the communicable disease statute, during a state of emergency.

The bill would require the Commissioner of Health and Human Services to be subjected to additional legislative oversight during the course of an investigation of any incident or imminent threat of disease pursuant to RSA 21-P:53, IV that would involve immunization. Currently, per RSA 21-P: 53,V the Commissioner may order an individual to undergo medical treatment including immunization as may be necessary to address a public health incident or threat of disease. HB 1271 proposes that any order that would require a person or persons to be immunized be subject to an approval vote of two thirds of the legislature before this action could take place. It also proposes a repeal of RSA 141-C: 15,V relative to the cost for maintenance of quarantine.

The statute with its current language serves as a protective mechanism for the Commissioner to have the authority to isolate, quarantine or control access to an exposure is designed to protect public health during a state of emergency. Actions and directives given during this time are based on consultation with epidemiologists, and other doctors when considering complex, ethical decisions related to medical care or immunizations to prevent the spread of communicable disease.

The Department is very concerned that by the time the legislature had gathered, and considered any proposed action, any delay would put at risk the emergency nature of any intended order to protect public health.

It may be too late to mitigate an outbreak or public health incident that any order was intended to address. The Department has serious concerns that consideration by the legislature of individual orders could present significant privacy issues related to protected health information.

In addition, HB 1271 has a statutory defect on line 8 of the bill as RSA 141-C:15, VI is referenced which is prior law. Last session in HB 187- *relative to the emergency powers of the Commissioner of Health and Human Services* which became law in August of last year, that reference was changed to RSA 141-C:16 which provides for an exemption from treatment for religious reasons as long as there is compliance with the sanitary, isolation and quarantine requirements as relates to the threat of a communicable disease. Also referenced here per HB 187 is RSA 141-C: 20-c, which relates to the provisions for medical and religious exemptions for children. Of course, Individuals also have due process under RSA 141-C: 14-a.

The Department is concerned with proposed provision for legislative oversight in HB 1271. It would hamper the ability for addressing emergent public health threats quickly and efficiently. The Department has concerns with HB1271 as there are adequate safeguards in place currently to protect individual rights while simultaneously providing public health protection currently afforded by RSA 21-P:53.

All 3 letters re-state the CBHA policy on vaccines, shared with you earlier as testimony on HB 1224, prohibiting health care providers from refusing to provide care or services based on patient vaccination status:

The NH Community Behavioral Health Association (CBHA) would like to thank its Community Mental Health Center members and the thousands of Community Mental Health Center NH Employees for all their efforts to stay up to date and vaccinated for the best health and safety of the patients they serve. NHCBHA believes that our state's public health policies should be based on scientific research, and medical literature, and reputable sources like the Centers for Disease Control and Prevention. At a time when the intense public health danger associated with the COVID-19 pandemic is being exacerbated with misleading and inaccurate information about basic public health norms – including vaccines, mitigation measures, and responsible public behavior – and is being amplified in public arenas, establishing this baseline of relying on trusted and informed voices is critically important.

Vaccines have worked historically for diseases such as polio and they work today – they are regulated and tested by credible science and their use should not be subjected to political interference. The NH Association of Counties would like to register its opposition to the non-germane amendment 2022-0729h to HB 1271.

County Nursing Homes have operated under extreme pressure for the last two years as a result of the COVID-19 pandemic. The unexpected and dramatic impact that COVID-19 has had on our facilities, including, but not limited to, the increased guidance and direction from both state and federal authorities that our facilities are required to comply with is challenging for all healthcare facilities across the state. In April of 2020, the NH Attorney General issued an opinion letter that stated that any actions that a health care facility took to comply with these new rules and regulations would provide the facilities with immunity from civil liability. The language is tailored to ensure that the specific actions laid out by state and federal authorities in regard to COVID-19 are the only ones that cannot lead to civil liability. This bill would remove the Attorney General's opinion from statute and put the county nursing homes at risk.

My name is John Friberg, and I am the Chief Legal Officer for SolutionHealth, the not-for-profit parent organization of Elliot Health System and Hospital in Manchester and Southern New Hampshire Health System and Medical Center in Nashua.

I appreciate the opportunity to testify in opposition to Amendment 2022-0729H which is being proposed as a non-germane amendment to HB 1271.

As the Committee is likely aware, the amendment seeks to remove a section of current New Hampshire law that was part of SB 149, passed during last year's legislative session (now codified as RSA 21-P:42-a). This statutory provision clearly confirmed the Legislature's intent regarding the applicability of New Hampshire's Emergency Management statute, RSA 21-P, to licensed healthcare facilities and their personnel when they have complied, or reasonably attempted to, comply with a COVID-19 related emergency order, rule, or waiver from state or federal authorities. This simply codified the Attorney General's opinion of April 22, 2020 and made the state of New Hampshire law undeniably clear – that actions to comply, or reasonably attempt to comply, with any such emergency order, rule or waiver constitutes Emergency Management activities and are thereby immune from civil liability.

Beginning in March of 2020, as the result of the sudden and unexpected onset of an unprecedented public health emergency, healthcare organizations and personnel were provided with guidance and direction from state and federal authorities, designed to slow the spread of the COVID-19 virus and ensure that we maximized our ability to respond effectively to patient surges and other complexities. These emergency orders, rules and waivers encouraged or required healthcare providers to, for example:

- Cancel elective procedures, to support stay-at-home orders and preserve resources for COVID response.
- Maximize the use of tele-health visits for the same reasons.
- Expand the locations at which healthcare is delivered, to Alternative Care Sites (ACSs) and into areas of our facilities not previously licensed for such services.
- Limit or prohibit visitors.
- Allow for ER triage screening in new places and ways.

- Source and utilize increasingly scarce Personal Protective Equipment (PPE) in non-traditional ways.
- Adjust documentation and discharge planning requirements.

Compliance with such guidance and directives has caused the healthcare system to deliver care in non-traditional ways in order to meet the COVID-19 challenge head on and as effectively as possible. A concern of many doctors and nurses has been whether these very actions, in order to comply with governmental guidance and directives, could give rise to potential civil tort liability, bases on an assertion that such action in compliance fall below the standard of care, and are therefore indicative of constitute negligence. The language as now codified in state law is narrowly tailored and drafted to simply ensure that those specific actions in compliance, or reasonably attempting to comply, with such governmental guidance and/or directives, while such an emergency order or rule is in effect, may not give rise to civil liability.

Compliance with Emergency Management guidance and directives should not later give rise to civil tort liability exposure. This is why RSA 21-P conveys immunity from such claims in cases where healthcare personnel are acting within the scope of the statutory scheme.

While New Hampshire's healthcare providers are certainly grateful to the Department of Justice for the Opinion of the Attorney General from last spring, opining that RSA 21-P does confer such immunity to such actives, a clear and succinct confirmation of the Legislature's intent, in agreement with this analysis, provided significantly greater comfort, clarity and protection.

In developing the legislation in 2021, SolutionHealth worked closely with the NH Association of Justice and Trial Bar to craft a narrowly-tailored bill which could be supported by a wide variety of interested parties.

The actions of the House Health and Human Services Committee, the full Legislature and the Governor regarding SB 149 last year were an important effort to ensure that New Hampshire's healthcare providers would not be inequitably penalized later, in the context of civil litigation, for what they were called upon to do in order to protect our communities and during this unprecedented public health emergency. This was a vital and worthy effort then, when this legislation was proposed and passed, and it remains so today for the very same reasons.

We thank you for your attention to this important issue, in furtherance of the health and wellbeing of the citizens of New Hampshire.

This bill provides that any immunization requirement established by the commissioner of health and human services shall require a two thirds vote of the legislature that such action is a necessary and appropriate response to the virus. The commissioner may order a person to undergo such medical care as may be necessary to treat or prevent an incident or threat of disease or other health condition prompting an investigation pursuant to paragraph IV. Such care may include immunization of individuals as necessary to prevent the spread of contagious disease, [except that] provided that any *immunization requirement shall require a two thirds vote of the legislature that such action is a necessary and appropriate response and provided further that* an individual may refuse treatment or immunization pursuant to the provisions of RSA 141-C:15, VI.

9 2 Repeal. RSA 141-C:15, V, relative to the cost for maintenance of quarantine, is repealed.

10 3 Effective Date. This act shall take effect 60 days after its passage.
