Rep. Blasek spoke in opposition. She said that this bill would undo the reforms made last year. There were no questions.

After seeing how emergency powers could be used to effectively turn our state into dictatorship, it became obvious we needed common sense legislation to ensure rational checks and balances of power in regard to emergency powers. This bill would remove much of the progress made in that regard and I urge you to oppose it and move forward with the reforms, including a limit to the length of a state of emergency and requirement for legislative approval in order to issue any extensions.

The declaration of a state of emergency was never meant to be continually extended; any extension should require legislative approval and a clear demonstration of its necessity, along with an assessment of the potential harmful consequences and clear proof that the benefits greatly outweigh the harms. This was not done for the Covid response and the state and its people have suffered as a result.

For 15 months, the governor was able to issue extensions of the state of emergency and as a result any mandates he saw fit - all without any legislative oversight or public input of any kind. In addition, and rather conveniently for the governor, his state of emergency and the resulting closures or transition to virtual operations of the court system and nearly every public forum made it nearly impossible for people to challenge both the appropriateness and the legality of such actions. Many, if not all, of the mandates regarding the lockdowns, business restrictions, remote learning, and other nonpharmaceutical interventions (NPIs) were never recommended, were not based on evidence, and had no significant effect on the virus trajectory. A recent study from Johns Hopkins found that the lockdowns and the other NPIs had little to no public health effects, while imposing enormous economic and social costs.

The operation of the state and the lives of its people should not be subject to the unchecked rule of a single person, but that's exactly what happened and we need strong legislation to ensure it never happens again.

STATE OF NEW HAMPSHIRE

*In the Year of Our Lord Two Thousand Twenty Two*

AN ACT relative to the governor's power to declare a state of emergency.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1           1 Emergency Powers; Notice; Termination at 21 Days. Amend RSA 4:45, I and II to read as  
2 follows:

3           I. The governor shall have the power to declare a state of emergency, as defined in RSA 21-  
4 P:35, VIII, by executive order if the governor finds that a natural, technological, or man-made  
5 disaster of major proportions is imminent or has occurred within this state, and that the safety and  
6 welfare of the inhabitants of this state require an invocation of the provisions of this section. [As  
7 soon as practicable, the governor shall notify the speaker of the house of representatives and the  
8 senate president of the impending issuance of emergency orders under this section and provide a
