In Mathematics, our proficiency has gone from 48% to 38%. We do need to seek out alternatives. These courses do meet the competencies.

Rep Porter: DOE can override the School Board for graduation requirements??? She shared a story.

I am submitting this testimony in response to the proposed legislation captured in HB 1329 relative to alternate programs for credit leading to high school graduation.

NHSAA supports the principles of personalized instruction, and the education of the whole child. We further support flexibility for each locality in implementing and determining those principles as they apply to the local culture. In addition, we view the role of the State Board of Education as one that should determine whether the local policies and procedures are conducted lawfully, and in accordance with federal and state laws and regulations. Not in the granting of credit to satisfy locally determined graduation requirements.

In the competency based environment that currently exists in our New Hampshire schools that have been endorsed and embraced by the Department of Education as part of its standards, we find it concerning that schools in this bill language "shall accept credits required for high school graduation consistent with the rules of the state board". We would suggest that his bill be amended to state "high school credit for graduation may be granted for coursework that satisfies local competency requirements."

We believe that the determination of granting credit rests in the local community whose educational program is being funded primarily at the local level, and whose educational experts are in the best position to determine the satisfactory achievement of those locally determined competencies.

Dear Chairman Ladd and Members of the House Education Committee.

My name is Jerry Frew and I am the Associate Executive Director of the NH School Administrators Association. Out of respect of the time demands on this committee, I will offer this testimony in writing, and apply the concept to the number of Curriculum related bills this session, and not repeat it for each of the bills during oral testimony.

NHSAA appreciates each bill sponsors concerns, the passion, and interest behind each proposal. By making these curriculum related proposals, each sponsor has created an awareness of the desire of many of our legislators to see changes in curriculum offerings and practices. We encourage bill sponsors to work with their local districts and constituents at the local level to make these changes. A "one size fits all" approach is not effective in a state where the burden of funding these changes takes place at the local level. As the Chair of this committee has stated previously "Curriculum decisions should be made at the local level".

Curriculum changes typically are part of a long term plan to account for budgetary implications, and the distribution of Human Resources for professional training, curriculum, and staff development. These curriculum related bills are all well intended, but also carry with them commitments of time, human, and sometimes physical resources that impact our local districts capacity in one form or another. Districts have various capacities to meet the ambitious timelines for implementation with each one of these bills intended to be in place for the 2022-2023 school year- or sooner. By the time the legislative process is complete, course selections, class schedules for students, and school budgets will have already been enacted by the local legislative bodies for the 2022-2023 school year.

We encourage each sponsor or legislator interested in changing curriculum, to work with their local school systems officials and communities to achieve the desired curriculum changes. If the legislature as a body is determined to dictate local curriculum, then each bill should contain a fiscal note that accounts for any additional training time, additional staff, curriculum materials, and facility modifications that might be necessary to equitably implement these proposals.

At the very least, we would propose that any curriculum bill enacted, be respectful of local capacity by allowing phased in or flexible timelines for implementation, with none of it taking effect until July 2024 at the earliest and be accompanied by a fiscal note to adequately implement the legislation. This flexibility allows for local communities to plan for the fiscal impact of training, staffing, facility management and policy making required as a result of these decisions.

The sheer volume of these bills imposes demands on local resources and bandwidth, and with all due respect, we ask this committee to look at these not only as individual bills, but in the sum total of all of these proposals as they impact local curriculum development. It is with that thought in mind that we ask the committee to find each of these curriculum bills inexpedient to legislate at this time, or at least retain them for further study looking at the complete curriculum package as proposed by this legislature. We are happy to assist with this process.



This bill requires high schools to accept alternative programs for credit leading to graduation pursuant to rules adopted by the state board of education.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Two

AN ACT relative to alternative programs for credit leading to high school graduation.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 1 Adequate Public Education; Rulemaking; Alternative Programs for Granting Credit Leading 2 to Graduation. Amend RSA 193-E:2-a, V(b) to read as follows: 3 (b)(1) The state board of education shall adopt rules, pursuant to RSA 541-A, relative to 4 the approval of alternative programs for granting credit leading to graduation. 5 Schools shall accept credits required for high school graduation 6 consistent with the rules of the state board. Upon receiving a valid completion certificate 7 from a state board approved alternative program, a high school as defined in RSA 194:23 8 shall grant equivalent high school credit leading to graduation to a student who has 9 completed such alternative program.
 - 2 Effective Date. This act shall take effect upon its passage.

10
