Rep. William Foster introduced the bill. This would make a company liable for any damage caused by its medical mandates. This would be for damages to either an employee or a customer of that business. This is to make sure that businesses are willing to take responsibility for what they require to be done.

Rep Turcotte: How or where would this apply?

Rep. Foster If someone does decide to do what the company asks, the company would then become responsible

Rep. Turcotte: Specific example?

Rep. Foster A concert venue requires a vaccine for attendance so the person gets a vaccine and then gets a bad reaction. They still must prove their case. This just gives them the standing to do this.

Rep. Warden: Could this mean someone driving to a drugstore for a vaccine gets in an accident and could he then blame the company that made him feel that he should get the vaccine for the accident

Rep. Foster: I don't think that is provable.

Rep. Sullivan: If I get the vaccine and then get a bad reaction can I sue every company that requires a vaccine.

Rep. Foster: I think you could only sue one.

Rep. Sullivan: I know what you're saying, but I don't see that in the legislation as written.

Rep. Foster: I don't see it that way, but I wouldn't be against an amendment to make it clear.

Rep. Maneval: This doesn't seem limited to physical damage. Could it also be financial or other damage?

Rep. Foster: It was not intended to be quite that broad.

Peter McKenna from DOL expressed a couple of concerns. Damages don't seem to be well-defined in this bill. There are possible damages here that we are not familiar with calculating. We have only historically dealt with employee/employer relationships not business/customer relationships. That is not usually our purview.

Rep. Love: You take no position?

Peter McKenna: Correct.

*Paula Minnehan from the NH Hospital Association testified against the bill. She provided written testimony.

Rep. Seaworth: If a hospital requests a medical procedure before admission would that be covered under this?

Paula Minnehan: I believe that is covered under informed consent and medical malpractice.

David Juvet from the BIA testified against the bill. I would like to focus on the customer angle. I was asked today when making a restaurant reservation if I was vaccinated. Under this law I would be able to sue the restaurant.

Rep. Maneval: Apparently If I was required to get blood work prior to an operation and I was injureed there I could sue the hospital requiring the blood work

David Juvet: Yes.

Rep. Love: Since I can't be asked about my HIV status how can I be asked about vaccination status?

Dave Juvet: In some cases, you can be asked about your HIV status.

I am writing to in support of HB1410, relative to causes of action involving private business entity policies requiring employees or customers to receive medical treatment. This bill, in essence, requires an employer to assume liability for any damages that an employee or customer can prove to have occurred as a result of attempted compliance with medical mandates. As the federal Occupational Safety and Health Administration (OSHA) warned early last year employers should be held liable for any adverse events resulting from mandatory "vaccination" policies related to the COVID vaccines.

In the "Frequently Asked Questions" section of a OSHA guidance that was issued on April 20, 2021 the agency explained that all employers who mandate the COVID vaccine would be required to record any adverse events that result from the injections. If an employee who was forced to be injected became paralyzed or died, for instance, that injury or death will be considered "work-related," meaning the employer would be held responsible.

They were on the right track but back-tracked in May 2021 simply because they wanted to encourage Covid-19 vaccinations, not because it was the right thing to do. They did not want to deter employers' vaccination efforts. So they opted to not enforce the recording requirements through May 2022 and said they will reevaluated their position at that time.

Why shouldn't employers be responsible if they are mandating? These "vaccines" are different than a mask that you can take off when you leave or gloves that can be removed at the end of your shift. This crosses the line. Employers have no business mandating these fake vaccines.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 Purpose and Findings. The general court finds that:
- I. The purpose of this bill is to establish that a private entity that mandates, through access or employment requirements, the choice in a medical decision for employees or customers in New Hampshire, for access to goods, services or employment, shall assume the liability for any damages caused by attempted compliance with the medical mandate or requirement.
- II. Decisions regarding an individual's physical body shall, whenever possible, be the free choice of the individual in a manner most agreeable to the dictates of their own conscience and reason.
- III. We as a people and a state recognize and acknowledge an individual or businesses right to conduct business, retain employees, and provide access to goods and services as they see fit within the framework of current law.
- IV. Mandates or requirements in regards to a person's physical body, as a requirement for access to goods services, or employment opportunities by private business, shall come with legal responsibility for damages caused by attempted compliance.
- V. A private entity mandating a decision of this nature shall come with the responsibility and accountability for any consequences caused by attempted compliance.
- VI. As the choice to mandate is being made by private entities, without the representation or consent of the people of the state, additional burdens shall be laid upon the private entity.
- 2 New Subdivision; Non-governmental Medical Mandates. Amend RSA 275 by inserting after section 77 the following new subdivision:

Non-governmental Medical Mandates

- 275:78 Non-governmental Medical Mandates. A private business entity that imposes a medical mandate on an employee or a customer as a condition of access to goods, services, or employment shall assume liability for any damages that an employee or customer can prove to have occurred as a result of attempted compliance with the medical mandate. The moving party shall be granted standing upon a showing that the moving party suffered any amount of loss or damage which may have been caused by their attempted compliance with the entity's medical mandate.
 - 3 Effective Date. This act shall take effect 60 days after its passage.
