The amendment that he will bring at the executive session changes the effective date to "on passage". The memorial is in Hampton on Ocean Boulevard. The Lady of the Sea Memorial was dedicated in 1957 to honor servicemembers lost at sea. Initially these were mostly World War II but in 1990 Merchant Marine and Vietnam members were added. He supports the legislation. The Federal government would not provide markers for servicemembers lost at sea. There were 248 names originally. The memorial was rededicated in 1993. He learned that legislation was needed to add these names and that is how the bill came to be filed. Rep. Abbott asked who does the inscription and is DNCR involved. The response is yes, DNCR funds it.

## Testimony

## Remarks in support of HB 1456



Good morning, Chairman Graham, I would like to thank you and the members of this committee for the opportunity to speak in favor of HB 1456, which would include recent conflicts and allow additional names to be added to the Hampton Marine Memorial at Hampton Beach. My name is Berkley Bennett, and I am the Commander of American Legion Post 35 in Hampton.

As a bit of background, the idea for a memorial came from Manchester resident William E. Downs. His son, Army Captain William D. Downs had died aboard ship while returning from the South Pacific in WW II, and was buried at sea in May 1945. Mr. Downs attempted to get a grave marker for a token burial plot for his son, but was told at the time the Federal government would not provide grave markers for those who had died at sea. Frustrated, he approached William Loeb of the Manchester Union Leader for help. This was the beginning of the creation of a memorial for those from NH who were lost at sea in all wars. In 1950, Governor Sherman Adams created the NH Marine Memorial Commission and after seven years of study, hard work, and fundraising, the "Lady of the Sea" Marine Memorial was dedicated on Decoration Day 1957. The Memorial included the names of 248 men, not only WW II veterans, but also two service members who were killed when the USS Maine exploded in Havana Harbor prior to the Spanish American War, five veterans of WW I who died when their ships were sunk while enroute to France, and one sailor who was lost when the destroyer USS Rueben James was torpedoed by a German U-Boat, just prior to America's entrance into WW II.

In 1990, legislation was adopted to include Viet Nam War veterans, and WW II Merchant Mariners on the Memorial. On Memorial Day 1993, the Memorial was rededicated, adding 42 names to the honor roll, including 24 Merchant Mariners. The Memorial presently has 290 names, but its design allows for over 400. The purpose of this bill is to seek the addition of more recent New Hampshire service members who were lost at sea while serving in Operations Desert Shield/Desert Storm and the Global War on Terrorism.

One such member, Hampton native Marine Cpl Jonathan Currier, was believed to have fallen overboard while deployed aboard the amphibious assault ship USS Essex while sailing off the coast of the Philippines in August 2018. He was declared lost at sea, his body never recovered.

Another service member, Marine Captain Gary Dillon, of Concord, would also be eligible for inclusion if this bill is passed. Capt Dillon, a Marine Aviator, was killed in a helicopter mid air collision while conducting night vision google training in the Arabian Sea, just before the onset of hostilities in Desert Storm. His body was also never recovered.

When I spoke to the Division of Parks and Recreation about how to go about adding names to the Memorial, I was told the criteria is set through the Legislature, and that is when I reached out to Hampton State Representative, Mike Edgar, for help. His efforts have led to the bill that is before this committee. The Marine Memorial doesn't exist just to memorialize those lost in WW I or WW II. It needs to continue as a living monument, to honor those lost at sea defending our country today. Passing this bill will allow Jonathan's and Gary's names to be added to the stone. It would allow the "Lady of the Sea" Memorial to provide solace to the Currier family, where Jonathan played on the beach beneath her gaze as a child. With its location at the edge of the shore, overlooking the vast ocean that is the final resting place of so many of our heroes, an updated Memorial would allow the tens of thousands of people who visit Hampton Beach the opportunity to pause and reflect on the continuing cost of our freedom.

I thank you for the opportunity to address you this morning, and I strongly urge your support for this bill.

#### STATE OF NEW HAMPSHIRE

AN ACT relative to the Hampton marine memorial.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Hampton Marine Memorial; Inclusion of Veterans from Desert Shield, Desert Storm, and the 2 Wars on Terrorism. Amend 1990; 125:2, I to read as follows:

3 I. The division of parks and recreation, department of [resources and economic development]

4 natural and cultural resources, is directed to add to the list of names on the Hampton Marine

5 Memorial those veterans lost at sea during the periods including Operation Desert Shield,
