STATEMENT OF INTENT

This bill proposes to require a forensic audit of the general election of November 2020. It also allows private donations to an election audit fund which would be used to fund this and any audits. The expense of this audit is indeterminable at this time. The sponsor and supporters believe that private funds would pay for the audit. However, this bill compels the state to complete a statewide election audit whether those private donations materialize or not. Taxpayers would then be forced to potentially pay very large sums for this audit. The 10/1/2022 time frame given in this bill to complete the audit would occur in the midst of preparations for upcoming elections, a task the Secretary of State warned would be extraordinarily difficult for his office to conduct. Essential details of specifically who would do the audit and how it would be performed were absent in this bill, leading to concerns of further discord in making those arrangements. In consideration of this request, the committee learned that no representatives of a campaign for a federal office have contacted N.H.state election officials to request a statewide recount of the 2020 election. The reasons presented by supporters of this bill as indicators of a need for this audit were localized issues that are serious concerns. The committee believes that those concerns are best addressed by continued vigilance of implementation and enforcement of current state election laws and improved communication with the public about them.

AN ACT requiring a forensic audit of the 2020 election results.

COMMITTEE: Election Law

ANALYSIS

This bill requires a forensic audit of the 2020 general election and establishes a fund to cover the costs of conducting such an audit.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Two

AN ACT requiring a forensic audit of the 2020 election results.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 November 2020 Election; Forensic Audit Required.

2 I. Notwithstanding any provision of law to the contrary, the speaker of the house of
3 representatives shall appoint an independent third party to conduct a forensic audit of the general
4 election that took place on November 3, 2020.

5 II. The audit required pursuant to paragraph I shall be completed no later than October 1,
6 2022.

7 III. The independent party conducting the forensic audit shall submit a report detailing the
8 audit's findings, including anomalies or discrepancies in voter data, ballot data, or tabulation, to the
9 speaker of house of representatives, the president of the senate, the house clerk, the senate clerk,
10 the governor, and the state library on or before November 1, 2022.

11 2 Election Audit Fund.

12 I. There is established in the state treasury an election audit fund which shall be
13 administered by the secretary of state. Any gifts, grants, and donations, including monetary
14 contributions from non-governmental sources, shall be credited to the fund to cover the costs of the
15 election audit required in this and any other election audits.

16 II. The secretary of state shall accept any gifts, grants, or donations to be credited to the
17 fund and shall approve all requests for disbursement from the fund.

18 3 Effective Date. This act shall take effect 60 days after its passage.

METHODOLOGY:

This bill requires a forensic audit of the 2020 general election and establishes a fund to cover the costs of conducting such an audit. The Department of State indicates they are unable to estimate the fiscal impact of the bill as the bill does not outline forensic auditor qualifications or specification for the audit. It also does not address the source of funds to cover the audit expenses other than creating a fund administered by the secretary of state to receive gifts, contributions and donations for that purpose. It is assumed general funds would be used to conduct the audit if gifts, contributions or donations to the election audit fund are not sufficient to cover the expenses associated with the audit.
