STATEMENT OF INTENT

This bill allows a person to remove his or her information from the state vaccination registry without a health care provider's signature. The majority was in agreement that the current rule requiring a signature is an unnecessary, extra step that increases the difficulty of withdrawing from the registry and also creates extra work for the medical provider. Since many patients routinely change medical providers or may have received a vaccination by a pharmacy-based provider, it may be difficult or impossible to obtain a signature from the actual provider who administered the vaccination. This creates an undue burden on the patient trying to have their private health information removed from the vaccine registry. The bill allows for an individual to submit the form to the Department of Health and Human Services (DHHS) with his or her own notarized signature in lieu of a provider's signature. The entirety of the committee believes this offers greater protection of citizen privacy in line with Article 2-b of the State Constitution.

Rep. Leah Cushman for Health, Human Services and Elderly Affairs. I am writing today to ask you to strongly support HB 1487 and HB 1488. These bills relate to the New Hampshire immunization registry.

HB 1487 removes the requirement for a current or former doctor or other health care provider to sign the form to withdraw from the immunization registry. This co-signature requirement is unduly burdensome and does not reflect the fact that most people receive immunizations from employees of pharmacies or clinics, and not their current or former doctor or health care provider. The requirement can be costly and time consuming, and it serves no reasonable purpose; citizens must be able to exercise their right to withdraw from the registry without needless bureaucratic requirements. Please vote OTP on HB 1487 and remove this unnecessary requirement.

HB 1488 prohibits those health care providers and others who have access to citizens' immunization information from discriminating against them because they have chosen not to participate in the registry. Participation or non-participation in the immunization registry must never be a reason for discrimination. Under the New Hampshire Constitution, citizens are guaranteed the right to privacy in Article 2-b which states: "An individual's right to live free from governmental intrusion in private or personal information is natural, essential, and inherent." Participation in the immunization registry is not mandatory, and a citizen may decline to participate in the registry. No inference should be made by anyone regarding a citizen's decision to not participate in the registry. HB 1488 makes citizens' privacy rights clear with respect to the registry. Please vote HB 1488 OTP to respect and protect the constitutional privacy rights of New Hampshire citizens with respect to the immunization registry.

Members of the House Health, Human Services and Elderly Affairs Committee, Following up on the discussion of identity impersonation during the public hearing yesterday, I would like to draw your attention to the current DHHS "Request for Immunization/Vaccination Record" form (attached). This form notes: "[I understand in the interest of maintaining the confidentiality of the record, this request must be notarized by a notary public if this form is mailed to the address listed below.](#)" and "[If this form is handed to my current health care provider, the notarization is not required.](#)" The key difference in this requirement is that it only be processed through the *office* of the provider, which implies the expense of a consultation visit to gain the provider's signature is not required. Additionally, notaries public are available across the country for individuals that may have moved out of state or when their provider is not available.

I would not object to a similar policy for a revised withdrawal form, and I do not believe the wording of HB1487 prohibits the department from mirroring the identity proofing procedures present in the record request form.

ANALYSIS

This bill provides that a health care provider's signature shall not be required for withdrawal from the state immunization/vaccination registry.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Two

AN ACT relative to the procedure for withdrawal from the vaccine registry.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Legislative Findings.

2 I. Immunizations and vaccines are often distributed by pharmacists, clinics, and other
3 settings where the patient has a loose and transient relationship with the health care provider.

4 II. However, the department of health and human services process for withdrawal and
5 removal of information from the New Hampshire immunization/vaccination registry requires a
6 signature from a current or former health care provider.

7 III. It may be difficult or impossible for an individual who does not receive regular health
8 care to track down a former transient providers for the purpose of signing the form prescribed by the
9 department for this purpose.

10 IV. To ensure that an individual's right to withdraw from participation in the
11 immunization/vaccination registry is effectively available to all residents of New Hampshire, if they
12 so choose, the general court finds that the requirement for a current or former health care provider
13 to sign the form is an undue burden that does not further a legitimate state interest.

14 2 New Paragraph; Communicable Disease; Immunization Registry. Amend RSA 141-C:20-f by
15 inserting after paragraph III the following new paragraph:

16 III-a. A patient, or the patient's parent or guardian if the patient is a minor, may withdraw
17 from participation in, and request the removal of information from, the registry at any time by
18 submitting a request for withdrawal directly to the department of health and human services.
19 Under no circumstances shall the request for withdrawal require the signature of the individual's
20 current or former health care provider.

21 3 Effective Date. This act shall take effect 60 days after its passage.
