Dear Members of the House Health, Human Services and Elderly Affairs Committee:

I am writing today to ask you to strongly support HB 1487 and HB 1488. These bills relate to the New Hampshire immunization registry.

HB 1487 removes the requirement for a current or former doctor or other health care provider to sign the form to withdraw from the immunization registry. This co-signature requirement is unduly burdensome and does not reflect the fact that most people receive immunizations from employees of pharmacies or clinics, and not their current or former doctor or health care provider. The requirement can be costly and time consuming, and it serves no reasonable purpose; citizens must be able to exercise their right to withdraw from the registry without needless bureaucratic requirements. Please vote OTP on HB 1487 and remove this unnecessary requirement.

HB 1488 prohibits those health care providers and others who have access to citizens' immunization information from discriminating against them because they have chosen not to participate in the registry. Participation or non-participation in the immunization registry must never be a reason for discrimination. Under the New Hampshire Constitution, citizens are guaranteed the right to privacy in Article 2-b which states: "An individual's right to live free from governmental intrusion in private or personal information is natural, essential, and inherent." Participation in the immunization registry is not mandatory, and a citizen may decline to participate in the registry. No inference should be made by anyone regarding a citizen's decision to not participate in the registry. HB 1488 makes citizens' privacy rights clear with respect to the registry. 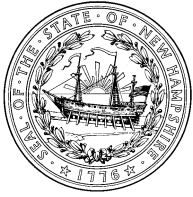

Dear Chairman Pearson and Members of the Committee:

The Department is here today to **provide information on HB 1488.**

Immunization is considered one of the most important public health achievements of the last century. Immunizations are a safe, effective way to protect children and adults from disease, including some cancers, as well as hospitalization, disability, and death. Immunization information systems (IIS) are the confidential, secure, population-based, databases that record these critically important immunization doses that are administered by healthcare providers.

The **NH Immunization Information System (NHIIS)**, as authorized RSA 141-C:20-f, is the single secure repository of accurate, complete and current immunization records in New Hampshire. It provides benefits to individuals, healthcare providers, and the Department, including:

- Preventing administration of duplicate immunizations.
- Increasing immunization rates by promoting the most up-to-date immunization recommendations and helping to remind patients when immunizations are due. (**By age 2, more than 20% of children in the U.S. have seen more than one doctor**)
- Consolidating immunization records from multiple providers. Patients and families benefit from having access to a complete electronic immunization record that includes information from multiple healthcare organizations regardless of where a vaccine was received.
- Ensuring accountability of publicly purchased vaccines.
- Supporting public health activities by identifying communities with low vaccination rates to ensure access to vaccination and prevent infectious disease outbreaks.

HB 1488 proposes to expand the prohibition against discrimination based on an individual's election not to participate in the state immunization/vaccination registry to additionally include entities such as schools, child care agencies, and government health agencies who were not previously included in RSA 141-C:20-f, X.



*Be it Enacted by the Senate and House of Representatives in General Court convened:*

- 1           1 Communicable Disease; Immunization Registry. Amend RSA 141-C:20-f, X to read as follows:  
2           X. No health care provider ***or any other entity identified in paragraph IV*** shall  
3 discriminate in any way against a person solely because that person elects not to participate in the  
4 immunization registry.  
5           2 Effective Date. This act shall take effect 60 days after its passage.
