### **STATEMENT OF INTENT**

This bill ensures equal access to places of public accommodation regardless of vaccination status. It also provides no one should be denied access to public accommodation because the person refuses to use a medical device. The majority believes that one's vaccination status is and should be protected private information. Similarly, no one should be required to use any medical device simply to buy groceries, take a bus, or attend a public event. The committee rejected establishing similar protection across the board and focused on this narrower area. We believe discrimination on these bases significantly reduces the natural rights of our people, but in areas like employment or education there could be valid reasons for requiring vaccination for the protection of others. The majority recognizes these areas are matters of individual choice and believe they follow a rationale similar to what we used to protect sexual orientation or gender identity.

The minority believes that the reasons giving rise to the current list of classes protected are substantially distinguishable from the reasons proffered to extend that list to include “vaccination status.” Moreover, it is important to note that the legislature enacted RSA Chapter 354-A (the state’s anti-discrimination statutes) under the state’s police power to ensure the public’s welfare, health, and safety. Including “vaccination status” as a protected class for purposes of access to public accommodations (including health care providers) would threaten public health, rather than protect it. For example, the New Hampshire Hospital Association testified at hearing that a vaccine requirement is an essential tool to protect their employees and patients against COVID-19. Other employers and businesses across the state should be able to protect their employees and patrons from potentially lethal diseases, such as COVID-19. Finally, the bill also prohibits a place of public accommodation from discriminating against a person for refusal to use a “medical device.” The term “medical device” is too vague, and its meaning will have to be sorted out through costly litigation.

TESTIMONY

**Rep Comtois Sponsor Support** RSA 354 deals with Human Rights and laws against discrimination. Civil rights are a class of law that protect one's entitlement to participate in society without discrimination. All people are created equal and discrimination of any kind should not be tolerated based on one's beliefs. We have HIPPA statutes protecting medical information, but people are being discriminated against for not taking a shot.

**Q Horrigan:** Is a civil right to spread a disease?

**Ans:** No. Does it happen? All the time. We don't discriminate against people for spreading STDs or other diseases, and we shouldn't.

**Q** Do you feel people have the right to endanger others?

**Ans:** I think people have the right to protect themselves.

**Q Chase:** How would we be endangering others by not getting the vaccine?

**Ans:** My sister died of a massive heart attack just after getting the vaccine. There are other known serious effects. We should have bodily integrity. There are ways to protect yourself as you are by wearing a mask. That is a choice.

**Q Langley:** How do you define a medical device?

**Ans:** It could be anything used to protect one's health, but we shouldn't be forcing people to wear something that could cause them extreme harm.

**Q Kenney:** Would you share the studies you reference with the committee?

**Ans:** I will see what I can do.

**Q: Smith:** Did they come from your County medical officials?

**Ans:** not sure.

**Q Chase:** the bill is about not allowing people to go places because of vaccine status, isn't it?

**Ans:** Yes, and we have laws to protect medical information, but we are making exceptions for a certain disease.

**Q Gordon:** You are addressing specifically public accommodation?

**Ans:** Yes.

**Q** Why did you pick public accommodation, vice vaccination status?

**Ans:** Because I have constituents that were prohibited from going to places, they had gone for decades because of the vaccine mandates.

**Q** Public accommodation is defined in the law. Do you intend this to be broader than the legal definition?

**Ans:** Yes

**\*Kathy Bizarro-Thunberg Exec Dir NH Hospital Association Opposed** We have the same objection to this bill we had to HB 1260 a few minutes ago. Enacting laws like this will simply add to confusion and conflict between employers and employees.

We don't think volitional choices should be part of the law. HIPPA is being misapplied by the sponsor.

**Q Simpson:** Have you talked through people who are immunocompromised and can't take the vaccine?

**Ans:** Yes, there are many mitigation efforts that could be used.

**Q Sylvia:** Does the Association think patients should be vaccinated before getting treatment?

**Ans:** No.

**Q** You want to protect your workers who are almost 100% vaccinated. What danger does an unvaccinated person pose?

**Ans:** we require anyone who enters the hospital to wear a mask and it is our right to do so,

**Rosasan Chester Self Support** I developed Bell's Palsy after a previous vaccination. Failing to pass this bill would discriminate against me. I can't take this vaccine because we don't know all the ingredients. I refuse to take any such shot. The CDC recognized the vaccine will not prevent Covid. I had Covid and I shouldn't be discriminated against because I won't take the shots. I have been denied my religious and my medical exemption by a company in Massachusetts.

**Q Smith:** This bill deals only with public accommodations while your concerns are different?

**Ans:** I was in another hearing for your first bill. My doctor will not provide me an exemption because she is afraid of losing her license. That is not acceptable. The money being made on our backs shouldn't be driving our individual actions.

**Q:** can you provide the studies you mention?

**Ans:** I will send information to you.

**Q Horrigan:** Would you tell us more details of your story?

**Ans:** The private non-profit refused my application because I couldn't get a note from my doctor despite my showing them, I was vaccine injured.

**Q DiLorenzo:** What about you getting Bell's Palsy?

**Ans:** I was a social worker and got a flu shot. I knew that was a possible side effect. For some reason, seven of us, who all had gotten flu shots before, got Bell's Palsy. I've had the flu shot since. I am very careful about the ingredients of any shot I take.

**Rep Harvey-Bolia Self Support for** The way vaccination status gets known is vaccinated people announce they are vaccinated. It becomes obvious who hasn't been vaccinated. This leads to discrimination against those who fail to say when they were vaccinated and that should not be.

**Ahni Malachi Exec Dir Human Rights Commission Information only** Public accommodation is any Inn/tavern or Hotel...Restaurant; bath house; store; and does not include any thing distinctly private. The right to refuse medical treatment is well established, but with the broad definition of "medical device", we think the definition in this bill needs to be clarified. The business should be able to implement some sort of reasonable accommodation if one can't comply with a mandate.

**Q Smith:** Does that definition include a public institution of education be included as a public accommodation?

**Ans:** No.

**Q Gordon:** Would this apply to customers or employers?

**Ans:** It is focused on public accommodations.

**Q DiLorenzo:** Could a restaurant using open flame cooking deny access to one wearing an Oxygen tank?

**Ans:** We would have to look at it closely. It would depend on the details-could they be seated away from the flames, etc.? The specific circumstances would drive our actions.

**Q Chase:** The bill says 'equal access', could some accommodation be allowed to meet the law?

**Ans:** Maybe. I would have to have that vetted by a legal expert, considering the laws and our past practices and interpretations.

**Q Sylvia:** Can one file suit about discrimination directly in Court?

**Ans:** One must start with the Commission but can move to the court later. In Education the complainant has more choices.

**Q Horrigan:** Is PPE part of the definition of medical device?

**Ans:** I read from the formal definition. We would have to investigate the extent of previous interpretation, etc.

**Q Gordon:** Does access mean physical access or access to services?

**Q** Good question. I am unsure. One might have physical access without full access to the service or experience.

**Q** Access to the hospital: does that ensure access to their services?

**Ans:** I would want to look into that. It could depend on the business and its services.

**Victoria Gulla**                      **Self & Family Support**                      I have lung damage from limited mask wearing and I have a son with Turret's syndrome. He goes through different ticks. Now he is chewing. These ticks come from anxiety. Mask wearing makes him want to touch his face, mooting the effectiveness of the mask. For this reason, I won't make him wear a mask. He is being denied a public education at a Charter school. Hospitals are leading the discrimination and disinformation. Places re forcing you to wear these things that have no value. We shouldn't be discriminated against because we can't comply with these mandates. I am being prevented from officiating at ski races because I would have to be the 'mask police'. They are discriminating against healthy people. This is a steppingstone to put the people of NH into a system that will lead to social scoring system similar to what is being used in China. Dear Committee Members and Fellow Citizens,

We are copying/indenting below much of the written testimony submitted for HB1260 that you just received via email.

It's the same testimony because it is the same issue. It's a fundamental issue of basic human dignity and rights. Is being denied entry to a hotel where our family may need to sleep, shelter, or vacation quite as bad as missing out on The Smithsonian or the historic sites of Boston? I guess that depends on your perspective. But it's absolutely, fundamentally the same issue. What's next, gas stations for the vaccinated only? Hospitals? Kwik-E Marts?

We recognize the idea that the state should decide for a private business owner is prickly for many. However, we are talking about businesses that provide a priority service of shelter, rest, retreat, or in many cases, temporary safe dwelling. Without equal rights of accommodation, we are talking about impeding people from ever traveling beyond their own towns in the State of NH, because there is no where for them to stay besides their own homes.

Recall again that COVID-19 vaccines do not prevent transmission of or infection with the virus. Supporting this bill does not impede on a businesses right to operate as they see fit to protect the health of their residents. All it does it impede on is their ability to discriminate and exclude based on misinformation or fear.

Recall too that all sorts of public health risks take place in hotels right now—unsafe sex, IV and other drug use, smoking, alcohol abuse, verbal, mental and physical abuse, human trafficking, lice, strep, flu-spreading, bedbugs, gross little potential deadly hairs from strangers in the sink drain—we could go on.

Is it within the proprietors' rights to ban people who might do/have these things, based on zero evidence indicating they will, from staying on the premises?

Allowing conditional rights to be established based on immunization status should never be considered. In fact, is has **not** been considered in any meaningful way, but instead just rolled out across this country as if it were nothing significant. Pay to play, or lose. And lose more than a lot.

No U.S. Citizen, N.H. Citizen or Resident, nor Human Being on this planet should ever be subjected to fear of, or actual loss of, freedoms, privacy, income, access to venues, markets, etc., and the very ability to engage in society due to their medical choices or medical conditions.

Our family moved to NH last summer as a direct result of this type of tyranny. We can tell you from personal experience how absolutely terrifying and stunning it was to suddenly lose everything we had worked for because the state decided they could make a blanket

medical decision on behalf of the entire populace. In addition to the many other disastrous consequences of the state's decisions, we were forced to explain to our children why they were suddenly outcasted members of society. I believe many NH families have faced the same this year as COVID vaccines mandates have spread.

As these conversations have unfortunately continued this year throughout the COVID pandemic; our son says often he'd like to travel to another country, or see a big concert but knows he won't be able to because he's not vaccinated for COVID. Our high-school-aged daughter wonders which colleges she will be eligible to apply to? Even if she can choose freely, are they in towns that will welcome her and allow her to enjoy social activities with her friends?

Professionally, as adults, we have been forced to consider that, in addition to educational rights, we may lose the right to earn an income, take a trip to see family, enter the nursing home where our mother resides, or any other myriad of freedoms.

Our family is currently essentially banned from enjoying much of anything to enjoy in the United States cities of: New York City, Boston, Minneapolis/St. Paul, Los Angeles, Salem, MA, Washington DC, San Francisco, and Los Angeles. We are likely missing some additional locations—as the list grows longer, our sense of doom, exclusion, and fear for our children's future increases and we begin to lose track of some of the details—but the message of where we now stand could not be any clearer.

Do you have any idea how it feels to know your children will potentially never see the historical collections in Boston or experience the museums of New York City? Never eat real NY Pizza in a restaurant, or see a rock concert in San Francisco? Despite the fact that a mere six months ago they could have? It feels like a G-damn nightmare that will never end. It feels like our entire connection to story and collective artifacts and generational experiences, and identities as Americans--born here because our grandparents and great-grandparents came here for more freedom--has been severed. But not by choice. Without an ounce of ceremony or even public debate, this was taken from us. So fast, most days we aren't even fully able to process it.

We are among a group of "refugees" who have fled to NH in the last two years for something very simple and which many of us perhaps took for granted—freedom.

Anyone who cannot see that as a nation have sped toward creating an entirely second-class of citizens based on one criteria; with many of our fellow citizens gleefully willing to circumvent their own rights along with others for an easy solution to a complex problem—is just plain blind.

**In so many ways, and for so many people, the protected class status tied to immunization status is now absolutely required.**

We know we can do better than this as Americans, and we believe NH has the right leaders to make sure we do. Being proactive about this matter couldn't be anymore essential than it is at this moment. Clearly we are in the process of losing this battle in multiple states across the US right now. Do not let NH fall! Please miss this opportunity to protection under the law for our family and so many others in NH.

Thank you to the authors and sponsors of this bill and to all who vote to support it. To those who do not, I hope you consider what you would say to our family in person and how ethically and morally you could justify looking us in the eye and uttering any such explanation. (This time around, imagine us exhausted, dirty, and unable to safely drive any longer, as we arrive at the Comfort Inn, attempting to check in with our beautiful, healthy children.)

### **HB 1490-FN – Relative to Equal Access to Places of Public Accommodation Regardless of Vaccination Status**

#### **Testimony**

Good morning, Mr. Chairman and members of the committee. My name is Kathy Bizarro-Thunberg, Executive Vice President with the New Hampshire Hospital Association (NHHA), representing all 26 of the state's community hospitals as well as all specialty hospitals.

The NHHA is opposed to HB 1490-FN. The bill before you would provide that an individual shall not be denied access to places of public accommodation based on vaccination status or the decision not to use a medical device.

We do not believe it is appropriate to include "vaccination status" as a protected class under the State Commission for Human Rights. This committee just heard a similar bill, HB 1260 as well as a bill last week, HB 1519, which we also testified in opposition. This bill as well as other bills before this committee, attempts to insert additional "classes" into the statute that protects individuals from discrimination. It is our position that adding these additional "classes" is not appropriate and not the intention of our anti-discrimination laws. We believe all these bills are focused on, without explicitly stating such, an attempt to insert vague language into the statute against the COVID-19 vaccine or other public health measures such as masks. We are also concerned that the term "medical device" in this bill is vague and misleading, especially if the intent is really focused on masks. The result of all these bills will just lead to lawsuits and further confusion among employers, employees, and patrons of public establishments.

It is NHHA's position that employers, and any business open to the public, have the right to determine what is best for their employees, their clients, patients, and/or patrons. Requiring vaccinations of healthcare workers from communicable diseases is not new for hospitals in New Hampshire. Hospitals have required vaccination against several communicable and deadly diseases such as mumps, measles, rubella, chicken pox, diphtheria, tetanus, pertussis, and influenza as a condition of employment, with the same type of medical and religious exemptions allowed for COVID-19 vaccines. We believe requiring vaccinations is absolutely the right thing to do for the health and safety of our patients, our staff, and the citizens of New Hampshire. The vast majority of hospital staff have been vaccinated against COVID-19 or have received exemptions, and we've heard from many healthcare workers who support the vaccine requirement to protect their health and that of their patients.

**We are opposed to HB 1490-FN, and we urge the committee to find this bill Inexpedient to Legislate. Thank you for the opportunity to provide our comments on HB 1490-FN.**

As a New Hampshire physician, I want to express my opposition to HB1490. We are in the midst of a viral pandemic where a life threatening illness is spread by respiratory particles and many NH residents, including myself, have been sickened by this virus. 2,100 NH residents have died. It is proven that immunizations and wearing of masks decrease the spread of the virus and the severity of illness in those who become infected. If a public place (library, town hall, school, hospital, restaurant, theater) decides that the best interest of the facility and its employees and customers requires vaccination and/or masks, the legislature should not stand in the way. Many NH residents (my friends and patients) are stuck at home, unable or very hesitant to visit the grocery store, library and even the hospital due to concerns of exposure to COVID. These people are deprived of safe access to essential services by the danger of infection. The hospitals are full to overflowing with COVID patients. Sick patients who otherwise would be admitted are sent home for lack of beds. Patients with non-emergency surgeries are delayed (this includes patients with serious cancers).

1 Equal Access to Public Accommodations a Civil Right. Amend RSA 354-A:16 to read as follows:

354-A:16 Equal Access to Public Accommodations a Civil Right. The opportunity for every individual to have equal access to places of public accommodation without discrimination because of age, sex, gender identity, race, creed, color, marital status, physical or mental disability, ***vaccination status***, or national origin is hereby recognized and declared to be a civil right. In addition, no person shall be denied the benefit of the rights afforded by this section on account of that person's sexual orientation ***or because the person refuses to use a medical device.***

Testimony for HB1490, *relative to equal access to places of public accommodation  
regardless of vaccination status*  
House Committee on Judiciary  
January 26, 2022

Thank you for the opportunity to provide testimony on House Bill HB1490, providing that an individual shall not be denied access to places of public accommodation based on vaccination status or the decision not to use a medical device.

This testimony is based on the assumptions that public postsecondary institutions are considered “public accommodations” for the purposes of this bill, and that the term “medical device” includes masks that cover the nose and mouth.

CCSNH has significant concerns with HB1490. We believe the ability to require masks in certain spaces when public health circumstances warrant it has been a key element in our colleges remaining open and continuing to provide education to enrolled, tuition-paying students working toward a degree, and that to eliminate this tool would be unfair to students whose educational opportunities could be curtailed as a result.

One thing the COVID-19 virus has proven to be is unpredictable. In March of 2020, when we shifted to remote operations and online classes, no one thought we would still be dealing with COVID-19 22 months later. At the start of the pandemic, and for months, people were clamoring for a vaccine. Masks and other personal protective equipment were in high demand. When it arrived, it was rationed to first responders and the most vulnerable. The prevailing question was: when will I be able to get vaccinated? Will there be enough masks for me to have them when I need them?

In the summer of 2020, our colleges began bringing students back to on-site instruction, beginning with lab courses, particularly those that are part of allied health and technical programs where onsite labs are an essential and intrinsic part of preparing students for professions. Programs in nursing, respiratory therapy, radiation therapy, surgical technology, dental hygiene, fire protection, HVAC, welding, automotive technology, diesel heavy equipment - even programs in culinary arts - and more rely on on-site instruction for students to complete their programs and take their place in New Hampshire’s skilled workforce. We brought students back by reconfiguring lab spaces, installing Plexiglas dividers, adjusting scheduling, and in many cases requiring students and instructors to wear masks to curb the spread of the virus, the incidences of illness, the resulting and disruptive need for quarantine, and those overall effects on our ability to continue to educate our students.

Our duty to educate students well, sits alongside our responsibility to keep students, faculty, and college staff who execute our mission as safe as possible from the effects of COVID-19. We cannot do the former, without the latter. The community colleges train students for the professions that are in high demand – even more so given the present labor market dynamics with individuals opting out of the workforce in greater numbers than we have ever seen - either unable to return to work for a variety of reasons, taking a “stop-out” while home lives and domestic economies are disrupted, or who are part of the “Great Resignation.” Our students are enrolled in our community college programs because they want to work. They want to compete their training and take their place as nurses, as firefighters and paramedics, as electrical line workers, as CDL drivers, as chefs and pipe welders, as substance abuse counselors and child care teachers, as cybersecurity specialists and law enforcement professionals, and much more. We can only help them do that if we have the tools to keep their learning environments open and accessible to them, and to the faculty whose role is critical to preparing the next generation of our workforce.

HB220 already prevents us from requiring that students be vaccinated. Masking is a critical tool we can employ to keep our colleges open and the level of learning high. The use of masks in certain conditions, such as indoors when social distancing cannot be maintained, is recommended by public health experts. During a time of a disruptive global pandemic, we rely on the guidance of experts in determining the most appropriate response to local conditions. HB1490 removes such public health guidance as a consideration. We know that some do find masking inconvenient, uncomfortable, and/or an unwelcome imposition. It is, however, a way for us to keep our classrooms and labs open to students, to keep educating New Hampshire residents, and to keep graduating Granite Staters who will go on to become the skilled workforce needed in our communities and state.

For example – just this month, we graduated a class of nearly 40 new LPNs from River Valley Community College. These students were able to complete their program without disruption, and we believe the fact that they wore masks during classes and labs (as they will in the workplace) was an important part of their ability to complete the program. These 40 LPNs are desperately needed in New Hampshire’s assisted living facilities, medical practices and other healthcare settings, as are the cohorts of students currently enrolled and progressing towards graduation. We do not believe that masking is too high a burden to protect the education of students like these new nurses.

We would also seek clarification over the term “medical device.” HB1490 would seem to make optional any medical device. We hope testimony from the bill’s sponsors or others will indicate what is meant by this language and what scenarios, aside from a prohibition on mask requirements, could arise from the use of this broad term.

five reasons Americans should hold on to their masks:

### **1. No vaccine is 100% effective.**

Large clinical trials found that two doses of the Moderna and Pfizer-BioNTech vaccines prevented 95% of illnesses caused by the coronavirus. While those results are impressive, 1 in 20 people are left unprotected, said Dr. Tom Frieden, a former director of the Centers for Disease Control and Prevention.

Malani notes that vaccines were tested in controlled clinical trials at top medical centers, under optimal conditions.

In the real world, vaccines are usually slightly less effective. Scientists use specific terms to describe the phenomenon. They refer to the protection offered by vaccines in clinical trials as "efficacy," while the actual immunity seen in a vaccinated population is "effectiveness."

The effectiveness of covid vaccines could be affected by the way they're handled, Malani said. The genetic material used in mRNA vaccines — made with messenger RNA from the coronavirus — is so fragile that it has to be carefully stored and transported.

Any variation from the CDC's strict guidance could influence how well vaccines work, Malani said.

### **2. Vaccines don't provide immediate protection.**

No vaccine is effective right away, Malani said. It takes about two weeks for the immune system to make the antibodies that block viral infections.

Covid vaccines will take a little longer than other inoculations, such as the flu shot, because both the Moderna and Pfizer products require two doses. The Pfizer shots are given three weeks apart; the Moderna shots, four weeks apart.

In other words, full protection won't arrive until five or six weeks after the first shot. So, a person vaccinated on New Year's Day won't be fully protected until Valentine's Day.

### **3. Covid vaccines may not prevent you from spreading the virus.**

Vaccines can provide two levels of protection. The measles vaccine prevents viruses from causing infection, so vaccinated people don't spread the infection or develop symptoms.

Most other vaccines — including flu shots — prevent people from becoming sick but not from becoming infected or passing the virus to others, said Dr. Paul Offit, who advises the National Institutes of Health and Food and Drug Administration on covid vaccines.

While covid vaccines clearly prevent illness, researchers need more time to figure out whether they prevent transmission, too, said Phoenix-based epidemiologist Saskia Popescu, an assistant professor in the biodefense program at George Mason University's Schar School of Policy and Government.

"We don't yet know if the vaccine protects against infection, or only against illness," said Frieden, now CEO of Resolve to Save Lives, a global public health initiative. "In other words, a vaccinated person might still be able to spread the virus, even if they don't feel sick."

Until researchers can answer that question, Frieden said, wearing masks is the safest way for vaccinated people to protect those around them.

### **4. Masks protect people with compromised immune systems.**



People with cancer are at particular risk from covid. Studies show they're more likely than others to become infected and die from the virus, but may not be protected by vaccines, said Dr. Gary Lyman, a professor at Fred Hutchinson Cancer Research Center.

Cancer patients are vulnerable in multiple ways. People with lung cancer are less able to fight off pneumonia, while those undergoing chemotherapy or radiation treatment have weakened immune systems. Leukemia and lymphoma attack immune cells directly, which makes it harder for patients to fight off the virus.

Doctors don't know much about how people with cancer will respond to vaccines, because they were excluded from randomized trials, Lyman said. Only a handful of study participants were diagnosed with cancer after enrolling. Among those people, covid vaccines protected only 76%.

Although the vaccines appear safe, "prior studies with other vaccines raise concerns that immunosuppressed patients, including cancer patients, may not mount as great an immune response as healthy patients," Lyman said. "For now, we should assume that patients with cancer may not experience the 95% efficacy."

Some people aren't able to be vaccinated.

While most people with allergies can receive covid vaccines safely, the CDC advises those who have had severe allergic reactions to vaccine ingredients, including polyethylene glycol, to avoid vaccination. The agency also warns people who have had dangerous allergic reactions to a first vaccine dose to skip the second.

Lyman encourages people to continue wearing masks to protect those with cancer and others who won't be fully protected.

#### **5. Masks protect against any strain of the coronavirus, in spite of genetic mutations.**

Global health leaders are extremely concerned about new genetic variants of the coronavirus, which appear to be at least 50% more contagious than the original.

So far, studies suggest vaccines will still work against these new strains.

One thing is clear: Public health measures — such as avoiding crowds, physical distancing and masks — reduce the risk of contracting all strains of the coronavirus, as well as other respiratory diseases, Frieden said. For example, the number of flu cases worldwide has been dramatically lower since countries began asking citizens to stay home and wear masks.

**METHODOLOGY:**

This bill provides that an individual shall not be denied access to places of public accommodation based on vaccination status or the decision not to use a medical device.

The Department of Justice states this bill would expand RSA 354-A:16 adding to this section a new provision that would prohibit public accommodations from discriminating based upon vaccination status and a person's refusal to use a medical device. The bill does not distinguish specific vaccines or medical devices and would likely lead to an increase in complaints received by the Attorney General's Office. The Department has no information on how many places of public accommodation have policies refusing service based upon vaccination status or usage of a medical device and states the financial impact is indeterminable.

The Human Rights Commission indicates the bill would expand RSA 354-A:16 to include vaccination status as a protected class for anti-discrimination protections in the area of public accommodation. The Commission states it is unknown how many new cases may result from the legislation. Therefore, the Commission has no information at present to determine if additional resources or staff will be needed.

It is assumed that any fiscal impact would occur after FY 2022.
