### **Granite State Taxpayers Supports HB 1543**

This bill modifies the voter registration forms and establishes a provisional ballot system.

*GST* supports revising New Hampshire voter law to make our voting system simple to understand and execute, resistant to fraud, and available exclusively to bona fide residents of New Hampshire.

The election strategy that has the least opportunity for fraud is one where:

- individuals themselves, in person, go to a polling place and
- they show proof of identity, citizenship, and residence in New Hampshire in order to vote.

New Hampshire allows people to register to vote, and vote, without showing proof of identity, citizenship, or residency. They can do so by filing affidavits where voters self identify and vote without providing any proof. This ability provides a cleat opportunity for mischief.

In Massachusetts, if a person won't present proof of residency, they are not allowed to vote.

HB 1543 provides for a voter registration process where registrants are obliged to provide documentation of residence in New Hampshire. This was the intent of SB 3, which GST supported. It provides for information on place of prior registration and authorization for removal from the voter registration in that place. It requires that the registrant acknowledge that they are relinquishing their registration and residency in any other state.

All of those are desirable steps. Issues are that the wording will need work to put it at a reading comprehension level that can survive legal review. The provisional ballot concept will require review. Also, a list of acceptable documentation is missing.

For these reasons, although we support many parts of the bill, we think it needs more work.

#### Granite State Taxpayers recommends that HB 1153 be held for further review.

#### **METHODOLOGY:**

This legislation establishes a new voter registration form to be used by all persons registering to vote in New Hampshire. It also requires that any person who wishes to vote after registering at a polling place on election day must do so by casting a provisional ballot and establishes requirements for processing provisional ballots

The Department of State indicates the fiscal impact of this bill will be an indeterminable increase to State General Fund expenditures. The Department states they will need to design and print provisional ballots as well as have instructions on how to vote using a provisional ballot. The Department also indicates extensive training of local election officials and voter education will be necessary.

The New Hampshire Municipal Association (NHMA) states the fiscal impact of this bill would be an indeterminable increase in local expenditures. The NHMA notes there would be significant additional work by elected officials including new voter verification on the new longer voter form, follow up requirements to ensure applicants have obtained a New Hampshire driver's license, electronic scanning of identification from provisional ballot voters, a review of all election-day registration and associated documents at the close of polls and lastly, a requirement that each polling place have additional voting booths to be used solely by voters

who are casting provisional ballots. The NHMA states the amount of increased expenditures will vary depending on the municipality and the election.
